The Public Transportation Advisory Council (PTAC) was created in Idaho Code 40-154 to advise the Idaho Transportation Department (ITD) on issues and policies regarding public transportation in Idaho. PTAC participates in planning activities, identifying transportation needs and promotes coordinated transportation systems. PTAC gathers pertinent information, facts and data from local governments, agencies, and providers regarding rural public transportation issues. PTAC advises the department in making funding recommendations to the Idaho Transportation Board.

PTAC is made up of six members appointed by ITD’s Board. Each appointed member represents local governments and agencies, private organizations, citizens groups and private providers that have an interest in public transportation, the elderly, and people with disabilities in their district. Each PTAC member keeps in touch with the transit agencies in their district to lend support or bring issues, concerns, wins, or needs to the ITD's Public Transportation section.

"PTAC is the conduit between ITD-PT and the people," said District 3 rep Al Schneider. "Numbers are what drive us, but people are why we drive."

One of the standing agenda items for PTAC's quarterly meetings is to report out concerning the agencies in their district and any trends or commonalities they may be seeing. They have a forum to discuss problems and brainstorm with peers and their PTAC representative.

"As a transportation engineer, I appreciate how public transit can move people from place to place," said PTAC Chairman Ryan Luttmann. "However, as a member of PTAC, I am amazed at the impact public transit has on independent living and freedom when our community members in need discover this safe, efficient, and affordable means of transportation."

PTAC works with the transit agencies endeavors to get the word out to their local communities with the services they provide. Since the work they do is rural, one means of communication isn't always the answer.

"Serving on the Public Transportation Advisory Council is an honor and a privilege," said Jeff McCurdy in District 4. "As we work with ITD's PT Team, together, we strive to support all public transportation providers as they deliver

safe, reliable and assessable transportation options throughout the great State of Idaho." So, through collaboration with PTAC an agency can bring their concern to every region of Idaho.

"Public transit is the cornerstone of a vibrant community," explained PTAC Vice Chair Michelle Ziel-Dingman of District 6. "It provides the opportunity for employment, healthcare, independence, and commerce. Each representative on PTAC serves because they believe in the power of public transit to better lives and support the business they serve."

Alisa Anderson of District 2 also points to community impact. "I have proudly served on the PTAC representing District 2 for many years, which has given me the opportunity to advocate and be a part of a collaborative engagement to support public transportation options to better connect people with mobility and access to employment, schooling, community resources, medical care, and shopping.
