1 COMMISSIONER GOLLOTT: I would like to call this
2 meeting to order.
3 Welcome everyone. The first thing we are going
4 to do is have the Pledge of Allegiance led by Jamie
5 Miller.
6 (Whereupon, the Pledge of Allegiance was
7 recited.)
8 COMMISSIONER GOLLOTT: We now have to approve
9 the minutes of the last meeting.
10 Do we have any modifications?
11 (No response.)
12 COMMISSIONER GOLLOTT: With no modifications, do
13 we have a motion to approve the minutes?
14 COMMISSIONER ZIMMERMAN: So moved, Mr. Chairman.
15 COMMISSIONER GOLLOTT: Do we have a second?

17 COMMISSIONER GOLLOTT: All those in favor say

13 Executive Director's report.
14 JAMIE MILLER: Thank you, Mr. Chairman. I've
15 got just a very brief report.
16 Update on the public hearings that are being
17 held currently with the Governor's Oyster Council. We
18 held the first public meeting, in Hancock County last
19 night in Bay St. Louis. Tonight we will hold the second
20 of three public hearings, in the Bolton Building in this
21 room here, at 5:30. The public and everyone is invited to
22 participate in that and give public comment, and, then,
23 tomorrow, Wednesday, we will be at Gautier City Hall at
24 5:30 for a public meeting. Then, Thursday, we will travel
25 to Jackson to give a presentation and update to a joint

1 meeting of the House and Senate Oversight committees.
2 That will conclude our round of public meetings.
3 Of course, we will be taking public comments throughout
4 the process, with the delivery date of the report and plan
5 to the governor scheduled for the first week in June.
6 Thank you.
7 COMMISSIONER GOLLOTT: We have Marine Patrol up
8 next.
9 KYLE WILKERSON: Commissioners and Director, you
10 guys have the list of all of our violations and activities
11 in March.
12 If you have any questions, I will answer them.
13 COMMISSIONER GOLLOTT: No questions. Looks like
14 it's been pretty quiet.
15 KYLE WILKERSON: Yes, sir.
16 COMMISSIONER GOLLOTT: Thank you.
17 KYLE WILKERSON: Thank you.
18 KEITH DAVIS: I've got one other request, Mr.
19 Chairman. I would like to request if you would consider a
20 moment of silence for the U. S. Deputy Marshall.
21 COMMISSIONER GOLLOTT: Be glad to.
22 KEITH DAVIS: I've got a couple of words. I had
23 to run down here so I'm out of breath.
24 Deputy Marshall Wells was twenty-seven years of
25 age. He was born in Wade, Mississippi, graduated from

1 East Central High School, and later joined the U.S.
 2 Marshall Service.
 3 On March 10th, 2015, he died, during the service
 4 of an arrest warrant for a murder suspect.
 5 As I thought about that this morning, I thought
 6 about a Bible verse, John 15:13, and it simply reads:
 7 "Greater love has no man than this that one lay
 8 down his life for his friend."
 9 Please join me in a moment of silence.
 10 (Whereupon, a moment of silence was observed.)
 11 KEITH DAVIS: Thank you very much, Mr. Chairman.
 12 COMMISSIONER GOLLOTT: Thank you.
 13 Joe Jewell, Marine Fisheries.
 14 TRACI FLOYD: Good morning Mr. Chairman,
 15 Commissioners, Director Miller and legal counsel.
 16 I'm Traci Floyd. I'm representing Fisheries
 17 office today. Mr. Joe Jewell is attending the Gulf States
 18 Marine Fisheries Commission meeting in Point Clear.
 19 I wanted to mention a couple of items, before we
 20 get to our agenda presentations.
 21 First is our finfish commercial quota status.
 22 Red drum is currently at twenty-seven thousand one hundred
 23 and fifty-three pounds, our Spotted Seatrout at one
 24 thousand four hundred and ninety-one pounds, and flounder
 25 is at one hundred and forty-two pounds.

1 Our Mississippi Oyster Season, as you know,
 2 closed on March 14th, this past Saturday, at 4:00 p.m.
 3 Overall for the season, our harvest was twenty-six
 4 thousand and four sacks. That's the result of three
 5 thousand three hundred and thirty-six trips taken this
 6 season.
 7 With that, I'm going to go to our agenda
 8 presentations. First up, I'm pleased to introduce Ms.
 9 Carly Somerset. She is representing the Finfish Bureau,
 10 and she will talk today about the Red Snapper reporting
 11 program.
 12 CARLY SOMERSET: Good morning Mr. Chairman,
 13 Commissioners, Director Miller and Counselors.
 14 Today, I would like to present to you some of
 15 what the Fisheries staff has been working on for Red
 16 Snapper reporting.
 17 Recalling some decisions from late last year,
 18 effective October 21st, 2014, the Commission adopted a
 19 regulatory modification to Title 22, Part 9, Statistical
 20 Reporting and Confidentiality of Statistical Data for
 21 Marine Fisheries in the State of Mississippi.
 22 This provided provisions to reporting
 23 requirements, making it mandatory for the owner, or
 24 captain, of any vessel recreationally harvesting Red
 25 Snapper to complete a harvest report that is provided by

1 MDMR.
 2 Fisheries staff reviewed all options of
 3 reporting and concluded the best method was to develop an
 4 electronic reporting system.
 5 The purpose of the mobile app is to collect
 6 information on all recreational Red Snapper landings in
 7 Mississippi, during the 2015 season.
 8 Anglers will be required to register and request
 9 a trip number, prior to any trip on which they intend to
 10 target Red Snapper.
 11 New trip numbers will not be issued, until the
 12 previous catches are reported.
 13 Active trips each day will be available to
 14 Marine Patrol for enforcement purposes.
 15 A call-in option will be available for anglers
 16 without smartphones, or internet access.
 17 The information collected, once the trip has
 18 been completed -- this is per vessel -- is the location of
 19 the vessel landing, the number of anglers, the time spent
 20 fishing -- this means the time spent with the line in the
 21 water, not including travel time -- the number of Red
 22 Snapper harvested, and the area fished, natural bottom,
 23 rig, or artificial reef.
 24 We contracted with an information technology
 25 company in Texas called Elemental Methods to develop a

1 smartphone app and web portal, and we are in the final
 2 stages of the development and testing process.
 3 As far as time frame goes, the reporting system
 4 will be ready to go in plenty of time before snapper
 5 fishing starts.
 6 I would like to show you some examples of the
 7 system, in the next few slides.
 8 This is the icon that will appear on your phone,
 9 representing the mobile app and the web portal and what
 10 will appear when the app is initially downloaded.
 11 The app is called Tails n' Scales. This is the
 12 initial flash screen with the MDMR logo, and, then, the
 13 next screen is the login screen with the icon. This is
 14 where the user first registers and creates an account, or
 15 logs in with their information.
 16 Once logged in, users can create a new trip, or
 17 report on a current trip, or check on a recent trip
 18 status.
 19 We are providing, within the app, an area for
 20 anglers to check the weather for their convenience. We
 21 think it is very important to provide the marine weather
 22 forecast for the anglers and allow them to access it
 23 easily.
 24 The system will create a comprehensive log that
 25 the anglers will be able to access to see their past trips

1 taken, and the system will also allow managers to track
 2 all trips and harvest information in real time.
 3 This is the screen shot of the web portal, and,
 4 essentially it's the same as the mobile app, but it is for
 5 the internet for anyone who can't download the app on
 6 their phone (indicating slide).
 7 The registration process for the web portal and
 8 reporting process is the same. We will be asking users
 9 for name, email address, mailing address, vessel type and
 10 vessel registration number, or Coast Guard documentation.
 11 Again, users will be able to see their past
 12 trips taken, and the system will also allow managers to
 13 track all the trips and look at harvest information in
 14 real time.
 15 I will be happy to answer any questions.
 16 COMMISSIONER ZIMMERMAN: Is the web portal and
 17 the app one sign on and you use either or, or is it two
 18 different sign ons?
 19 CARLY SOMERSET: It will be same information.
 20 As long as the user creates an account with their email
 21 and password, they can use that on their phone with the
 22 app, or on the internet. It will be the same across all
 23 of them.
 24 COMMISSIONER ZIMMERMAN: That's a lot easier.
 25 COMMISSIONER GOLLOTT: I would just like to say

1 good job. I know you put a lot of work into developing
 2 this.
 3 CARLY SOMERSET: Thank you very much. I'm
 4 excited about it.
 5 COMMISSIONER BOSARGE: You will download this
 6 app through the MDMR?
 7 CARLY SOMERSET: Yes, sir. We will have a link
 8 so that it will be easy to get to and download, and it is
 9 for iPhone and for android. We wanted it to be as
 10 accessible to all types of phones as possible. So it will
 11 be in the iPhone store and the Google store.
 12 COMMISSIONER BOSARGE: Great.
 13 CARLY SOMERSET: Thank you.
 14 TRACI FLOYD: Next up for Fisheries, I'm
 15 introducing Mr. Jason Saucier. He will represent the
 16 Shrimp and Crab Bureau, and he will talk today about live
 17 bait shrimp.
 18 JASON SAUCIER: Good morning Mr. Chairman,
 19 Commissioners, Director Miller and Counselors.
 20 I'm presenting an update on the live bait shrimp
 21 for the 2014 and 2015 season.
 22 This is an overview of our live bait regulations
 23 which can be found in Title 22, Part 6.
 24 The applicant may submit an application any
 25 time, during the year.

1 The inspection is completed within thirty days
 2 of submittal of a complete application.
 3 They are allowed to shrimp twelve months out of
 4 the year.
 5 They are allowed to shrimp inside the half mile
 6 of the shoreline.
 7 They are not allowed to shrimp at night.
 8 Tow times are limited to twenty-five minutes,
 9 and that is including the time taken to pick the trawl up
 10 and put it out.
 11 They cannot sell shrimp for consumption.
 12 They must report landings and sales monthly to
 13 the MDMR.
 14 These are the inspection requirements:
 15 The facility must be able to safely serve the
 16 public.
 17 The dealer must have a Mississippi state sales
 18 tax number and all privilege licenses.
 19 The facility must have signage easily visible
 20 from the nearest public roadway, using letters at least
 21 six inches high and one-half inch wide, with the words
 22 "LIVE BAIT" and the name of the camp.
 23 Holding tanks must have adequate water flow for
 24 optimal survival of shrimp.
 25 Catcher vessels are allowed trawls that are no

1 larger than sixteen foot wide and have four foot doors.
 2 The tanks have to be covered, or shaded, and must be
 3 clearly marked with "LIVE BAIT BOAT" and the name of the
 4 camp.
 5 Catcher vessels and transport vehicles must also
 6 pass an MDMR inspection.
 7 This is an example of a holding tank at one of
 8 our live bait camps. You will notice the sufficient
 9 aeration and the rounding in the corners (indicating
 10 photograph).
 11 This is an example of one of our catcher boats.
 12 You can notice the shaded holding tanks on the stern, or
 13 close to the stern, sufficient markings on the side that
 14 have to be on the port and starboard sides at least six
 15 inches high with the words "LIVE BAIT" and the name of the
 16 camp (indicating photograph).
 17 This is our dealer report. We do have, on the
 18 report, number of purchasers, live shrimp numbers caught,
 19 live shrimp numbers sold, dead shrimp sold and that's in
 20 pounds, chum in pounds sold, squid and hard crabs and
 21 that's in numbers sold (indicating slide).
 22 This is our live bait purchases going all the
 23 way back to 2002 through the 2013-2014 season. You will
 24 notice a significant drop, in the 2004-2005 and 2005-2006
 25 seasons. That's due to hurricanes, as we are well aware.

1 Then, you will see another drop in 2010-2011 season, due
 2 to the oil spill (indicating slide).
 3 This is a graph of our live bait sales, going
 4 back to 2002. The same thing. You can see a significant
 5 drop, in our 2004-2005 season and our 2005-2006 season, as
 6 well as in 2010-2011. The blue line marks shrimp caught
 7 and the green marks shrimp sold (indicating slide).
 8 This shows our dead bait sales from 2002. The
 9 same thing applies here where the dips are; shrimp sold
 10 with the blue line, and, then, chum, squid and crabs are
 11 put together into the green line (indicating slide).
 12 Here are the number of live bait camps and
 13 vessels from 2002 to 2014 (indicating slide).
 14 Here are our camps that we have currently.
 15 There is a total of fifteen camps that are inspected and
 16 licensed in the state (indicating slide).
 17 In Hancock County, we have three.
 18 In Harrison County, we have Biloxi Harbor,
 19 Boardwalk Marina, Crabb's, Tackle Box Gulfport, Tackle Box
 20 Long Beach.
 21 In Jackson County, we have Bait Box, CC's, Fort
 22 Bayou, Marine Mart, Mary Walker, Little River Marine and
 23 Who Zat.
 24 There are twelve live bait vessels inspected and
 25 licensed, and there are nine live bait transport vehicles

1 currently.
 2 Here is a map that shows the location of all of
 3 our camps (indicating slide).
 4 That concludes my presentation. If there are
 5 any questions, I will be happy to answer them.
 6 COMMISSIONER GOLLOTT: Thank you.
 7 JASON SAUCIER: You're welcome.
 8 TRACI FLOYD: Finally for Fisheries, we have Mr.
 9 Scott Gordon, the Shellfish Area Director, and he will
 10 talk today about oyster basket dredge and gear
 11 requirements.
 12 SCOTT GORDON: Good morning Mr. Chairman,
 13 Commissioners, Director Miller and Counselors.
 14 I was asked to put together a brief review on
 15 basket oyster dredges.
 16 The basket dredge is also known as a self-
 17 dumping dredge, or Alabama Oyster Dredge, and here are
 18 some pictures illustrating those).
 19 Here is your typical bag dredge that has the
 20 rope bag (indicating photographs).
 21 Basket dredges.
 22 The reasons they are used:
 23 The are self-dumping. Less muscle is required
 24 to operate them. They require fewer deckhands. The ease
 25 of use. They are required in the state of Alabama. There

1 is probably less maintenance required with the basket
 2 dredges, since they are all metal.
 3 Some of the concerns that have been expressed:
 4 It may be more difficult to fish them properly.
 5 They may damage, or bury, oysters. They may dig too deep.
 6 They may make oysters in the area muddy, by stirring up
 7 excessive sediment.
 8 That is my presentation.
 9 COMMISSIONER BOSARGE: When you say they are
 10 required in Alabama, refresh my memory, but most of the
 11 oystering done in Alabama is done by tonging.
 12 I don't recall seeing many dredge boats.
 13 SCOTT GORDON: Alabama has a relatively small
 14 area set aside for dredging and, on those, they require
 15 the basket dredge use.
 16 COMMISSIONER BOSARGE: If I remember correctly,
 17 that area is open just on rare occasions.
 18 SCOTT GORDON: That's correct.
 19 COMMISSIONER BOSARGE: In other words, they
 20 don't use them in Alabama very much.
 21 SCOTT GORDON: That's correct.
 22 COMMISSIONER GOLLOTT: I would like to say this.
 23 The old rope dredge, or bag dredge, was used for probably
 24 fifty to seventy years without any problems.
 25 I've gone over some of the minutes to try to

1 find out why they changed and went to the basket dredge,
 2 and about the only thing that comes out is that it is
 3 self-dumping and easier to use.
 4 I think we need to err on the side of
 5 conservation and go back to the old tried-and-true method
 6 of the hundred-and-fifteen pound dredge with sixteen
 7 teeth.
 8 With that, I would like to get a motion, or
 9 anybody else's opinion on this.
 10 COMMISSIONER ZIMMERMAN: Mr. Chairman, I would
 11 like to make a motion that we do that. We should prohibit
 12 the basket dredge and go to a maximum bag dredge of a
 13 hundred-and-fifteen pounds with sixteen teeth.
 14 COMMISSIONER GOLLOTT: We have a motion.
 15 Do we have a second?
 16 COMMISSIONER BOSARGE: I'll second that motion.
 17 COMMISSIONER GOLLOTT: We have a motion and a
 18 second.
 19 All those in favor say aye.
 20 (All in favor.)
 21 COMMISSIONER GOLLOTT: Opposed?
 22 (None opposed.)
 23 COMMISSIONER GOLLOTT: Motion carries. Thank
 24 you.
 25 SANDY CHESTNUT: This is going to be a

1 regulation change. It is going to have to go out on
2 public notice and all that, with the Administrative
3 Procedures Act.

4 Do you-all want some language brought back to
5 you next month to approve, or do you want to go ahead and
6 give the staff the authorization to write that language
7 and go ahead and start the administrative procedures?

8 COMMISSIONER GOLLOTT: Well, we're really not in
9 a hurry. Oyster season is closed. So come back and get
10 approval for it.

11 SANDY CHESTNUT: Okay.

12 SCOTT GORDON: Thank you.

13 COMMISSIONER GOLLOTT: Thank you.

14 COMMISSIONER ZIMMERMAN: I know y'all have
15 worked hard on getting us some information, and thank you
16 for the work y'all have done.

17 TRACI FLOYD: This concludes Fisheries. Thank
18 you.

19 COMMISSIONER GOLLOTT: Next we have Office of
20 Finance, Bill Feidt.

21 BILL FEIDT: Good morning everyone. I'll go
22 through the financial results as of the end of February.

23 At the end of February, we had State revenue of
24 five point two million dollars. We are still having some
25 challenges with MAGIC. There is revenue in the pipe that

1 Now, we come to Melissa.

2 MELISSA SCALLAN: Good morning Director Miller,
3 Commissioners, and Counselors.

4 The Department of Marine Resources was mentioned
5 -- your paper says thirty-one times, but it was actually
6 thirty-two, with the report from WLOX last night on our
7 public meeting on oysters. We had mentions in local,
8 state and national media, since the last Commission
9 meeting.

10 The things that garnered the most attention were
11 the rescue of a man in Ocean Springs who went missing
12 after going fishing in Davis Bayou, as well as the
13 citation of a man carrying unrefrigerated oyster from
14 Louisiana to Alabama.

15 Our agency employees participated in the Region
16 VI Science and Engineering Fair at the Coast Coliseum and
17 Convention Center. More than seven hundred students
18 participated, in this annual event, and we gave out five
19 awards, the Excellence in Marine Sciences Award, which we
20 give out every year, and the winners were from the Coast.
21 They were from third grade to seniors.

22 One of the winners, Trey Rocha, did a report
23 entitled "Can Oysters Clean Water", and we got Trey to
24 come to the council meeting last week, the Oyster Council
25 meeting, and he gave his presentation about his project at

1 we haven't received yet, in particular appropriations, and
2 we haven't received any interest from Treasury yet.

3 We did complete our first transfer from
4 Wildlife, Fish and Parks of six hundred and fifty thousand
5 dollars.

6 Total agency revenue, we are just under twenty
7 million dollars and, from a state net income standpoint,
8 we are negative one point six million dollars. That is
9 impacted by the revenue we haven't received yet, as well
10 as we did do some spending out of cash on hand which would
11 show up as a negative as well.

12 From a total agency standpoint, we are positive
13 three point three million dollars.

14 Any questions?

16 BILL FEIDT: From a budget standpoint, we are in
17 good shape, after eight months of the fiscal year.

18 Our Operating Funds have fifty-two percent of
19 the budget remaining.

20 Tidelands Trust Fund has fifty-nine percent
21 remaining.

22 Any questions?

1 State your name, Gilbert, and you have five
2 minutes, sir.

3 GILBERT RAMSEY: Good morning Commissioners. My
4 name Gilbert Ramsey. I'm here to represent the veterans.
5 I'm initiating a new program with the City of Biloxi at
6 Hiller Park location.

7 I have been networking within the state and
8 community to initiate options for mobility impaired
9 citizens and wounded warriors to enable other amenities to
10 involve family-oriented activities throughout our region,
11 heritage and culture.

12 We believe, through educational training and the
13 use of adapted angling equipment, everyone is able to
14 share in a dream come true with the goal to open up the
15 great outdoors and the world of fishing to people with
16 disabilities.

17 We are united in our support for the men and
18 women who served our state. As home for four Federal
19 military basis, two Army National Guard installations,
20 three Air National Guard units, eighty-five National Guard
21 readiness centers, our state's military operation creates
22 thousands of direct and indirect jobs. Economic impact
23 generates an estimated two point five million dollars a
24 year.
