All right. Let's see if we've got -can we get the employment -- you see we've got
several new hires. Robert, he's not exactly a new
hire. Robert was with us and left and now he's
come back. We don't call that much of a new hire.
We just call it got him back. He went to the
portal and then we, I guess, was able to get him
back out of it and you know how that goes.

But we've got several other promotions, and all. You can see them on the screen. I won't read them out, but doing good. We're glad to have the two new personnel. Robert being one of them back with us, and we're always glad to have the promotions.

Okay. Any questions? (No response.)

JOE SPRAGGINS:

There's no contracts, so we'll move right along and go into the agency update.

First off, if you have a public comment, TJ is somewhere back there in the back. There he is, and just see TJ and get a -- he'll give you a piece of paper and you can fill it out. We'll be glad to bring it. And we like to do it during the part of what you want to talk about, so if it's

1 something very -- at the start of it, please get 2 it to him now. 3 With the 2019 Bonnet Carré, we're 4 getting there. We're getting there. We're 5 updating, as we've talked about. 6 Traci, I do not have that sheet you sent 7 Do you have it with you? me. 8 TRACI FLOYD: 9 I do. 10 JOE SPRAGGINS: 11 Could you come -- would you mind 12 stepping up and briefing that? Somehow or 13 another, I lost that sheet. 14 TRACI FLOYD: 15 Good morning. So just a recap, on Job 16 Titles 1 and 2, which was the financial 17 assistance, all the charters have been paid out. We have 29 of 31 signed dealers' agreements that 18 19 have received their final payout. We have 267 of 293 signed commercial 20 21 fishermen agreements for their payout. We have 22 about five who are still in process, so we have 23 some folks that are waiting for that second 24 payment to sign, for their personal reasons. And 25 we hope that next round will come at the end of

January.

JOE SPRAGGINS:

Yeah. And the next round, we're talking about the commercial fishermen and, you know, if they — if they were oystermen and they had it, they got 15,000 in the initial. And if they was other than that and didn't have oyster but shrimp or whatever, finfish or crab, they got 7,500.

Now, what we're able to do is go back after that point and look at it and whatever they would -- we think from their four years prior, whatever they would have been -- would have made in 2019 that they didn't, we can pay them up to 108,000. Isn't that --

TRACI FLOYD:

That's a -- yeah, that's correct.

JOE SPRAGGINS:

Up to \$108,000 we can pay back on what they lost, so we're going to be able to make a lot of fisherman halfway well for a little bit, you know, and that's just for that one year.

The ones that are not going to be able to get whole that were over \$108,000 in loss, they're the big main shrimpers or whatever and, you know, companies and they were able to go

somewhere like Florida or wherever and do some fishery. So maybe they wasn't hurt as bad because they could make it up, but we can get them up to that point.

And so hopefully, we'll be able to -we'll take this off of trip tickets and it will be
off of what they have turned in for trip tickets
of prior years and all, and hopefully we can make
a lot of people a little bit close to whole and
keep them in the business for a little bit longer.

TRACI FLOYD:

Yes, sir.

13 JOE SPRAGGINS:

14 Is that right, Traci?

15 TRACT FLOYD:

Yes, sir.

17 JOE SPRAGGINS:

And then also, we're working on the processers, and we're being able to give them and -- we'll be doing some stuff there where they can turn in and tell us that they need to purchase this type of equipment for whatever and we'll be able to help them with that. What was the number on that? 2 and a half, 3 million?

TRACI FLOYD:

1 So that was 3.6. 2 JOE SPRAGGINS: 3.6 million that we have for that. 3 4 TRACI FLOYD: 5 Which includes a little staff time 6 and -- but most of it is for the processing. 7 JOE SPRAGGINS: Yeah. But anyway, it's in a round-about 8 9 figure. So we'll be able to help them to be able 10 to upgrade their equipment. That's what we're 11 trying to do with that and basically where you 12 can -- you know, a lot of the Louisiana and 13 everybody else has got better equipment because 14 they got money to do it. We're going to try to do 15 what we can to be able to help ours get back on 16 board. 17 Anything else on that? TRACI FLOYD: 18 19 I would mention, in February we will 20 have the commercial fishermen safety program where 21 we will give them -- reimburse them to have safety gear for their -- to make their livelihood more 22 23 safe, you know, their vessels. 24 JOE SPRAGGINS: 25 And we're also, you know, hoping to do

some stuff with off-bottoms that we have got in our -- we have that in the grant, but we're doing some oyster stuff out of the grant, too, you know, where we're replenishing some oyster reefs and all.

We're working on a lot of things with it, so the grant is going to help pay for a lot, and I think that a lot of people will benefit from it and we will be able to move forward in the agency.

And we also applied and were granted another 3 million starting in 2020, right? Isn't that right? Was it 3 million? Is that right? RICK BURRIS:

(Nods head.)

JOE SPRAGGINS:

Rick is shaking his head. So we haven't received that yet, but that will be mainly for the oysters and shrimpers and stuff and, you know, to be able to help them for what they lost in 2020 compared to what they had.

We did not get approved for 2021. We're still working on trying to get some other stuff, but it seems like, especially -- the only thing would be the oysters that we're still losing in

      some stuff with soil and water, so he is over

      there. But he's still on the committee. But we
22
      have Brent and he will be helping us out.

                And then on the House side, we have
24
      Senator Thompson, and Senator Thompson is our new
25
      chairman over there. And so we've been working
```

with him, too, and that's not a problem. And he's been working with us all along. He was the co-chair before, so I think we'll be doing fine.

We're still trying to figure out the appropriations side of it because they broke appropriations down to like A, B, C and D and E and one of them -- they're going to take -- like, my understanding of it will be the Department of Marine Resources, Department of Wildlife and Fisheries and Department -- DEQ and some others and put them in one lump sum and that way, then they'll have -- there will be an A, B, C or whatever number it is. And they will be the appropriations people that we go to, and then they will take it and work it through. And then I think John Read is the head of appropriations for the House, so it will all go back through them still for the final stamps, is my understanding.

But we'll work it out. We'll figure it out, which way we need to do it. The session is going to go to the end of April this year, so, you know, we've got a while to get it done. And we have to get our bills in, I think, the first of February, somewhere along in there. We've got to get the stuff in there and we'll be able to move

1 forward with that. We still just have small -- we 2 don't have anything big. 3 Any questions on the legislators? 4 (No response.) 5 JOE SPRAGGINS: All right. Second floor, it's going to 6 7 be off-limits, anything on the other side of it. Is that west side or south side? South side, 8 9 yeah. I can't keep my mind straight. I can't 10 keep my mind -- I'm not in a jet, so I don't know 11 which way I'm going. 12 But the south side, the whole thing for 13 fisheries is being redone. The Department of 14 Finance and Administration is redoing it for us 15 and they're just going to come in and gut 16 everything on that south side at one time. We've 17 got all the people moved to other areas. And they're going to gut everything out and then start 18 19 rebuilding it, and it will be a whole lot better 20 in the near future. 21 We're hoping -- TJ, tell me if I'm wrong 22 by a yes or no -- around the summertime? 23 TJ MORAN: 24 Around Memorial Day hopefully. 25 JOE SPRAGGINS:

1 Huh? 2 TJ MORAN: 3 Around Memorial Day hopefully. 4 JOE SPRAGGINS: 5 Somewhere along in there having 6 it finished, so much needed. They have been 7 working in all kind of travesty conditions with the cubicles and everything else, and now they're 8 going to have something decent. We're getting 9 10 some new furniture there for them, so they're 11 going to have something decent there too. And 12 we're glad to do that for fisheries. 13 And so if you have got any questions, 14 you're going to -- to find somebody in fisheries, 15 you're going to have to jump around all over the 16 agency because they're everywhere, and -- but let 17 us know and we'll get you. 18 Any questions on that? 19 (No response.) 20 JOE SPRAGGINS: 21 All right. Gulf Council, we've got --22 we have it starting on the 29th in New Orleans, 23 and so we will be working on that. I know that they are going to bring up the -- if you haven't 24

noticed, you know, and we have put in -- we're

working with the Mississippi Creel, MS Creel and we're getting that started and that's going to be a big thing. Louisiana, Alabama, Mississippi are all under the LA Creel type, and we're doing that for this year. And hopefully we'll get -- be able to take samples and take -- be able to take surveys and all under that. And when we get that done, then we will be able to look at it and I think it will definitely help us as far as our reef fish and everything else.

And we'll probably get a lot of other things with the seatrout, spotted seatrout and other things that will come in, the redfish and everything else. We will get a lot of different capabilities of managing that resource. And this is something that NOAA is paying for so that's even better. So they're paying for it and that means they're on board with us. And by them having — on board with us, we'll probably get NMFS on board, and NMFS will be able to help us get this and implement it. And I think our 60-something thousand pounds of red — of snapper will probably go up a lot, and we'll probably get back closer to where we should be and I think this will be a fantastic move.

| 25 | going to, you know, reef fish and that will give |

us -- what this is going to do is take our sample size from here to here (indicating).

It's going to be extremely better, and hopefully the people will -- we'll have, you know, a year or so that it will take us, just like we do with everything else, to be able to implement it 100 percent. I don't think we'll be giving anybody a ticket this year, you know, with it.

We'll be asking them to get -- you know, go back and do it if we find out, but -- or catch them, but I think we will work it out just like we did with our snapper before with the Tails and Scales.

We'll work something out.

But I think this will be fantastic because instead of 80,000 people they survey out of NOAA, then it will be down to probably 15 or 20 or something like that, if we do it right, thousand. And this will really help our sample size in which it will turn around and give us a better chance to be able to get the numbers the way they should be.

Which one is it? There's one fish that if we caught one in Mississippi we'd shut the whole Gulf down?

| 15 | slow month. It means everybody is playing |
| 16 | properly. And not a lot of citations. I think we |
| 17 | had 75 citations total over 1,064 stops. Now, |
| 18 | that's a slower a slower month for us. We |
| 19 | normally range about 2,500 to 3,000, but December |
| 20 | is always traditionally slow due to the holidays. |

RONNIE DANIELS:

Thank you, Chief.

All right. Next up, coastal resources management, Ms. Willa.

WILLA BRANTLEY:

Good morning. I wanted to go through some of our numbers for the past year. You all see very few of what the permitting staff actually does, so I do like to bring the numbers at the end of the year.

For the last year, 2023, we had a total of 810 actions that the permitting staff handled.
667 of those were either regulated by the state or were regulated by federal agencies that we get to review before they issue permits for them.

We had a combination of reviews and pre-application meetings, 95. That number is actually up this year. That's where people send us information about their project, what the impacts will be and we review it and see if it needs a permit, if it's a regulated activity or not; or if they know they have a regulated activity and it's kind of going to be complicated,

we'll do a pre-application meeting and discuss what they need to turn in their application so it helps make the process go smoother.

We did have 48 reported violations this year. Not all of those were actually violations. I do have a little more details in the last slide about those numbers.

This is just a comparison over the last two years so we can see how the numbers have gone. If you notice, this year, our second half numbers went up significantly, but our total numbers went down just a little. Usually, we have more actions in the first half of the year and they drop in the second half. We flip flopped that in 2023 for whatever reason. We had fewer in the first half but significantly more in the second half. So we'll see how the first half of this year goes, how our numbers will compare for next year.

We did go down a little bit in the regulated activities and consistencies and up a little bit in the other two categories.

And this is a little bit of detail on the violations. Total, we have 48, but actual violations were 26 of those, which means 22 we went out to and there is no violation once we got to the site. Out of the 26, we either issued an after-the-fact for 15 or it was resolved voluntarily by the property owner. There were 10 of those. And then there was one that had -- part of it was covered by an after-the-fact and part of it was a restoration of some vegetation that had been damaged.

Of the ones that were actually violations, 15 were reported by the public and 11 were found by staff when we went out to do site visits for new applications.

So I just wanted to give a little bit of the detail on the violations. And you see there we did present one to the Commission that was finished off with a \$1,500 fine.

There have been some presentations about another violation in Ocean Springs, you may remember. We only count them when they get closed out and that one's not closed out yet, so it doesn't show up in those numbers. So we don't know exactly yet what the resolution is going to be on that one.

So if you have any questions about the details, I will be happy to answer them.

RONNIE DANIELS:

1 Anybody? 2 (No questions.) 3 RONNIE DANIELS: 4 Thank you, Willa. Y'all run a lot of 5 the permits through there. 6 WILLA BRANTLEY: 7 Yeah. Thank you. 8 JOE SPRAGGINS: 9 They -- and also, I would like to tell 10 you, you know, there is a couple of them, what you 11 said, maybe have not been closed out. But I see 12 Ray is back there. Secretary of State is working 13 with us on some of the things, and I think the 14 Secretary of State has sent some letters to some 15 people in trying to get some things done. 16 Ray, we appreciate that. Tell the 17 Secretary we appreciate his help on that because there's a couple of things that -- you know, that 18 19 people have done something and we're trying to 20 work it out. But we have got to have the 21 Secretary of State backing us to be able to go 22 forward, and we appreciate that. And we want to 23 just let people know that they are working with us 24 on it and we appreciate it. 25 RONNIE DANIELS:

All right. Up next, finance and 1 2 administration, Ms. Brewer. 3 LESLIE BREWER: 4 Good morning, everybody. I'm presenting 5 the financials for December 31st, 2023. 6 At the end of December, our state 7 revenue was 4.3 million. Our agency revenue was 22.2 million. 8 9 State net income, 779,000, and agency 10 net income is 2.9 million. 11 And after six months of fiscal year '24, 12 we have 92.4 of our budget remaining, and the 13 Tidelands budget is at 67. 14 Any questions? 15 RONNIE DANIELS: 16 No questions. All right. Thank you. 17 LESLIE BREWER: 18 Thanks. 19 JOE SPRAGGINS: 20 And not to say, you know, after six months we're not spending any money, but it's just 21 22 a matter of a lot of things come in at one time 23 toward the end. So don't think the 92 percent 24 means we have got that much in reserve. 25 RONNIE DANIELS:

1 Ms. Charmaine, public affairs. 2 CHARMAINE SCHERMUND: 3 Good morning. The Mississippi 4 Department of Marine Resources had 11 media 5 mentions since the December MACMR meeting. News items included shrimp season closing north of the 6 7 ICW on January 1st, the MDR Hatchery Bureau releasing spotted seatrout, the marine information 8 9 calendars coming available and the Mississippi 10 Creel fishing survey. 11 The Office of Marine Patrol took part in 12 the inaugural parade for Governor Reeves on 13 January 9th in Jackson. Marine patrol also 14 participated in Adventures Church Club at Destiny 15 Church in Gulfport. They provided boat and water 16 safety demonstrations and information to the 17 children taking part in the event. 18 I also put calendars in the back of the 19 room there if anybody needs to get any, and if we 20 happen to run out, there is some in the front in 21 the licensing office as well. 22 RONNIE DANIELS: 23 Those are a hot commodity. I get phone 24 calls every year on when are they going to be out.

It's a cross between a white 12 trout. It's good. Throw it back. 13 JOE SPRAGGINS: 14 Good fish. Throw it back. 15 RONNIE DANIELS: 16 Well, that's great. And I would be 17 happy to make the motion to approve this for Miss Margo. Her dad, Sonny Schindler, is a great 18 19 captain and a huge asset to the Mississippi 20 Fisheries. So I will make that motion. 21 22 CAM ROBERDS: 23 I'll second it. 24 RONNIE DANIELS: 25 All in favor?

1 (Unanimous vote.) 2 JOE SPRAGGINS: 3 Hey, before you go, anything on the MS 4 Creel? 5 TREVOR MONCRIEF: 6 So calls started this past week. We 7 have been working with Gulf States and the other 8 ones to get everything set up. It's moving 9 forward. 10 We released the press release recently. 11 We updated our website to include information 12 about it, basically frequently asked questions, 13 things of that nature, so if individuals call, 14 they can kind of -- at least get most of the 15 answers there. 16 If they have more information, if they 17 would like, we're using the Tails and Scales 18 hotline, which is routed directly to our staff for 19 them to call. And they can always call the main 20 line here and get directed to me or anybody else 21 to answer those questions. 22 But so far, haven't had too many calls. 23 We haven't gotten the data from the first week 24

1 far, everything is running well. 2 JOE SPRAGGINS: 3 Yeah. And I know you put it out to the public and everything in asking them to please 4 5 continue -- please do, you know, answer this and 6 please, you know, fill out surveys or whatever. 7 You're going to get phone calls. I think it's 8 phone call style. 9 TREVOR MONCRIEF: 10 Yeah. So it's all -- it's all phones. 11 JOE SPRAGGINS: 12 And you put out a number that you're 13 going to call from or some type of number? 14 TREVOR MONCRIEF: 15 Yeah. So it's going to be --16 JOE SPRAGGINS: 17 Of course, people see robocalls and say, 18 I ain't answering that thing. 19 TREVOR MONCRIEF: 20 Yeah. It's a 985 area code from South 21 Central Planning, who is currently doing the calls 22 for Alabama and Louisiana. They have been doing 23 Louisiana's calls for a while. They'll call 24 multiple times, so it's going to be repetitive. 25 CAM ROBERDS:

1 Oh, yeah.

TREVOR MONCRIEF:

And there's also going to be the option, should the angler not want to repeatedly get called or anything else like that, they can provide an e-mail to be able to fill out the survey electronically in the future should they be selected. So we'll be populating that as time goes on as well.

And yeah, basically if you have any -like, if anglers or any of y'all's constituents
have any questions about it, it's not a burdensome
survey. It's short. It's sweet. We tried to get
it pared down as much as possible.

Louisiana is on the same page as that.

I mean, they designed it to be quick and easy, get it filled out, don't try to bother anybody's day and get the information, the basic information that you need -- or we need as managers. So that's the goal of the survey.

So if they get that call, try to answer it, try to participate. And if you don't want to get called again, try to provide an e-mail and be able to do it that way.

JOE SPRAGGINS:

| 25 | We don't have a current spotted seatrout |

assessment. So remember, I -- we talked about it last year, I believe. We talked about the index, how it's been, you know, for the last two years with Bonnet Carré and the freshwater inputs.

We've seen a drop in the index, but not a corresponding drop in the harvest, which leads to lower SPR values.

And we haven't really moved forward on that end as far as pushing any decision from management. We've essentially kind of recommended status quo, which is where we kind of -- that conversation has led to when I presented it here.

We are working on a new assessment to include the data for this year and hopefully the upcoming year. It's a summertime assessment, so we should be able to have it on the back end of the year to hopefully get past this freshwater influence and see what that index does. If it continues to stay where it's at or continues to drop, I think there will be some considerations and some conversations to have about it.

But yeah, we -- the recommendation of status quo remains simply due to the fact of the large-scale perturbations in the environment with Bonnet Carré, record rainfall in 2021 and

1 everything like that. We didn't want to rush to 2 the management decision if it was environmentally 3 based and a change in the fishery couldn't help 4 because usually when you change a fishery's 5 management regime, it's hard to have any 6 justification to change it back. 7 So it's kind of the same conversations 8 we have been having about multiple species. 9 we should have an assessment on the back end of 10 the summer around August, September. 11 JOE SPRAGGINS: 12 Any questions? 13 (No response.) 14 JOE SPRAGGINS: 15 One other thing, Commissioner Daniels, 16 would you talk to him -- in the last two months, 17 if y'all told me to do something or asked me to do 18 something, it may or may not have stayed in my 19 brain long with what was going on, but you were talking about the charter boat stuff that's going 20 21 on in Louisiana. 22 RONNIE DANIELS: 23 Yes. I forwarded over the text that I 24 got to you. 25 JOE SPRAGGINS:

1 Yeah.

RONNIE DANIELS:

And I may have sent it to Matt. I'm not sure. There's -- and I don't remember all the details on it. There's some type of program that they've funded in Louisiana, similar, it sounds like, to the safety upgrades that we talked about earlier for commercial fishermen, but this is equipment upgrades that is grant money that they're being able to provide to their charter fishermen over there to upgrade things that they may need. I don't know where the money is coming from, but --

TREVOR MONCRIEF:

It's likely through Bonnet Carré. Most of their stuff — their program didn't include direct pay. Their program is, I think, reimbursements across each fishery, so it's providing equipment, receipts and everything else and being reimbursed based on that, not direct pay to fishermen, the way we had. So that's where the money is and where it's coming from, I believe.

RONNIE DANIELS:

Okay.
