**NOTICE OF CONDITIONAL GRANT OF APPLICATION OF CSDVRS, LLC. FOR  
RECERTIFICATION AS A PROVIDER OF VIDEO RELAY SERVICE ELIGIBLE FOR  
COMPENSATION FROM THE INTERSTATE TELECOMMUNICATIONS RELAY SERVICES  
(TRS) FUND**

**CG DOCKET NO. 10-51**

By the Chief, Consumer and Governmental Affairs Bureau:

On June 15, 2012, CSDVRS, LLC (CSDVRS) filed an application<sup>1</sup> for Commission recertification<sup>2</sup> as a provider of video relay service (VRS) that is eligible for compensation from the Interstate TRS Fund (Fund).<sup>3</sup> The Consumer and Governmental Affairs Bureau (Bureau) hereby grants the CSDVRS Recertification Application on a conditional basis for a period of sixty (60) days, pending confirmation of CSDVRS's compliance with all applicable rules and orders. We note that we did not specify time limits for prior conditional certifications granted as part of the initial implementation of the certification rules. Based on our experience, however, we believe that a more incremental approach may

be warranted in situations where we find additional time is necessary to assess an applicant's compliance with our rules. Granting conditional certification for 60 days here will avoid service disruptions as we continue the evaluation necessary to determine whether it is appropriate to grant five year certification, or even indefinite conditional certification to CSDVRS. Before granting further certification, we must determine that CSDVRS is qualified to receive compensation from the Fund and that grant of such additional certification would be consistent with the objective of preventing waste, fraud, and abuse to the Fund, as embodied in our VRS rules and orders.

In the *iTRS Certification Order* released on July 28, 2011, the Commission amended its requirements and processes for certifying iTRS providers as eligible for compensation from the Fund, to ensure that iTRS providers receiving certification are qualified to provide iTRS in compliance with the Commission's rules, and to eliminate waste, fraud, and abuse through improved oversight of such providers.<sup>4</sup> These rules require that all iTRS providers obtain certification from the Commission to be eligible to receive compensation from the Fund.<sup>5</sup> They further require that all VRS applicants for certification lease, license or own, as well as operate, essential facilities associated with iTRS call centers and employ their own CAs to staff those centers on the date of their application for certification.<sup>6</sup> Each iTRS applicant for certification is also required to submit specific types of documentary evidence that demonstrate its compliance with Commission rules, including those adopted in the *VRS Practices R&O*.<sup>7</sup> On October 17, 2011, the Commission released the *iTRS Certification Clarification Order*,<sup>8</sup> clarifying certain aspects of the certification requirements adopted in the *iTRS Certification Order*, and modifying section 64.606 of the Commission's rules to lessen the burdens on applicants for certification associated with the submission of certain documentation to the Commission.<sup>9</sup>

Based on our review of the CSDVRS Recertification Application, we grant conditional certification to CSDVRS to provide VRS services for a period of sixty (60) days, to terminate on November 20, 2012, unless such certification is extended for an additional period of time. To assist our determination as to whether to extend certification, we reserve the right to conduct one or more on-site inspections of CSDVRS's facilities by designated personnel, and to request additional documentation relating to CSDVRS's provision of VRS.<sup>10</sup> In the *iTRS Certification Order*, the Commission reserved the right, after initial review of an application, to conditionally grant certification, subject to one or more

subsequent on-site visits to the applicant.<sup>11</sup> The Commission noted that such visits would “better enable the Commission to verify the information provided in a certification application, and help us to better assess an applicant’s ability to provide service in compliance with our rules.”<sup>12</sup> This grant of conditional certification is without prejudice to the Commission’s final determination of CSDVRS’s qualifications, and is dependent on the Commission verifying the information provided in the CSDVRS Recertification Application, including its supplement, and on the veracity of the applicant’s representations that it will provide service in compliance with all pertinent Commission requirements.<sup>13</sup>

Ultimate conversion to full certification will be granted if, based on on-site visits and our review of such additional documentation, the Commission finds that CSDVRS is in compliance with the Commission’s rules and orders, including those rules designed to ensure the accuracy and integrity of Fund payments,<sup>14</sup> and is qualified to receive compensation from the Fund for the provision of VRS.<sup>15</sup> If at any time during the period in which CSDVRS is operating pursuant to this conditional certification, the Commission determines that CSDVRS has failed to provide sufficient supporting documentation for any of the assertions in CSDVRS’s application or that any of those assertions cannot be supported, or finds evidence of any apparent rule violation, fraud, waste, or abuse, the Commission will take appropriate action, including the possible denial of the CSDVRS Recertification Application. In the event of such denial, CSDVRS’s conditional certification will automatically terminate 35 days after such denial.<sup>16</sup> If, however, the Commission grants full certification, CSDVRS, like all VRS providers, must continue to operate in compliance with all relevant Commission rules and orders.
