## **FCC ANNOUNCES MEMBERSHIP OF THE NORTH AMERICAN NUMBERING COUNCIL INTEROPERABLE VIDEO CALLING WORKING GROUP AND THE NATIONWIDE NUMBER PORTABILITY WORKING GROUP'S TECHNICAL SUBCOMMITTEE**

### **CC Docket No. 92-237**

This Public Notice serves as notice that Federal Communications Commission (FCC or Commission) Chairman Ajit Pai has appointed members to serve on the North American Numbering Council's (NANC's)<sup>1</sup> Interoperable Video Calling (IVC) Working Group and the Nationwide Number Portability (NNP) Working Group's Technical Subcommittee. The IVC Working Group is tasked with exploring how to facilitate the provision of interoperable telephone number-based video calling, allowing service providers to voluntarily offer, to any customer, the capability to make or receive video calls between 10-digit North American Numbering Plan numbers.<sup>2</sup> The NNP Technical Subcommittee will help the NANC investigate the technical requirements necessary to support NNP and provide more detailed cost/benefit analyses of proposed solutions.<sup>3</sup> The NNP Technical Subcommittee members will report their actions and recommendations to the NNP Issues Working Group, which, in turn, will report to the full NANC. The members of the working group and subcommittee are listed in Appendix A.

The NANC is organized under, and operates in accordance with, the provisions of the Federal Advisory Committee Act (FACA). The NANC was created to advise the Commission on numbering issues and to make recommendations that foster efficient and impartial number administration.
