Other people might join, or we can just go through the questions you guys have.

I am recording and transcribing this session so we can share it on our website for other people just so you all are aware this is the open office hours for the 2023 for a community grant program we wanted to offer these office hours just to let applicants ask questions and also here answers to other questions that other applicants have.

We are having themes for the office hours at least for the 1st 30 minutes and then opening it up to any questions.

After that, if there's still questions remaining and the theme of this session is the flood recovery track.

A brief description of the flood recovery track.

Obviously, we added this track in in light of the floods over the summer in Vermont.

We worked with our partners to do some initial scoping of where and what damage occurred on recreation infrastructure and also worked with partners to kind of develop what was needed in in a grant process.

Based on all of the other grant opportunities and funding opportunities that were available.

And so that's what we tried to do.

There's some special things about this track #1 is that we are willing to reimburse for expenses starting on July 10th, 10th.

And so we will reimburse for repairs that have already been made.

And secondly, we are really looking to to fund what is like the gap funding needed.

And so we really wanna make, although this is of where a community grant we wanna make the application as smooth as possible for flood recovery.

So we have told the general interest webinar this, but I'll tell you this as well.

You know, some of the questions are based more towards the implementation grants and and outdoor equity grants then towards the flood recovery.

Please answer the questions like the project team for example.

But if the project team is the trails organizations that manages the trails like that is totally fine.

We're not gonna take points away for not being like a cross sector team that's implementing these projects.

Umm, the other thing to note is that we're very interested in hearing from you how the repair will help the situation.

We don't want to make to put more funding into infrastructure that will fail in the next flood, and so I really encourage you to take that time and in the especially, the narrative questions to say like we analyze the situation, we saw why the trail washed out in this place because there was water coming from place.

We never knew it could come from before, and so we realized we needed better infrastructure in this like confluent situation.

And we're repairing it by solving that problem rather than just going out and fixing a trail.

So it looks good now, but the next big rain storm, it won't look good because the same problem will happen.

We're not like holding you to that.

This infrastructure will survive another 8 inch range storm, but we're asking you to start thinking about how the repair will will do that and we really wanna see that.

That's really important.

Umm, if for some reason this is just like a crossing of a river in a floodplain.

If it's like a critical link between a downtown and A and A and a town forest that is still gonna be susceptible, like, tell us why it's that important to keep replacing it.

I think that's my spiel and so.

How we'll do questions is you can raise your hand and it'll put you in order.

We had a lot of flood damage in Marshfield, Umm.

And my first question is we have a section of the Cross Vermont Trail that's on the old abandoned railway grade, uh and uh, it's a Class 4 Rd for that section.

Mm-hmm.

Umm.

It's also the cross front trail and then it goes over into grotten.

Uh, would the fact that it's on a Class 4 road and it's technically classified that way, would that disqualify it?

Or is it still a recreation asset because it's a cross Vermont trail?

If it's designated as a trail, for example the crossword, Montreal or an ETD trail, and it's on a Class 4 Rd that is qualifies as a recreation asset, and so that is is a potential funding like we can fund for that there we do have on our application the class for Rd permission because we need to know that that permission exists on for that recreation recreational use on that route.

So I guess, yeah, I mean like cross front trail has a permission to be on that road.

OK.

The second question related to that particular project is we're getting FEMA funding. It's approximately \$90,000 to fix the road had made to wash out.

Uh, it's but 3 foot of it's it's down about 3 foot from where it was.

And we're gonna get some FEMA funding.

Can we use can we apply for a grant for the portion of FEMA?

That's not gonna be funded.

And then the last question is related to that.

So we have, we're, we've let out a contract to fix the road, right.

You know that's actually gonna start in a few weeks or fix the trail.

Umm there is some additional work that could be done to, uh, make it more resilient in the future.

What happened was there was another, an old abandoned Rd called Sleeper Rd that came down.

The water came down that and then went down the trail.

So if we did something to divert it, you know, with concrete blocks or whatever.

So that's so we could have request funding for the FEMA proportion and then some additional funding for future work like that we do next year, OK?

We have a town force called Stranahan Town Forest.

Although it's just never been declassified.

But it's, you know, definitely a trail.

It was not very.

A portion of it was not very good.

Tend to be wet and everything before.

I don't think it's gonna be female eligible, cause FEMA typically says we'll take it back to where it was.

Well, it was already not very good.

It got worse in the flood.

So my question is, would that be considered a flood?

Uh, fall into the flood damage.

Uh, category, I mean, it was not real good.

It got worse and we want to fix it.

Did the flood damage it to a point that it, like it became unusable or like is not it like was not able to function as a trail anymore.

Umm, that's kind of a that's kind of difficult to answer that well.

I guess we could apply for.

Well, let me ask you can if we apply for the implementation and just if this is not gonna probably be a huge, I mean it might be \$20,000 worth of, you know, we don't wanna do a whole project scope because it'd be it might be as much as a cost to fix it.

I mean, can you if you if you get a cost estimates, can you go right to implementation request for implementation money on something like that?

So that's a good question.

So first, my first thing is if you if you well OK.

I have a couple things for you for the Cross Vermont Trail, I know that Greg Western is interested in applying as well.

OK.

So please coordinate with him.

So you guys aren't applying for the same and maybe you know that already, but OK secondly.

We already.

Also, please only do one flood recovery application, so it's fine if it's in, like if the town of Marshfield is applying for that Class 4 road and the town forest damage like even though they're on opposite sides of the town, that's totally fine.

We just wanna make the grant agreement development as efficient as possible, so we're asking each applicant to only do one application.

Thirdly.


That is like a very much a Gray area that you're describing.


If the trail head, then a bad trail, you knew it was bad and it got wiped out by the flood.


It would count like we know that there are poorly designed trails out there, mostly historic trails that got hurt like we're not gonna like judge you based on like what

people 150 years ago decided about going straight up a hill.
Like we know that like people are working hard to repair those things all the time.
But like my like you know, we're working with a limited amount of funding.
We have a lot of funding, but if, like we can't fund every trail that like got flooded
and then the flooding went away and then now it's like equivalent to what it used to
be.
So like, that's where like you know, it's.

But if there's like some work that you had to do to reopen that trail, we would fund
that.

Could could you, but can you go right to implementation if you have a you know, a
simple budget sort of speak.

So there is like a Gray area there.
Right.
So a simple trail repair project will not score high on implementation.

If you have a simple trail repair project, I direct you towards applying for an RTP
grant which will be opening this winter and so that is just another like we don't want
to repeat funding across our trail grant program.

So like simple trail repair and rehabilitation or like ideal projects for RTP.
So we want to direct people there.

I know they won't.

They RT they will not fund if it's a class for uh.

Doesn't matter if it's the middle of nowhere, we'd have to get it declassified.

I ran through the I went through this before with the railroad grade.

But that's OK, because it was also in northern forest.

Uh has some has some small grants out there that are opening up.

If you're thinking of like a greater Marshfield work Grant that has like more components of the implementation, like connecting work in the down that you're doing in the downtown to your town for, it's like making an accessible trail at the library.


I know there's lots of ideas about that, and then you add repairing some trails at the town forest to that and argue that having trails at the town forest helps the economy in Marshfield as well.

You can add that on but it like so it it would help and implementation track grant but it won't score high if it's the only component.

I know you have other people there.
We also have a a short walking trail that goes around the schoolhouse over the town hall is and some of its now inside the middle of the river.

Uh, and obviously it was built too close to the river.

I mean it's we've had times where it's eroded away, but only a portion was actually

taken out.

And so FEMA may just say, well, we'll pay for that little reroute.

That one little section, but not the whole trail.

But it was flood.

I mean, it was clearly flood damage.

It was.

It's, you know, went to the river.

Could we rebuild the whole trail to a more a better location?

So it's away from the river, more resilient and all that.

And apply for that as as a flood damage project.

I mean, only a portion of the of the trail went in.

It's only probably maybe a mile long, but that's a lot of use.

So that is like where we are kind of feeling that gap that FEMA can't fill.

So like one of the ways we're filling that.

So like the, if you think of it as like the recreational resource is having a walking trail at your school and then saying like we think if we rebuild it, it'll just float out again.

So we wanna relocate it at another in a better location, still providing the recreational resource for the school.

So like you can't relocate it like 5 miles away, but like it's still needs to like provide that same recreational resource.

Right, because we're not sure what FEMA will do in getting an answer from FEMA. It can on recreation stuff is rather difficult.

OK, so maybe if we applied for the old schoolhouse walking trail and the railroad grade, the leftover funds, and fixing the the blocking the water so it doesn't slow down and they can, those two things could be one application, two projects, one application.

So we've already started running into some issues as we were doing our research.

The the biggest thing, obviously for us is we had three well technically two networks

completely get wiped.

Or to apply for some of that floating cover to help get open.

I'm because the only one that will have issue with this hardware because they're also doing all that massive construction cause the road went into the river as well, where we're running into issue.

We sat with some of our vast folks as well because we have some shared trails.

We did a big map on that is the easements, we can't get land owners to get anything over.

It's hard to get even the five years from see, and we know there's spots we were gonna help and put some bridges in on our shared trail and already we're running into just in reach out that land owners will not sign for 25 years to put in engineered bridges or anything like that.

And then with that 10 year reroute.

So we're just curious like with that part and then I guess the second kind of sub piece of that is we have done some work already that would fall under that that 10 year part.

And as we did that in August, would we have to then go back for work already done and also have similar signed agreements?

Yeah, I knew, like, like knowing how this works for for the TV.

And so we'll be able trails.

I know that my owner permissions are like the largest issue.

Umm, it's an like we talked about it and how we could potentially change that policy, but because it's you know general funding umm we can't expand public dollars on our resource that could be closed to the public in less than the amount of time that we've said.

So five years for basic maintenance, 10 years for major reroutes, 25 years for bridges.

And but the 10 year also would be no large scale reconstruction that reroutes.

But it's like with cat, that would be a full regrade of the trail and replaying gravel.

So is that all?

Also under that 10 year, that's what we thought.

The way we it read in the application.
Uh, major infrastructure.

So we are thinking about preparing our first borec grant application and we're thinking that the equity track is the one that we would focus on.

But since the soft open office hours was the first one to come up, I wanted to start asking my questions now and so my first question is, it looked like there was a desire for the other tracks to also sort of show up in the application, and I'm wondering how important that is and.

And I'm also wondering within the flood aspect of that we sustained, you know, maybe \$7000 worth of physical damages from the flooding.

And then another, I think 17,000 of lost income.

If it's important for us to include that track at all, would we include and and we've and we've received some offset from that from a couple different sources.

You can't, so that doesn't work.

I mean, I guess you could, but that's not gonna.

You're not gonna get both, umm, but there is a good chance you would get a flood recovery and another track grant.

We will we we're if you're lost income was from like from programming like that you didn't weren't we can't do that.

So it's it's the infrastructure we will pay for staff time involved in planning and implementing the repairs that you've already done.

Umm, I guess that's not lost income that's just expended expenditures.

So that's like so like unfortunately, we can't do the programming part, but we can do any gap you need filled in that \$7000 that you said.

And then so if we go with an equity track that is just its own separate thing that we could apply for and we can also apply for a flood track and we don't need to try to connect to the two.

I don't think the blood needs to be connected to it, but I in just my first read of the information it looked like there was, there was a desire for the different tracks to for your application to sort of include elements of the other tracks and I couldn't quite tell how.

And so that's why we're now recommending, like flood recovery should be a separate thing and then but but if you apply for a flood recovery grant, you're not nothing will.

That won't take away from your chances, and the other grant tracks?

Umm, because like that would be really unfair.

Ohh you got damaged in a horrible catastrophic flood like you can't have this opportunity now.

That would be pretty mean I think so.

The other thing I did want to mention is like in terms of like the integrating the other grant tracks like for example inclusivity and like reducing barriers to getting outside is integral to all of the grant tracks, but it's like the focus of the outdoor equity grant track.

So like you are right that there are elements that are shared and in particular outdoor equity.

But in, like, really what we're asking people, if the focus is on reducing barriers and in umm increasing opportunities for people to get outside that their equity if doing that is part of like a bigger project that has lots of components and is more complex.

We're asking you to do implementation.

I'm and then again flood recovery is separate.

I'm nick.

What's the eligibility for projects on federal land?

We had a inquiry room in chapter.

That's where has an agreement with the Army Corps of Engineers down Bedford was curious if that would be helpful.

It's you thought it was simple because I was going to say the Green Mountain National Forest went through a whole long process and like if there are gaps, let us know and we'll have to work with them to figure out like, why there was a gap with the Army Corps.

I I don't see why it would be an issue, but we need to ensure that the correct process is in place and so my ask for you is if you could look into.

Whether like what?

Their flood recovery process is like if they have to go through meeba, in which case it seems like it might be difficult to get that in if they haven't planned it already.

I know they're engineering requirements are pretty high on federal land like the

bridges that they're looking at.

So I can I can inquire the extent to which the folks down there have looked into that, but but short answer is doesn't not on its face and eligible but we need to know what the process is.

We've talked about administrative time or or sort of staff time.

We have funded internally some projects, so we have some projects where it's like ohh this thing broke and we put in a new thing.

But we've also funded some chapters where they've had to increase staff time across a network due to like dispersed damage, if that makes sense.

So it's like, you know, they've been cleaning and repairing trail tread and things like that in a more extensive.

So it's less like this thing's being replaced.

It's more we've had to increase our staff hours by X, by X amount.

Curious eligibility.

The transfer that and then the follow up would be just how to document because obviously that's harder.

If it's not, I guess, and that's a general question for staff time cuz it makes sense if you're talking about we contracted a person to do XYZ, but if it's like oh, they put in, you know, a certain number of hours in, be it administrative or operational.

That that would be it would be eligible like the idea is that like they needed to repair damaged trails, to reopen them for the public.

Yeah, simple as like the.

Yeah, good example being we had trail builder who was employed at 30 hours a week and our Woodstock chapter who they increased to 40 hours a week purely to keep up and and to respond to the damage caused through that prolonged series of storms.

Umm basic documentation so and learning a lot about how?

Like what I have, I've been avoiding this question.

And like the 40 and that those hours were allotted to flood recovery.

And then.

Documented like the thing with it, with the timesheet.

We also need documentation.

The person was paid so pay stub associated with that time.

That's going to be and then it would be like what we will need as well is to show as much as possible pictures of a before and after like we require for a grant any grant that we do.

But if there's no pictures of a before because they didn't have time like we understand, like we're asking you this and but like as much as possible, like a documentation that that funding went towards fixing the trail.

Like what kind of damage we're looking at for yours is gonna.

You obviously started working with multiple chapters and so like, you're probably gonna have more.

That's fine for the what I just said.

The photo documentation for reimbursement does not have to go in the application that just like that will be in like your invoice that you send us to get reversed.

How do you what do we recommend for applicants when they have that five image limit that we're supplemental information comes in?
