Subject: Incident Prioritization Worksheet

To assist with the task of prioritizing incidents, allocating scarce firefighting resources, and meeting reporting requirements of the National MAC Group (NMAC), the NW MAC has developed an Incident Prioritization Worksheet (IPW).

The IPW is to be completed each day for each incident with a Type 1 or Type 2 Incident Management Team (IMT) assigned. The IMT should submit the IPW to the Planning Section at NW MAC via fax (503-808-2789) or email (PNWMAC@gmail.com) at the same time the ICS-209 is submitted each day (by 2100). The information submitted on the IPW and the ICS- 209 will be used to validate the short and mid-term strategies, objectives, critical resource needs, threats and probabilities of success for each incident and will be used to prioritize incidents and allocate scarce resources in the Pacific Northwest.

The quality of information submitted on the ICS-209, as outlined in the following table, is essential for successful incident prioritization and resource allocation.

| ICS-209 Block # and Title | Information Provided by IMT |
|------------------------------------|--|
| Block 27 – Communities/ | Specific threats and their time frames |
| Critical Infrastructure Threatened | |
| Block 28 – Critical Resource Needs | Resources needed, listed in priority order based on threats identified in Block 26 |
| Block 42 - Remarks | Critical objectives that will be met if critical resources (Block 27) are made available |

Please note that an IPW must be submitted daily, even if no communities or critical infrastructure are threatened (i.e., even if Block 27 in ICS-209 is blank).

Your remarks are important when establishing an initial value or changing the value during the course of an incident; to provide context of the NWMAC in developing regional incident priorities. Referencing specific blocks on the ICS- 209 would be helpful and avoid duplication.
