The legal voters of the Town of Grand Isle are hereby warned to meet at the Grand Isle Municipal Offices located at 9 Hyde Road on Tuesday, May 17, 2022, beginning at seven o'clock in the morning (7:00 A.M.) when the polls will open, and continuing until seven o'clock in the afternoon (7:00 P.M.) when the polls will close, to vote by Australian ballot on the following Article:


**Article 1:** *Shall the action taken at the meeting of this Town held on March 1, 2022, in spite of the fact that the original Warning for Article 11 contained an error in the sum to be approved for the expenses of the Highway Department budget, in spite of the fact that the Warning lacked reference to a public informational hearing and in spite of the fact that notice of availability of the Town's Annual Report and the auditor's report therein may not have been given in a timely manner, and any act or action of the municipal officers or agents pursuant thereto be readopted, ratified and confirmed?*


The legal voters of the Town of Grand Isle are further notified that voter qualification, registration and absentee voting relative to said meeting shall be as provided in Chapters 43, 51 and 55 of Title 17, Vermont Statutes Annotated.
