She began with pencils, paper, and a typewriter. When she retired in November, Bridget Collier had brought the office of Greensboro's town clerk and treasurer smoothly into the new millenium. She began her career in public service as a town auditor and assistant to her aunt Cleora, the town clerk and treasurer, before being elected to the post herself when her aunt retired. She quickly became an expert in municipal law and a champion of open government.



Bridget also worked on the town's behalf outside Greensboro, serving as president of the board of the Vermont League of Cities and Town, the chair of the committee that organized solid waste management in the Northeast Kingdom, and a member of the group that designed Vermont's statewide voter checklist. She was recognized as Vermont Planner of the Year by the Vermont Planners Association and graduated from the Vermont Leadership Institute.

Bridget's parents were living in a house on the beach road when she was born. She spent her childhood here dreaming of cattle drives in the Old West. After graduation from Middlebury College, where she enrolled as a National Merit scholar, Bridget took several jobs, including a stint writing commercials for WCAX-TV. She then returned to Greensboro, where she dashed off a number of published westerns and romances. Later she created the persona of the Cranky Yankee, writing as a weekly columnist for the Times Argus and the Hardwick Gazette. Her wry take on small-town goings-on, which she subtitled "chewing the cud with the Town Cluck," has earned her many fans.

Bridget's parents were her best friends, and she nursed both of them through their last illnesses. Her mother would have been delighted to see the charming shade gardens Bridget has planted at their house. As Bridget will tell you herself, she has the best d—n hostas in Greensboro.

We'll miss her wit and helpfulness at the town offices, but I'm sure we'll run into her at Willey's.

Auditors' Statement

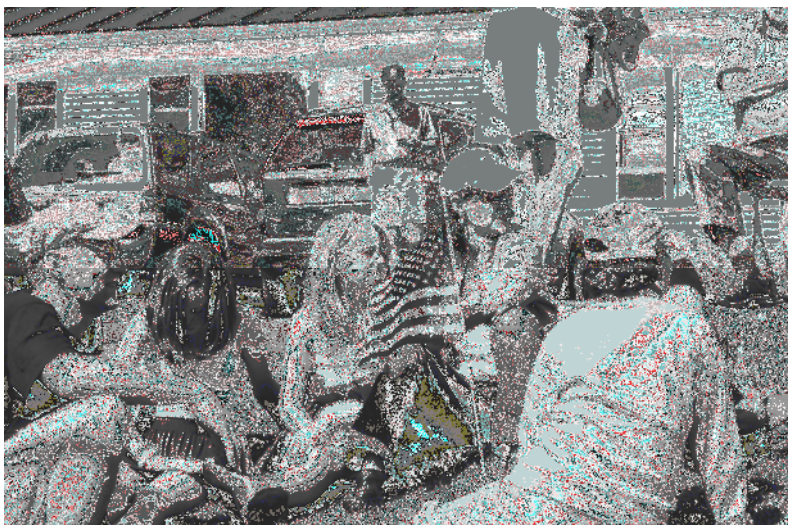
In accordance with VSA 24 §1681, we have examined the accounts and records of the Town of Greensboro. To the best of our knowledge, the financial statements and reports herein show the financial position of the town for fiscal year July 1, 2009, through June 30, 2010.

Specifically, we:

- conducted a detailed audit of property tax income;
- examined a random sample of debit transactions made during the fiscal year to assure that town books matched bank records, that documentation on file in the town offices supports the expenditures, and that the transactions were properly authorized by the select board;
- documented the deposit of payments from the state of Vermont in the town's operating account;
- reviewed the balances in town accounts listed by QuickBooks in its consolidated balance sheet;
- reviewed town revenues and expenditures listed by QuickBooks in its profit and loss statement;
- reviewed the minutes of Greensboro's 2010 town meeting to assure that decisions related to financial matters made there were properly voted and implemented;
- evaluated the town's internal financial controls with the help of an internal control questionnaire made available by the Vermont League of Cities and Towns; and
- examined the books of the Greensboro Town School District.

We remain grateful for the continuing cooperation, assistance, and patience of the staff at the town clerk's office.

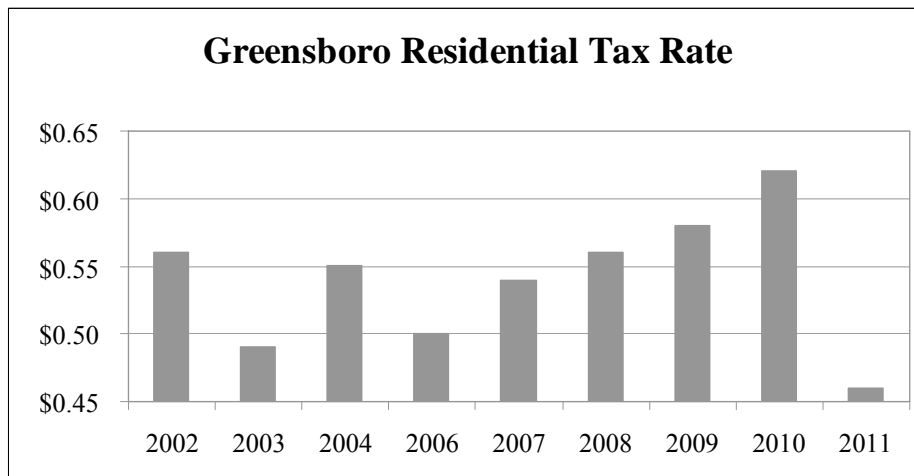
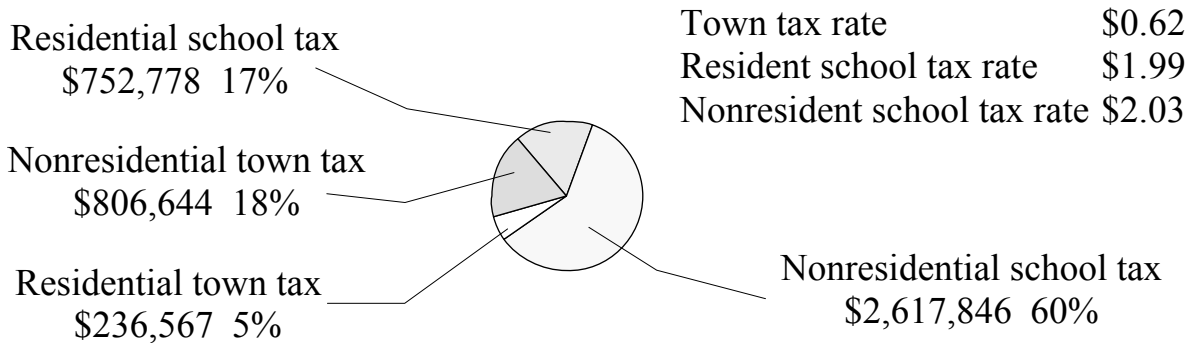

Greensboro Recycling

The recycling center continues to be a popular place on Saturday mornings, especially during the summer.

The July household hazardous waste collection was very well attended. There is only one HHW collection in Greensboro each year; however, residents can bring their HHW to the Northeast Kingdom Waste District headquarters in Lyndonville by appointment, from June through September, at no charge.

The recycling center was again open on Wednesday afternoons from 4-6 p.m. during the summer, and many residents seemed to appreciate this. We plan to continue this next summer.

In addition to the usual recycling items, the following oddball items are accepted every week: plastic shopping bags, aerosols, fluorescent light bulbs, broken dishes and window glass, rechargeable batteries, electronics, hardcover books, and lead sinkers.

The state has recently passed a new 'e-waste' law, which will make most electronic devices free to recycle. I'm not sure at this point if we'll continue to collect these items at the recycling center, or if they will need to be taken to another facility or a retailer.

A spot on the new fire station lot at Tolman's Corners has been reserved for a future recycling building. Do you think the two shipping containers that currently serve as our recycling center are adequate? Would a larger facility better serve the needs of our residents? A new recycling building would have plenty of room to move around in, be well lit, and have space for additional types of recycling. If you have any thoughts about this, talk to Josh or a select board member.

The Giving Closet

The Giving Closet is now located off the lobby of the town clerk's office in the Greensboro town hall. What began with leftover clothes and toys from a 2008 clothing swap at the Grange Hall has become so much more.

People for Lakeview Union School (PLUS)

Lorelei Wheeler

People for Lakeview Union School (PLUS) is a teacher, parent and school community organization whose purpose is the same as that of the school: to provide special support and experiences to the students and staff at Lakeview. Much of the group's funding comes from redemption of returnable bottles. One or two fundraisers are also conducted each year.

A few of the special items P.L.U.S has provided are soccer and basketball uniforms, playground improvements, playground balls and toys, special family field trips to IROC and the Danville corn maze, a bowling field trip, school appreciation events, donations to RIF book distributions, refreshments at school functions and co-curricular activities, kindergarten and grade six graduation assistance, and assistance for the sixth grade's field trip at the end of the year.

Since fall 2009, the PLUS playground committee has been fundraising to renew the current school playground. They have raised \$14,500 toward the \$48,000 planned for the renewal. Several raffles, three family dances, and a letter campaign have helped the group's progress. More work is to be done.

The bottle box is located adjacent to the recycling trailers. Please remember that only carbonated or alcoholic products that are VERMONT/VT redeemable including containers for soft drinks, carbonated water, beer, ale, hard alcoholic beverages, and liquor bottles). Check the label to see whether VT is listed. If it is not, then the container is not redeemable in Vermont. Containers not redeemable are wine bottles, spaghetti sauce jars, plain water bottles, milk containers, tuna cans, noncarbonated iced tea and nonalcoholic lemonade beverages, baby food jars, and pet food cans. All these items are often found in the box. Please do not place non-VT redeemable items or garbage in the bottle box. We raise an average of \$1800 each year just from the bottles and cans for deposit!

We thank the Greensboro community enormously for their continued support.

The Greensboro Fire Department responded to 38 calls from December 2009 through November 2010:

Of these 38 calls, four were made to the town of Stannard, two for car accidents, one for a chimney fire, and one for a bonfire.

Ten of the 38 calls were made to help other departments in our mutual aid system, and two were for help from other departments in our mutual aid system.

Training continued in 2010, with members training two Thursdays each month in-house. The fire department also continued its fire safety training at the Lakeview Union Elementary School with a full response to the school to simulate an actual alarm. We conducted a full burn drill for training with neighboring departments,

using a house donated for such practice.

Members also participated in jaws-of-life training at the Hardwick Fire Department.

In 2010 we applied for and received a grant from the U.S.

Department of Homeland Security to upgrade fire department pagers, complying with new FCC regulations.

As 2010 draws to a close we are well over the 491 calls we had in 2009. Our appropriations requests to towns, based on the number of calls in each town and averaged over the five years, due in part to cost savings from our new billing service.

We continue to recruit new volunteer members. Current members are continuing their education and increasing their certification levels to serve their community better. We have also conducted several CPR/AED and first aid classes in the communities we serve.

Hardwick-Greensboro Restorative Justice

Hardwick-Greensboro Restorative Justice provides dispute resolution services to Hardwick and Greensboro. Its primary work is to make amends for harm caused by crime by holding perpetrators accountable for their actions before and after adjudication. Perpetrators meet with a panel of community volunteers and those affected by low-level crimes to create a contract of conditions to be met by the perpetrator that meets the needs of the victim.

In the 2010 fiscal year, HGRJ served 47 area residents in the pre-charge and reparative probation programs as well as many others indirectly affected by crime. Other community members attended HGRJ events and trainings. Twenty-one volunteers contributed 424 hours to the program. Nancy Potak, a Greensboro resident, is one of four new volunteers and serves on the citizens' advisory board. HGRJ has also helped the Hazen Union Justice League bring restorative practices to the high school and will work to extend the program to the middle school.

HGRJ receives referrals from local law enforcement, the Vermont Department of Corrections, and community members interested in resolving neighborhood disputes or animal ordinance issues. HGRJ offers dispute resolution coaching and educational community events each year.

HGRJ influences the atmosphere of the community by offering allowing victims of crime to have a say in the outcome of cases.



Greensboro Historical Society

2010 was an exciting year for the Greensboro Historical Society as we shaped a new future with expansion of both our building and programs. The program expansion included exhibit focus groups, seminars on the American Revolution, co-sponsorship of an historic play, and outstanding general programs. In the winter an overflow crowd enjoyed a video interview with the late Lewis Hill talking of the collection of Hill artifacts donated to the historical society. Many Hills joined in the occasion and a discussion of life in early Greensboro. During the summer, a lecture and seminars by historian Timothy Breen provided insights into some little known aspects of the American Revolution, and historian Allen Davis linked these broader events to our town. It was a busy summer.



In April the GHS board realized that the generosity of our donors, including the town of Greensboro, and careful management of our construction budget would allow us to complete Phase II of our building project as well as the Phase I we had counted on. So we had a celebration of our new exhibit hall and then continued construction of the lower level work room and archival storage space.

Although obstruction of the normal access to the back of the building cost an additional \$10,000, the building expansion was completed in mid-November. Since then we have been moving in, setting up office and archival space, and preparing for a special exhibit and other uses for the new building in 2011. We hope all of you will visit your historical society and help us preserve the history of our town.

Our thanks to the many contributors to the building fund, the town of Greensboro for support, and all the dedicated volunteers who continue to give their time and energy to the many aspects of our work.

Greensboro Free Library

Mary Metcalf, Librarian

The Greensboro Free Library offers programs and services to both adults and children in Greensboro throughout the year. Programs for children are an important part of the library's mission. Thanks to a generous gift the children's room has been repainted, new carpeting installed, and the furniture re-covered, providing a bright cheerful, exciting room with lots of toys and books for youngsters. Adelle Kresky, the new youth services librarian, offers weekly story hours both at the library, Thursdays at 10:30 a. m. followed by a craft program, and at the Four Seasons Early Learning Center. She also works extensively with Lakeview to provide kindergarten enrichment. Other children's programs this year included Rob Mermin's Bubble Circus, TWA Mercer's drumming workshop, a Craftsbury Chamber Players concert, and a puppet-making workshop. Adult programs include book discussions, which this year focused on *The Reluctant Fundamentalist*, *Lord Jim*, *The Elegance of the Hedgehog*, and *Finnigans, Slaters, and Stonepeppers*. "Menu for the Future", a six-session program, explored food systems and their impact on culture, society and ecological systems. Vince Feeney led a discussion of the history of the Irish in Vermont, and the library again served as an AARP tax center to help residents file their tax returns; call 533-2531 for an appointment.

As a community center, more than 13,000 visitors came to the library in 2010, or 262 per week. Circulation of library materials was more than 19,000 volumes. Twenty-one online databases offer patrons access to a wide range of topics, and the fully electronic catalog may be accessed from anywhere in the world. Individuals with laptops access the internet in the library, on the porch, and in the parking lot. Others use the 12 public access computers to do such things as surfing the web, filing for unemployment benefits, making travel reservations, and educating themselves. The library has a website, a Facebook page, a blog site, which lists all new book purchases, and a Twitter account. The library also sponsored a chili dinner in February, a mystery dinner in July, and an ongoing book sale on the second floor. A number of groups, including Lakeview Elementary School, the Heart of Vermont Chamber of Commerce, and the Northeast Kingdom Travel and Tourist Association, used the second floor community room. Call 802-533-2531 to use the facility—it is free. The library was nominated at the National Book Festival for the National Medal for Museum and Library Service.

By careful management and with the help of our dedicated volunteers we have been able to offer all of these services at a budget that has not risen significantly for three years. Without our volunteers and the financial support of the Greensboro

community, we could not keep the library open. We sincerely appreciate the continued support of the townspeople of Greensboro.

The library is seeking an appropriation of \$10,000 to repair the roofs in the rear of its building. The 2005-2009 renovation of the historic Cuthbertson House did not include work on the roofs of the rear annexes or on the rear roof of the 1950s wing. That set of three roofs now needs to be reroofed, and the annex to the north side of the carriage house needs to be reconstructed to re-anchor it and to improve its pitch and provide more space for insulation. The total estimated cost of the project is \$20,000, of which the Library proposes to raise half from private donations.

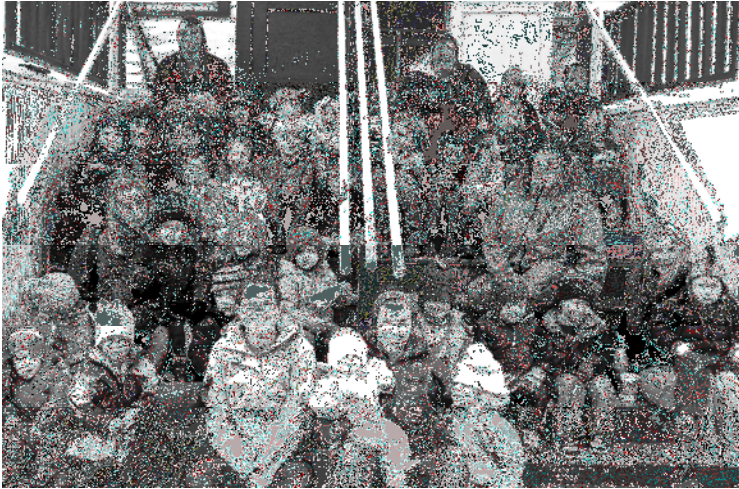

Four Seasons of Early Learning

We welcomed our 21st group of children to the center this year. We continue to offer one of the very few high quality, year-round options for early education in our local area, providing care from six weeks old through to kindergarten.



We had high hopes of having our water issues resolved by this time, but it seems that this is a slow process. We have learned more from the state about what keeping our own well would entail, and it has become obvious that this is not a sustainable option for the school. Instead, we are energetically pursuing options for connecting to an existing

water source, the Greensboro Bend water cooperative. We have had ongoing advice from both Ross Environmental Associates and the Vermont Water Supply Division regarding issues of design of the connecting line and financing options. This is not an easy or quick process, but we are committed to having this preschool serve the community for another 21 years or more, so we will do our very best to make it happen expeditiously and properly.

As always, we are looking to improve our center while keeping the elements that make it so special and so effective. One of the hopes we have for the coming year is redesigning the front yard area, where our play structure is nearing the end of its useful life. In keeping with our nature-based philosophy and programming, we are hoping to create a natural playscape area in front of the school. This would be a relatively inexpensive option, incorporating a wonderful amount of sensory exploration for the children, including plants, textures, sounds and scents. It would also benefit the school as a whole, allowing us to make the outside of our school as attractive to families and the community as the program itself. And of course, it goes without saying that one of our highest hopes is to connect to a reliable, safe water system!

We appreciate your support as we continue to do our very best to help young children to learn to love learning. Children who grow up able to achieve can give their best back to the communities that have nurtured them, and early education is a proven foundation.

Greensboro Nursing Home

It's hard to believe the Greensboro Nursing Home moved 40 years ago from the building that is now our town library into our present lovely space! We are a thriving nonprofit facility with room for 30 residents. Our residents come primarily from Greensboro, Craftsbury and Hardwick, though we are also here for summer residents and others, especially those who have relatives in the area. We work cooperatively with the Craftsbury Community Care Center, Lauredon Apartments, and local hospitals. Each year we provide increasing numbers of meals-on-wheels to community members and continue to loan medical equipment free-of-charge to anyone who needs wheelchairs, walkers, commodes, or crutches.

Our new administrator, John O'Donnell, took over the reins in March from Lance Comfort, who had led us capably for more than 10 years. John comes from upper New York state and is settling into his new position with enthusiasm. GNH, under his leadership, is now emphasizing quality rehabilitation care for short-term residents, physical, occupational and speech therapy, and respite care.

Our residents enjoy a beautiful new patio, installed last summer, which enables relaxation in the sun, gardening activities, and outdoor events such as picnics and ice cream parties. The patio was funded entirely by donations from the grateful family of former residents. Our donated white bus, shared with Wonder and Wisdom and the church, allows residents to go to the doctor and dentist, take excursions to the Caspian Lake beach, attend church, and enjoy outside activities.

GNH continues to be Greensboro's largest employer, with more than 50 caring local employees and a payroll of more than one million dollars a year. Our 25 wonderful volunteers add a great deal to the residents' quality of life. Just come by and see the fun at a Monday afternoon bingo game or watch everyone enjoy the music of the kazoo band, and you'll agree.

In the past ten years, GNH has received four Vermont Quality Care awards and four Gold Star Employer awards. We invite you to look at our new brochure, visit our website, and come by for a visit. Like nursing homes everywhere, we are struggling economically to make ends meet as our costs rise. Medicaid and Medicare do not cover our expenses. We appreciate the help of the people of Greensboro tremendously.

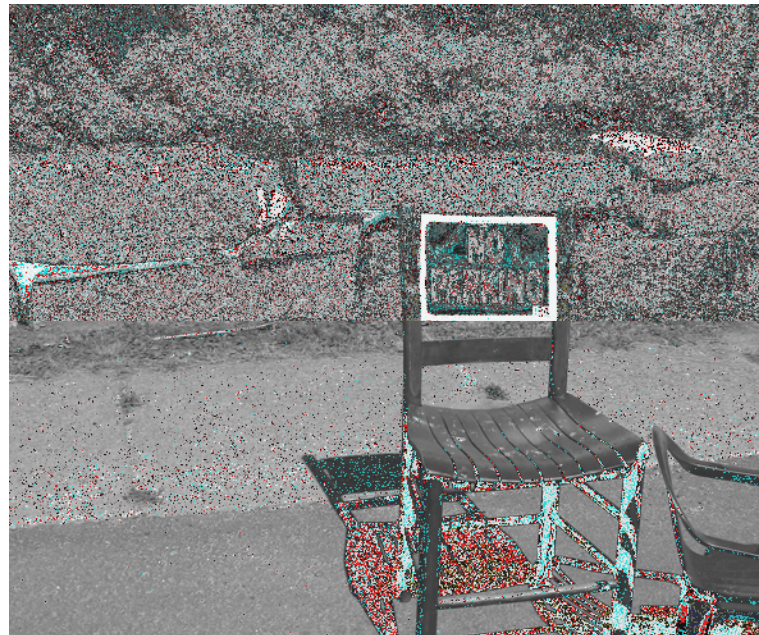
