### Updated Process to Access ASAP

The U.S. Department of Treasury's Automated Standard Application for Payments (ASAP) is an electronic system that federal agencies, including the Department of Justice (DOJ), use to quickly and securely transfer money. All DOJ grantees must remain up to date with ASAP requirements to receive federal funds.

To improve security, the Treasury Department is changing its ASAP log in process.

### **DOJ grant recipients must register and enable multi-factor authentication with [ID.me](#) no later than September 15, 2023.**

After September 15, grantees will not be able to log in to ASAP.gov until they successfully register for multi-factor authentication with [ID.me](#).
