# List for challenging GD improvements

---

## ■ English translation

Vision - provide English translation for all non-English documents which are possibly issued by Offices or by applicants

## ■ Document data in text format

Vision - provide documents which are possibly issued by Offices or by applicants in text (e.g. text embedded pdf) or XML format

## ■ Appeal and Trial decision

Vision - provide documents of Appeal and Trial Decision if the relevant data is available in each Offices

## ■ Enriched Citation

Vision - provide enriched citation information via GD

- CNIPA: Dossiers in readable PDF will be provided in 2022
- USPTO: Not yet determined.
