

## Regulatory Summary

## West Coast Region Limited Entry Drift Gillnet Permit

(March 2018)

This guide summarizes regulations for the West Coast drift gillnet fishery. It provides useful information that will assist owners and operators of vessels with a Federal Limited Entry Drift Gillnet (LE DGN) permit in understanding regulations implementing Amendment 5 to the Pacific Highly Migratory Species Fishery Management Plan.

The LE DGN permit applies to individuals fishing with large-mesh (14 inch or greater stretched mesh) DGN gear that is not stationary or anchored to the bottom. Individuals who target, retain, transship, or land fish captured with a large-mesh DGN must have a valid Federal LE DGN permit. Federal LE DGN permits are issued to an individual, and a vessel must be specified on the permit.

For the complete official fishing regulations, refer to Title 50 of the Code of Federal Regulations (CFR), Part 660. Regulations are subject to change, and with any discrepancies between this summary and the regulations will be resolved in favor of the regulations published in the *Federal Register* and the CFR.

## **Permit Requirements**

#### Q1: What are the general permit requirements?

If you use DGN gear to catch highly migratory species (HMS; swordfish, tuna) a general HMS permit and Federal LE DGN permit are required. All permit requirements are listed below.

#### Federal requirements:

- General HMS Permit endorsed for DGN gear to catch and land HMS off the States of California, Oregon, and Washington. Landing restrictions apply.
- Federal LE DGN Permit to target, retain, transship, or land fish with large-mesh DGN.
- Marine Mammal Authorization Program Certificate issued by the National Marine
  Fisheries Service (NMFS) West Coast Region (WCR) Protective Resources Division. To

#### State requirements:

- California: California State LE DGN permit and California swordfish permit. Visit: https://www.wildlife.ca.gov/Licensing for more information.
- Oregon: Oregon no longer issues DGN permits. DGN landings are prohibited.
- Washington: DGN landings are prohibited. DGN gear is prohibited in waters off Washington by State and Federal law.

#### Q2: How do I apply for a Federal LE DGN permit?

You may request a permit application from the following sources. Only active 2017-2018 State of California LE DGN permits holders are eligible to apply.

#### Q3: Where do I send the completed application and fee?

#### Q4: How do I renew my Federal LE DGN permit?

Permits are valid from April 1 – March 31 and must be renewed yearly. The WCR Permits Office will send notices to renew permits to the most recent address of the permit holder. Permit owners are responsible for renewing their permit prior to the deadline, April 30 of the permit year. A Federal LE DGN permit that is allowed to expire will not be renewed unless the permit owner requests reissuance by July 31 (three months after the renewal application deadline) and NMFS determines that failure to renew was proximately caused by illness, injury, or death of the permit owner. If the permit expires, it will be forfeited and NMFS will not reissue the permit to anyone.

#### **Q5:** How do I transfer my permit to another owner or vessel?

Complete the Drift Gillnet Limited Entry Permit Change of Vessel, Permit Holder, or Vessel Owner Form. Submit this with the required documents to the Long Beach Permits Office. #### **O5:** Continued

Permits can be transferred to another individual if the current permit owner has held the permit for at least three consecutive years, including carryover years of holding a State of California LE DGN permit. Transfers can also be made if the permit holder has a serious illness or permanent disability that prevents the permit holder from earning a livelihood from commercial fishing, if a deceased permit holder's estate or heirs submit a transfer request within six months of the permit holder's death, or upon dissolution of marriage if the permit is held as community property.

#### **Q6:** Are there reporting requirements?

Yes. Federal LE DGN permit holders are required to submit a California Department of Fish and Wildlife Gillnet and Trammel Net Fishing logbook. Logbooks can be obtained by contacting the California Department of Fish and Wildlife.

#### **Q7:** Is there an owner-on-board requirement?

Yes. Owners of the Federal LE DGN permit are required to be on-board while a vessel is using DGN gear. Owners are allowed to designate another individual to fish under their permit for up to 15 days per fishing year. You must notify NMFS of this at least 24 hours prior to a trip by calling (562) 980-4238 or email wcr-permits@noaa.gov. A temporary operator authorization will be issued for that vessel.

If a permit holder is prevented from being on-board a fishing vessel because the person died, is ill, or is injured, NMFS may allow an exemption to the owner on-board requirement for more than 15 days. The person requesting the exemption must send a letter to NMFS requesting an exemption with appropriate evidence. Evidence includes a death certificate or a letter from a certified medical practitioner regarding illness or injury. Requests can be sent to the Permits Office (see Q3).

# **Vessel Monitoring System (VMS) and Observer Requirements** O8: Am I required to have a VMS?

Yes. VMS units are required to be operating on all vessels using large-mesh DGN gear to fish in waters off the U.S. West Coast. Contact VMS OLE for more information (see contact information below).

#### Q9: Am I required to carry an observer?

To facilitate observer placements, vessel owners and operators are required to notify the designated observer contractor, Frank Orth and Associates, at least 48 hours prior to departure on a gillnet fishing trip at (800) 522-7622 or (562) 427-1822. NMFS will monitor compliance with this requirement. NMFS will compare landing receipts and vessel logbooks to Frank Orth and Associates' communication log to verify whether you provided the required pre-trip notification for every gillnet fishing trip you made. Failure to comply with the requirements and deadlines, including failure to notify or refusal to take an observer, is a violation of Federal law for which significant penalties, including forfeiture of catch, may be assessed. All such violations are referred to the NOAA Office of Law Enforcement for appropriate action. Please notify Frank Orth and Associates of all large mesh drift gillnet trips.
