# WHO TO CONTACT FOR WHAT?

Generally speaking, your [SARA State Portal Entity](#) (SPE) will be your primary contact for SARA purposes. Contact your SPE if you want to:

- Change your contact information
- Discuss your SARA participation status (including renewal dates and fees)
- Alert about any changes at your institution such as accreditation status, mergers, acquisitions, or student complaints that would impact your institution's participation in SARA
- Discuss other SARA policy questions or state-specific requirements

- Review any required statements about participating in SARA, such as SARA student complaint language and Professional Licensure Disclosure statements

## COMPLYING WITH SARA POLICY

## COMPLETING REQUIRED ANNUAL DATA REPORTING

The [Institution Directions for Annual Data Reporting webpage is your one-stop-shop](#) for all of NC-SARA's resources and tools for your institution's required annual reporting of exclusively distance education enrollment (EDEE) and out-of-state learning placements (OOSLP) data to NC-SARA.

The reporting window is May 15 - June 15 annually.

# ABOUT SARA

Recognizing the growing demand for distance learning opportunities, higher education stakeholders - including state regulators and education leaders, accreditors, the U.S. Department of Education, and institutions - joined together in 2013 to establish the State Authorization Reciprocity Agreements (SARA).

SARA helps expand students' access to educational opportunities and ensures more efficient, consistent, and effective regulation of distance learning programs. SARA is a voluntary agreement among 49 member states, the District of Columbia, Puerto Rico, and the U.S. Virgin Islands. The agreement establishes comparable national standards for interstate offerings of postsecondary distance education; participating colleges and universities must adhere to stringent requirements, including accreditation and remaining in good financial standing. As of July 2023 nearly 2,400 institutions in 49 member states, the District of Columbia, Puerto Rico, and the U.S. Virgin Islands all voluntarily participate in SARA.
