Conference membership is available to duly elected athletics conferences of colleges and universities that conduct conference competition and determine a champion in one or more sports in which the NCAA conducts championships or for which it is responsible for providing playing rules for intercollegiate competition.

A conference shall be comprised of at least seven core institutions. A conference may include provisional members in addition to the seven core members.

Please note, an athletics conference desiring to become a Division III member conference shall submit this form to the national office by **February 1** for multisport conference membership effective September 1 of that same calendar year. If your application is approved, you will immediately be invoiced the appropriate amount for annual dues (see Bylaw 20.13.2), which will be due no later than September 1.

In addition to this completed form, there are three items that must be submitted at the time of application:

1. A letter detailing the conference's rationale for pursuing Division III conference membership and its viability. This letter shall be submitted and signed by the conference president/chancellor contact (an active member president or chancellor.);
2. The conference's complete bylaws and constitution; and
3. A completed Conference Self-Study Guide using the latest form approved by the Division III Membership Committee. This form can be found on the Division III membership page.
