8. Briefly describe the legal experience and to the extent relevant other business or professional experience of the nominee. (500 word maximum, may include reference to a website for further information.)

I am now in my 22nd year of practice. I was first admitted in California in 1992, and for the first seven-plus years of my career, I was a litigator, practicing primarily in the area of commercial litigation.¹ I then transitioned to a corporate and securities law transactional practice, which has been the exclusive focus of my practice for the past 14-plus years. I spent the first ten years of my transactional law practice in large firms, allowing me to train and gain experience with two highly respect firms with a tremendous variety of clients and work. A former colleague and I then founded our own firm in 2010. My firm represents corporations and other business entities ranging from start-ups to mature public companies, as well as individual and institutional investors, in a variety of matters, consisting of general corporate and corporate governance matters and various transactional matters such as financing transactions, mergers, acquisitions, other change of control transactions and many different types of commercial matters. I was admitted to the Nevada Bar in 2007, and Nevada remains an important part of my practice both because of my Nevada-based clients and also because of my belief that Nevada is an attractive jurisdiction for businesses from an incorporation and corporate law perspective regardless of where they may be physically located.

I have served on the Executive Committee since 2008 for two primary reasons: (i) my belief that Nevada is a business-friendly state from a corporate law perspective and that Nevada should be on every entrepreneur's short list of jurisdictions to consider when forming a new business entity; and (ii) my desire to give back to my profession. Like my career generally, my path onto the Executive Committee was perhaps different than most members' in that just as I did not begin my career as a corporate and securities law attorney, I did not begin my career as a member of the Nevada Bar. But I am very relieved that my career path has taken me to being both a transactional attorney and a member of the Nevada Bar. Over the course of my career, which is now in its third decade, I have become familiar with the Nevada corporate law statutory scheme, which provides several significant benefits for my clients and others who choose to organize/incorporate in Nevada, and I have thoroughly enjoyed being a member of the Executive Committee and part of a group of committed attorneys working to make that statutory scheme even better and to make Nevada even more attractive to its prospective business "citizenry." I remain committed to that goal. I consider it a privilege to have been a member of the Executive Committee, and I would be honored to be able to continue to serve on it and to continue to play a role in the ongoing review and enhancement of the Nevada business law statutes.
