13. When isolating or quarantining Respondent, the State or Municipality will adhere to the following conditions and standards:¹

- a. Isolation and quarantine will be by the least restrictive means necessary to prevent the spread of a contagious or possibly contagious disease that poses a significant and immediate risk to public health.
- b. Isolation and quarantine may include confinement to private homes or other private and public premises. Unless there are exceptional circumstances that would jeopardize public health, Respondent will be allowed to choose confinement in Respondent's home.
- c. If isolated, Respondent will be confined separately from quarantined persons.
- d. If quarantined, and Respondent subsequently becomes infected or is reasonably believed to have become infected with a contagious or possibly contagious disease, Respondent will be promptly removed to isolation.
- e. The health status of Respondent will be monitored regularly to determine whether continued isolation or quarantine is required.
- f. Any isolation and quarantine order will be immediately terminated when Respondent poses no substantial risk of transmitting a contagious or possibly contagious disease to other persons. The court will be promptly notified of the termination date and time.
- g. The needs of Respondent shall be addressed in a systematic and competent fashion, including, but not limited to, providing adequate food, clothing, shelter, means of external communication, medication, and competent medical care.
- h. Premises will be maintained in a safe and hygienic manner and designed to minimize the likelihood of further transmission of infection or other harms to Respondent.
- i. To the extent possible, Respondent's cultural and religious beliefs will be considered in addressing Respondent's needs, and in establishing and maintaining the premises.
- j. Any adverse effects on Respondent's family of isolating or quarantining Respondent will be considered, and appropriate arrangements made to mitigate these effects.
