- 4. Coaches will only report to the court whether or not parents completed the units and attended the coaching sessions. Coaches may not be called to testify to provide any opinion about participation. Judges may ask parents about what they learned.
- 5. Notices to the court:
  - a. **Nonparticipation Notice:** If a parent fails to complete units or coaching sessions in a timely manner, the coach will notify the court in writing.
  - b.  **Status Update:** The coach will file a status update informing the court how many units and coaching sessions each parent has completed
    - after the second coaching session.
