The Alaska State Court Law Library serves the legal information needs of Alaskans by selecting, organizing, and facilitating access to legal research and court system information.

Our mission is to provide accessible and comprehensive legal information resources and services to the judiciary, the legal community, and the public.

There are 3 staffed law libraries and 13 locations with public access computers across Alaska. The main library collection and statewide administration is at the Anchorage Law Library, but library services are available throughout the state.

# What Can You Find at the Law Library?

The print collections are located in Anchorage, Fairbanks, and Juneau. The Anchorage Law Library contains the largest print collection and the government depository collection.

All locations have public computers with access to Westlaw, HeinOnline, eBooks, and other internet-based legal resources.

# **How Can Library Staff Help?**

The Alaska State Court Law Library serves the legal research needs of all Alaskans. Library staff members are available to assist you in Anchorage, Fairbanks, and Juneau.

### **Library Staff can:**

- Provide help with using the library's public computers, copiers, and catalog
- Explain how to use legal research tools and databases
- Help you locate a particular statute or case when you have a reference or citation
- Recommend legal resources
- Suggest a research strategy
- Assist with legislative history research

### **Library Staff cannot:**

- Give legal advice
- Interpret the meaning of statutes, cases, or regulations
- Select statutes, cases, forms, or regulations for your situation
- Tell you how to file a document, what document to file, or how to proceed with court actions
- Help write or prepare legal documents
