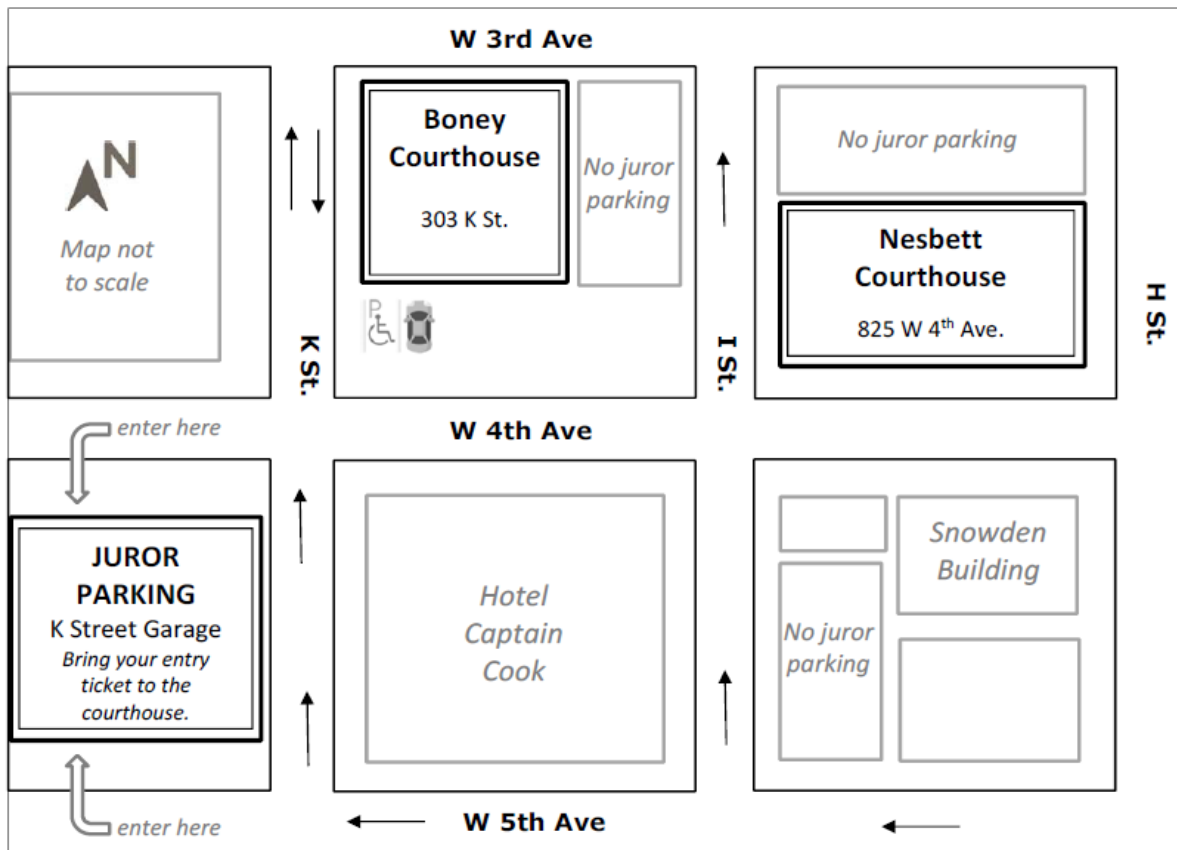

Parking Instructions: Parking is available in the K Street Garage at 400 K Street (next to the Hotel Captain Cook). When you enter the garage you will receive a ticket. Bring this ticket with you to the courthouse to have your parking validated (paid). You will not be reimbursed for parking at other locations. Accessible parking is available at 303 K Street in front of the Boney Courthouse and in the K Street Parking Garage near the exits. Use your service reminder letter to ride the People Mover bus for free on your first day of service.
