

## HOUSE FLOOR AMENDMENT

Second Reading

BY REPRESENTATIVES Bacon and Sullivan

1 Amend printed bill, page 6, after line 22, insert:

2 "(e) IN ADMINISTERING THE GRANT PROGRAM, THE OFFICE SHALL  
3 COLLABORATE WITH STAKEHOLDERS AS NEEDED TO ENSURE EQUITY IN THE  
4 DISTRIBUTION OF GRANTS. THE OFFICE SHALL CONSULT WITH  
5 STAKEHOLDERS TO DEVELOP GRANT PRIORITIES, SET CRITERIA FOR  
6 DETERMINING THE AMOUNT AND DURATION OF GRANTS, SELECT  
7 GRANTEES, AND DETERMINE REPORTING REQUIREMENTS. STAKEHOLDERS  
8 MUST INCLUDE INDIVIDUALS AND FAMILIES IMPACTED BY GUN VIOLENCE;  
9 ORGANIZATIONS WITH EXPERTISE IN GUN VIOLENCE PREVENTION AND GUN  
10 SAFETY, INCLUDING GUN DEALERS, SHOOTING RANGES, AND FIREARMS  
11 SAFETY INSTRUCTORS; AND COMMUNITIES OF COLOR."

12 Page 7, line 23, after the period insert "WHEN THE OFFICE DETERMINES IT  
13 IS APPROPRIATE, THE OFFICE MAY WORK IN COLLABORATION WITH OTHER  
14 STATE DEPARTMENTS AND PARTNERS TO IDENTIFY AND APPLY FOR  
15 FEDERAL GRANTS AND OTHER FUNDING."

16 Page 7, line 27, strike "**report.**" and substitute "**report - repeal.**".

17 Page 8, after line 26, insert:

18 "(3) (a) ON OR BEFORE DECEMBER 31, 2027, AND ON OR BEFORE  
19 DECEMBER 31 EVERY FIFTH YEAR THEREAFTER, THE OFFICE SHALL ISSUE  
20 A REPORT TO THE GENERAL ASSEMBLY SUMMARIZING GUN VIOLENCE  
21 PREVENTION MEASURES ADOPTED BY LOCAL JURISDICTIONS PURSUANT TO  
22 ARTICLE 11.7 OF TITLE 29 OR SECTION 18-12-214. THE OFFICE SHALL MAKE  
23 THE REPORT PUBLICLY AVAILABLE ON ITS WEBSITE OR, IF THE OFFICE DOES  
24 NOT HAVE A DEDICATED WEBSITE, ON A WEB PAGE OF THE DEPARTMENT'S  
25 WEBSITE. NOTWITHSTANDING SECTION 24-1-136 (11)(a)(I), THE REPORT  
26 REQUIRED PURSUANT TO THIS SUBSECTION (3) CONTINUES INDEFINITELY."

27 Page 9, after line 6 insert:

28 "**SECTION 3. Effective date.** This act takes effect upon passage;  
29 except that section 25-20.5-1206 (3), Colorado Revised Statutes, as  
30 enacted in section 1 of this act, takes effect only if Senate Bill 21-256  
31 becomes law, in which case section 25-20.5-1206 (3) takes effect on the  
32 effective date of this act or Senate Bill 21-256, whichever is later."

33 Renumber succeeding section accordingly.
