Monongalia County Schools requests a limited waiver, for school year 2023-2024, of Policy 4321.1, Standards for Child Nutrition, to allow the implementation of an la carte pilot project at University High School, with the provision of selling federally compliant, USDA-approved Smart Snacks during the student lunch periods.

WVDE staff have reviewed the waiver request and **recommend that a limited one-year (school year 2023-2024) waiver for Monongalia County Schools to implement the a la carte pilot project at University High School, with the provision of selling federally compliant, USDA-approved Smart Snacks during the student lunch periods be approved.**

WVDE staff further **recommend that the WVBE direct that: 1) all beverages sold as part of this pilot project adhere to the WVBE requirement of being free from caffeine and non-nutritive sweeteners;**

2) the Monongalia County Board of Education comply with all state and federal regulations and procurement standards; and 3) the Monongalia County Board of Education work with the WVDE Office of Child Nutrition on reporting and technical assistance needs.

3. Marshall University's Addition of a Clinical Teacher of Record (CTR) Program with Webster County - (Action) Attachment D

In May 2023, the West Virginia Educator Preparation Program Review Board (EPPRB) members agreed on a recommendation of approval to the WVBE of Marshall University's addition of a Clinical Teacher of Record Program with Webster County. Policy 5100 provides guidelines and procedures for the approval of new and continuing educator preparation programs of study leading to licensure in West Virginia and also for Clinical Teacher of Record Agreements with West Virginia school districts. Policy 5100 supports the intended collaborative process to improve educator preparation programs and potential educators by incorporating program guidelines based on research and best practices. Support of continuous improvement and clear and consistent guidelines to West Virginia educator preparation programs will produce more effective educators in West Virginia schools, resulting in increased student learning in the classroom.

It is recommended that the WVBE **accept the EPPRB's recommendation of approval of Marshall University's addition of a Clinical Teacher of Record Program with Webster County.**

Policy 5202 establishes the requirements regarding licensure of educators to work in the public schools of West Virginia. As changes occur in education, certification and licensure, and recent legislative changes, policy must be revised to meet the current education system's need. As continuous revision occurs, Policy 5202 reflects many of these changes including the restructuring and formatting changes for the entire policy. Twenty-eight comments were received during the comment period resulting in ten distinct changes (see Attachment F-1) to the proposed policy.

It is recommended that **Policy 5202 be approved and effective 30 days from filing.**

Policy 6200, Handbook on Planning School Facilities, requires all local boards of education to submit amendments to CEFPs to the WVBE and the School Building Authority of West Virginia for approval. The Kanawha County Board of Education requests approval to revise their 2020-2030 CEFP to include a change in their project priority list and the following closures and consolidations.

- 1) Marmet Elementary School is proposed for closure and consolidation into the existing Chesapeake Elementary School.
- 2) Grandview Elementary School is proposed for closure and consolidation into Edgewood Elementary School and Mary C. Snow West Side Elementary School.
- 3) George C. Weimer Elementary School is proposed for closure and consolidation into Alban Elementary School and Bridgeview Elementary School.

These closures and consolidations were approved by the Kanawha County Board of Education and are proposed to occur at the end of the 2023-2024 school year.

It is recommended and a motion is requested that the **Kanawha County Board of Education's request to amend their 2020-2030 CEFP be approved.**
