## **BID NOTICE UNDER OPEN BIDDING**

## Supply and Delivery of Selected Units of Heavy Earth Equipment and Accessories. Proc. Ref. No. MAAIF/SUPLS/2019-20/00378

- The Ministry of Agriculture, Animal Industry and Fisheries to be used for the acquisition of Supply and Delivery of Selected Units of Heavy Earth Equipment and Accessories (Lot 1 – Bull Dozer (1No.), Lot 2 – Chain/Track Loader (1No.) and Lot 3 – Water Bowsers (2No.).
- 2. The Entity invites sealed bids from eligible bidders for the provision of the above supplies.
- 3. Bidding will be conducted in accordance with the open domestic bidding method contained in the Public Procurement and Disposal of Public Assets Act, 2003, and is open to all bidders.
- 4. Interested eligible bidders may obtain further information and inspect the bidding documents at the address given below at 8(a) from 8:00AM 5:00PM.
- 5. The Bidding documents in English may be purchased by interested bidders on the submission of a written application to the address below at 8(b) and upon payment of a non-refundable fee of UGX 100,000/= (Uganda Shillings One Hundred Thousand only). The method of payment will be through the Banks authorised to receive non-taxable revenue.
- 6. Bids must be delivered to the address below at 8(c) at or before 11.00am, on 15<sup>th</sup> April, 2020. All bids must be accompanied by a bid security for: Lot 1 of UGX 32,000,000/= (Uganda Shillings Thirty-Two Million only); Lot 2 of UGX 17,000,000/= (Uganda Shillings Seventeen Million only) and Lot 3 of UGX 22,000,000/= (Uganda Shillings Twenty-Two Million only). Bid securities must be valid until 20<sup>th</sup> August, 2020. Late bids shall be rejected. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below at 8(d) at 11.10am, 15<sup>th</sup> April, 2020.
