The Ministry of Agriculture, Animal Industry and Fisheries to be used for the acquisition of Vehicles; **Lot 1:** Two (2) Station Wagons Vehicles Not exceeding 4500cc, **Lot 2:** Two (2) Station Wagons Not exceeding 3000cc, **Lot 3:** One (1) staff Van Not exceeding 3000cc, **Lot 4:** Three (3) Double cabin pick-up vehicles Not exceeding 2500cc, **Lot 5:** Two (2) Double cabin pick-up vehicles Not exceeding 2800cc
1. The Entity invites sealed bids from eligible bidders for the provision of the above supplies.
2. Bidding will be conducted in accordance with the open domestic bidding method contained in the Public Procurement and Disposal of Public Assets Act, 2003, and is open to all bidders.

The Bidding documents in English may be purchased by interested bidders on the submission of a written application to the address below at 8(b) and upon payment of a non-refundable fee of UGX 100,000/= (Uganda Shillings One Hundred Thousand only). The method of payment will be through the Banks authorized to receive non-taxable revenue.
5. Bids must be delivered to the address below at 8(c) at or before **11.00am, on 15<sup>th</sup> April, 2020**.
