

ARC Projects Approved in Fiscal Year 2020

The Appalachian Regional Commission approved funding for 474 projects in FY 2020 throughout the 13-state Appalachian Region. These projects include:

- Nonhighway projects funded through the Appalachian states' allocations;
- Nonhighway projects funded directly with Commission headquarters monies;
- Nonhighway projects funded through the Partnerships for Opportunity and Workforce and Economic Revitalization (POWER) Initiative; and
- Access road projects funded either through state allocations or from the Highway Trust Fund.
