<b>Activity Type</b> (Drop-Down List)	<a href="#">Activity Type</a> : 120 Certificate Program	
<b>Descriptive Activity Title</b> (Short Answer)	Title should provide learners with a basic understanding of what the activity is about - i.e., Carbohydrate Intake in Individuals with Type 2 Diabetes	
<b>Accountable Contact (AC)</b> (Drop-Down List)	Individuals will only appear in the application if they have provided their contact information and been designated and approved as Accountable Contacts.	
<b>Total Continuing Professional Education Units (CPEUs) Requested</b> (Short Answer)	The AC will enter the total amount of CPEUs requested. Total CPEUs must reflect the <b>average</b> of the three expert reviewers' estimated time to complete the product (will include - live components, enduring components, and time for formative and summative assessment).  For information on minimum CPEU requirements & rounding please refer to Policy 17.3 and 17.4. CPEUs are in increments of 0.25.	
<b>Enduring Components</b> (Multiple Choice)	If the activity has enduring components, the AC must indicate if the enduring components are reading based, non-reading based, or both.  <b>Note:</b> All activity components (including reading-based enduring, live, and learner assessment) must be included on the timing outline.	
<b>Multiple Sessions?</b> (Yes/No)	The AC must indicate if the activity has live components. If the activity does have live components, the AC must indicate if the activity has multiple sessions.  <b>Note:</b> If the total number of sessions is more than 10, conference processing fee applies (Policy 22.0).	
<b>Ethics Related CPE Activity?</b> (Yes/No)	If yes, the AC must select at least one (1) performance indicator from Sphere 1: Ethics.  <b>Note:</b> Activity application can either be ethics <b>OR</b> health equity related.	
<b>Health Equity CPE Activity?</b> (Yes/No)	If yes, the AC must select at least one (1) performance indicator from Sphere 2: Health Equity.  <b>Note:</b> Activity application can either be ethics <b>OR</b> health equity related.

<b>Activity Description for Public</b> (Short Answer)	Should include topic(s), delivery method(s), and requirements for completion.	
<b>Statement of Purpose</b> (Short Answer)	Should include a statement that explicitly indicates the program's purpose and intended learning outcomes (i.e., an indication of the knowledge, skills, judgements and/or attitudes that a practitioner will gain by completing the program).	
<b>Target Audience</b> (Multiple Choice)	Select target audience based on RD/DTR Practice Areas described in the revised <a href="#">2024 Scope of Practice for the Registered Dietitian Nutritionist</a> .	
<b>Learning Objective(s)</b> (Short Answer)	Learning objectives are statements that define the goal(s) of an educational activity. The AC must include at least <b>one</b> learning objective	

<b>Formative Assessment Type</b> (Short Answer)	Formative assessment may be informal or formal assessment.	
<b>Summative Assessment Type</b> (Short Answer)	Summative assessment must be formal assessment.	
<b>Passing Standard</b> (Check Box)	The AC will complete an attestation on the validation of content assessment. For additional information, refer to the <a href="#">Certificate Program activity type definition</a> .  “I, the Accountable Contact, do hereby attest that the CPE submission is in accordance with the Certificate Program activity type definition and contains clear standards for passing the summative assessment, which are communicated to practitioners before engaging in CPE content.”

<b>Three Completed Expert Review Forms</b> (Document Upload)	The AC will upload three Continuing Professional Education (CPE) Material Subject Matter Expert Review Forms completed by expert reviewers speaking to all components of the Certificate Program. Click here to access the <a href="#">Expert Review Form</a> .  <b>Note:</b> A minimum of one of the reviewers must be a CDR credentialed dietitian or dietitian technician, registered.	
<b>Information for Three Expert Reviewers</b> (Document Upload)	Expert Reviewer must have a resume, CV, or bio that contains information that establishes relevant expertise: <ul style="list-style-type: none"> <li>• Education (degree must be from USDE-recognized accrediting agency or foreign academic degree equivalent*); <b>OR</b></li> <li>• Published peer-reviewed journal article; <b>OR</b></li> <li>• Proof of presentation at a reputable, peer-reviewed conference.</li> </ul> <p><b>Note:</b> A minimum of one of the reviewers must be a CDR registered dietitian or dietitian technician, registered.</p>	
<b>Reference List or Bibliography</b> (Document Upload)	All references must be cited, and controversial/disputed issues must be presented as such, with documentation from current and reputable refereed scientific journals.	
<b>Conflict of Interest</b> (Yes/No)	ACs will indicate if conflicts of interest exist within the CPE activity. <ul style="list-style-type: none"> <li>• Refer to Policy 8 for additional information on conflict of interest</li> </ul>	
<b>Commercial Support</b> (Yes/No)	ACs will indicate if commercial support was utilized for the CPE activity. <ul style="list-style-type: none"> <li>• Refer to Policy 9 for additional information on commercial support</li> </ul>

<b>Best Available Research Evidence</b> (Check Box)	<p>The AC will complete an attestation on best available research evidence. For additional information, refer to Content Criteria 5.</p> <p>“I, the Accountable Contact, do hereby attest that the CPE submission is in accordance with the CDR CPEU Prior Approval policies and as such complies with all rules and regulations related to best available research evidence.”</p>	
<b>Performance Indicator(s)</b> (Drop-Down List)	<p>ACs must select at least <b>one</b> performance indicator from <a href="#">CDR’s Essential Practice Competencies</a>.</p> <p>Ethics activity applications must contain at least one PI from Sphere 1: Ethics and health equity applications must contain at least one PI from Sphere 2: Health Equity.</p>	
<b>Activity Date</b> (Drop-Down Calendar)	<p>Activities must be submitted at least <b>48 hours</b> prior to the start of the CPE activity. Exceptions will not be made for late submissions.</p> <ul style="list-style-type: none"> <li>The <b>start date</b> is the date of the live activity.</li> </ul> <p>The <b>end date</b> will be updated by CDR staff upon approval of CPEUs.</p>	
<b>Location(s) – City, State &amp; Country</b> (Short Answer, Drop-Down List & Drop-Down List)	<p>If the <b>live</b> portion of the activity is to be held in multiple locations, please provide a listing that includes each city, state, and country.</p> <p><b>Note:</b> Field is optional within the activity application.</p>

<p>* Within the activity application, the AC will be asked if the individuals responsible for CPE development hold foreign academic degrees. The AC will be asked to upload one of the following:</p> <ul style="list-style-type: none"> <li>Verification of the foreign degree by one of the agencies listed on the <a href="#">Foreign Degree Evaluation Agencies list</a></li> <li>Verification of credentials issued by relevant, recognized, and accredited programs that meet national or international standards</li> </ul> <p>If unable to provide verification, a non-refundable \$50 fee will be added to the activity application review fee (<b>Policy 22.0</b>).</p> <p><b>Note:</b> The AC is responsible for ensuring CPE meets Core Content Criteria. Regardless of upload or additional fee payment, CDR Staff may return the activity application and request additional documentation substantiating expertise.</p>
