Administrative Review – Notice of Deficiency

Dear Col. Danielson:

On March 30, 2020, the Land Protection Division of the Department of Environmental Quality (DEQ) received VAFB's post-closure permit renewal application (Application) dated March 23, 2020, followed by the appropriate application fee. VAFB published the notice of filing in The Enid News & Eagle on April 25, 2020, and submitted proof of publication on May 5, 2020. DEQ has reviewed the Application for administrative completeness in accordance with Title 40 of the Code of Federal Regulations (40 CFR) parts 264 and 270, the Oklahoma Hazardous Waste Management Act (27A O.S. §§ 2-7-101 *et seq.*), Oklahoma Administrative Code (OAC) 252:4 and OAC 252:205 and has noted the following deficiencies:

1. The Application does not include Part A of the RCRA Permit Application. Please provide an up to date Part A application pursuant to 40 CFR 270.13.
2. The post-closure plans for sites ST008 and ST012, Attachments 1 and 2, respectively, include inspection and maintenance activities to be conducted for these units; however, inspection and maintenance activities to be conducted at other units are not included in the Application. Please provide a copy of the general inspection schedule pursuant to 40 CFR 270.14(b)(5) and 264.15(b).
3. The Application includes neither preparedness and prevention information as required by 40 CFR 264 Subpart C, nor a request for a waiver of the preparedness and prevention requirements as allowed by 40 CFR 270.14(b)(6). Please provide either the required preparedness and prevention information or a justified request for a waiver of these requirements.
