### **Outdoor Dining Use Permits Require:**

- Modify existing insurance coverages so that the State of RI is to be added as an additional insured on a primary and non-contributory basis, with a waiver of subrogation on their CGL.
- The CGL must have a minimum of \$1 million per occurrence and \$2 million per annual aggregate. (If it is an umbrella policy, add the State of RI as an additional insured on a non-contributory basis with a waiver of subrogation in favor of the State of RI).
- If licensed to sell liquor, maintain at least \$1 million of liquor liability with the State of RI as an additional insured on a non-contributory basis with a waiver of subrogation in favor of the State of R.I.
- An indemnification clause is required in the agreement, in favor of the State of R.I.
- A description of the proposed use, with seating capacity;
- An aerial photomap of the proposed outdoor dining site overlaid with seating and service layouts;
- A drawing of the proposed outdoor dining use marked with all pertinent dimensions and distances; where possible, designate assigned working areas to staff to limit movement within dining area;
- Establish directional patterns for foot traffic of patrons and staff if possible;
- Images of all proposed signage, fixtures, materials and furnishings;
- Written permission from the property owner to occupy or use the site of the proposed outdoor dining use (if applicant does not own site);
- All relevant forms and certifications required by the State of Rhode Island;
