* Language courses attended in FAO, other UN agencies or Language Institutes **are not accepted** as valid proof of knowledge of FAO official languages. Even if there is an end of session test, it cannot be recognized officially.

* Living and working experiences in a country with English, French, Spanish, Arabic, Chinese or Russian as official language is not recognized as valid proof of knowledge of FAO official languages.
