EXECUTIVE SUMMARY

The document presents the Status of Contributions to the Regular Programme as at 30 June 2021 showing receipts of current assessments and arrears presented as follows:

The main points highlighted are:

As at 30 June 2021:

1. Total number of Member Nations that had paid their 2021 contributions in full are 83.
2. One hundred and eleven (111) Member Nations still owed current assessments (in full or in part), totalling USD 135.07 million and EUR 99.00 million (Appendix A/Appendix B) related to year 2021.
3. The collection rate for current assessments (Year 2021) was 49.25 percent.
4. Seventy (70) Member Nations still owed arrears (relating to assessments for 2020 and prior years) totalling USD 50.40 million and EUR 30.22 million (Appendix B/Appendix C) as at 30 June 2021 and which was equivalent to 16.74 percent of current assessments.
5. Twenty-three (23) Member Nations had arrears in such amounts as to jeopardize their right to vote in accordance with Article III.4 of the Constitution (Appendix G).

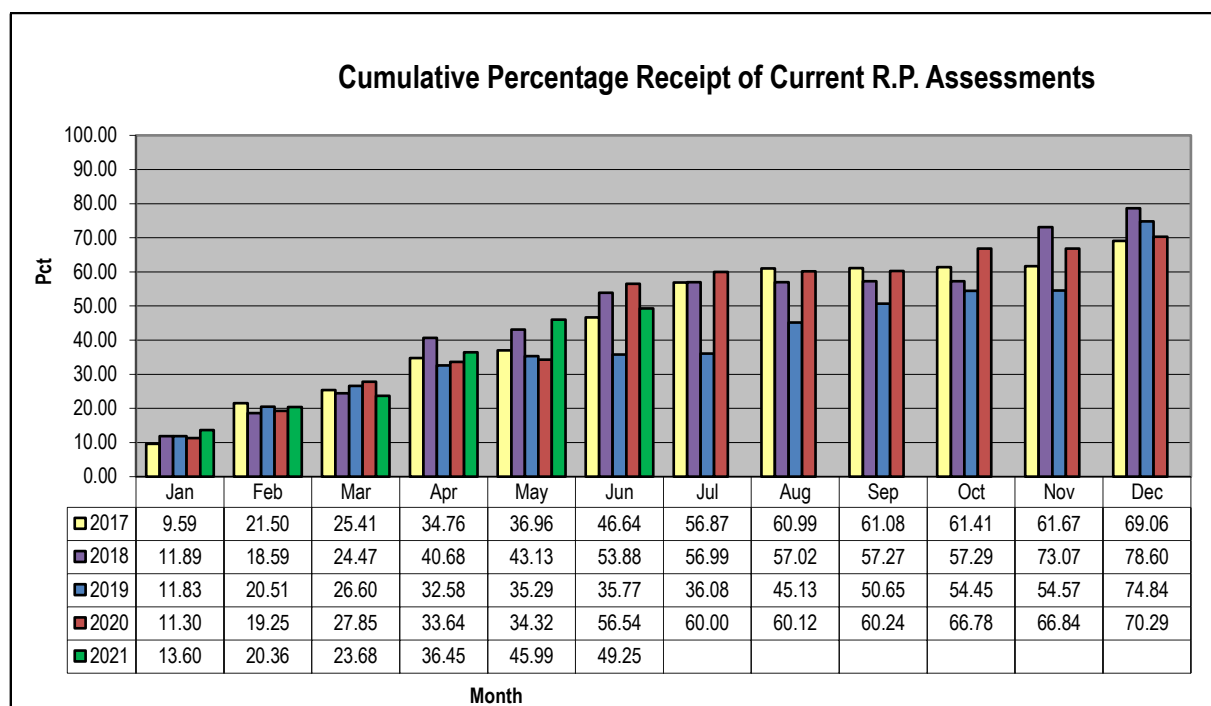

ADDITIONAL INFORMATION REGARDING ARREARS DUE AT 30 JUNE 2021

- The total arrears at 30 June 2021 was USD 50.40 million and EUR 30.22 million (*Appendix B/Appendix C*) equivalent to 16.74 percent of current assessments.
- Ten Member Nations had arrears in excess of USD 1 million: Argentina, Brazil, Colombia, Ecuador, Iran (Islamic Republic of), Libya, Nigeria, Turkmenistan, United States of America and Venezuela (Bolivarian Republic of). In addition, USD 8.4 million remain outstanding from the former Socialist Federal Republic of Yugoslavia. In line with the established practice of FAO, the issue of the arrears accumulated by the former Socialist Federal Republic of Yugoslavia will be dealt with by taking into account the final decision (still pending) taken on the matter at the United Nations (*Appendix C*).
- Arrears exceeding USD 1 million accounted for 93.65 percent of the total arrears due.
- Twenty-three Member Nations had arrears in such amounts as to jeopardize their right to vote in accordance with Article III.4 of the Constitution (*Appendix G*).
- The total of 70 Member Nations in arrears at 30 June 2021 was equal to the figure of 70 as at 30 June 2020.
