EXECUTIVE SUMMARY

The membership of the FAO Oversight Advisory Committee consists of five external members and a secretary *ex-officio*. All members are appointed by the Council on recommendation of the Finance Committee following a selection process managed by the Director-General. The updated Terms of Reference of the Oversight Advisory Committee endorsed by the Council at its 170th Session provide that members may be renewed up to a maximum of six years' service (two terms) on the committee.

- At the expiry of her initial term in June 2022, one member of the committee informed the Director-General that she would not seek renewal for a second term due to her taking up other new initiatives that required her time and commitment. This document proposes to fill the resulting vacancy on the committee.
- In line with Recommendation 5 of the Joint Inspection Unit report *Review of audit and oversight committees in the United Nations system*¹ the skills and professional expertise of the Oversight Advisory Committee members includes "a balanced mix of public and private sector experience at the senior level. In addition, a strong understanding of the structure and functioning of the United Nations system and/or intergovernmental and international organizations is desirable."
- Following an advertisement for the appointment of a member of the Oversight Advisory Committee and interviews conducted by a panel composed of FAO senior managers, as well as an external advisory expert, the Director-General is recommending the appointment to the vacant position of Mr Honoré Ndoko, for an initial period of three years, renewable thereafter up to a maximum of six years in total.
- With the appointment of Mr Honoré Ndoko, the FAO Oversight Advisory Committee comprises three men and two women, with representation from four geographical regions.
- ➤ The profile of Mr Honoré Ndoko, together with the current members of the committee, closely match the professional expertise required to complete the balanced mix of the composition of the committee.

GUIDANCE SOUGHT FROM THE FINANCE COMMITTEE

➤ The Finance Committee is invited to consider the document and make a recommendation to the Council regarding the appointment of one member of the Oversight Advisory Committee following the selection process managed by the Director-General.

Draft Advice

The Committee:

- considered the document in which the Director-General proposed that Mr Honoré Ndoko be appointed as member of the FAO Oversight Advisory Committee for an initial period of three years;
- > noted that such appointment would be made by the Council effective from 12 December 2022;
- > supported the Director-General's proposal and agreed to submit the recommendation to the Council.

INTRODUCTION

- 1. The Oversight Advisory Committee serves as an expert advisory panel to assist the Director-General and the Finance Committee on the internal control arrangements, risk management processes, financial reporting and internal audit, inspection, investigation, ethics and ombuds functions of the Organization. The Oversight Advisory Committee advises on these matters taking into consideration the Financial Rules and Regulations, as well as policies and procedures applicable to FAO, and its operating environment. The Oversight Advisory Committee provides advice and information to the Governing Bodies in these areas, through its annual reports and, as appropriate, updates to the Finance Committee during the interval periods.
- 2. The Oversight Advisory Committee consists of five external members, and the Director of the Office of Strategy, Programme and Budget (OSP) is the Secretary *ex-officio*. Members are selected on the basis of their qualifications and relevant experience at senior level in the areas of: oversight including audit, investigation and ethics, financial management, governance, risk and controls. Due regard is paid in their selection to gender and geographic representation in the committee. The committee elects its own chairperson.
- 3. The committee's <u>Terms of Reference</u> provide that new members serve for an initial period of three years renewable up to six years. The Finance Committee at its 191st Session in May 2022 acknowledged that Ms Anjana Das had informed that she did not wish to seek renewal for a second term as member of the Oversight Advisory Committee and, consequently, the Organization had initiated a process for the recruitment of a new member.

Current Members of the Committee

- 4. Following Ms Das' communication that she would not seek renewal for a second term due to her taking up other new initiatives that required her time and commitment, the composition of the committee comprises:
 - Mr Gianfranco Cariola (Italy), Group Chief Audit Executive of Ferrovie dello Stato Italiane spa, former Chief Audit Executive of RAI spa and Senior Vice President - Head of Audit Plans, Methodologies & ICS of ENI spa. Member since December 2017. His current term, which is not renewable, finishes in December 2023.
 - Mr Fayezul Choudhury (Bangladesh/United Kingdom/United States of America), former Chief Executive Officer, International Federation of Accountants (IFAC), and former Vice President, Corporate Finance and Risk Management, World Bank. His current term, which is not renewable, finishes in June 2025.
 - Ms Malika Aït-Mohamed Parent (Algeria/France/Switzerland), Independent Anti-Corruption Expert, International Speaker and Investigator. Her current term, which is renewable, ends in July 2023.
 - Ms Hilary Wild (Ireland/United Kingdom), Independent Finance and Audit Committee Expert. Her current term, which is renewable, finishes in July 2023.

Actions on Appointments

5. In March 2022, the Organization advertised online for the appointment of members of the FAO Oversight Advisory Committee. The deadline for applications was set to 29 March 2022. In view of the limited number of applications received, in April 2022 the vacancy was circulated among the representatives of the UN System Oversight Committees to reach out to a wider audience. Senior Management, taking into consideration qualifications and relevant experience at senior level in the

areas of: oversight including audit, investigation and ethics, financial management, governance, risk and controls, established a short list of nine candidates to be interviewed. A selection panel chaired by Deputy Director-General Thomas and comprised of Legal Counsel, Director OSP, Deputy Director CSH,² Deputy Director of Cabinet and, as external member of the panel, a former FAO Inspector General and with a Human Resources Officer serving as Secretary to the Panel, interviewed candidates on 28 October and 2 November 2022. Based on the panel's report, the Director-General, in consideration of the candidate's experience in oversight, is recommending the appointment of:

- Mr Honoré Ndoko independent international management and oversight expert
