### Recommendations of FAO's Regional Forestry Commissions for the FAO Programme of Work in Forestry

1. This document contains a summary of recommendations for the FAO Programme of Work in Forestry from FAO's Regional Forestry Commissions, including:

- 1) 29th Session of the Asia Pacific Forestry Commission (APFC29);
- 2) 32nd Session of the Latin American and Caribbean Forestry Commission (LACFC32);
- 3) 31st Session of the North American Forestry Commission (NAFC31);
- 4) 41st Session of the European Forestry Commission (EFC41);
- 5) 25th Session of the Near East Forestry and Range Commission (NEFRC25).

2. The 23rd Session of the Africa Forestry and Wildlife Commission (AFWC23) is scheduled for 22-25 August 2022, and by the time of preparing this document the recommendations were not yet available.
