EXECUTIVE SUMMARY

- The recommendations of the Evaluation of the Technical Cooperation Programme (TCP) were welcomed by Management and acted upon in close consultation with Members through the TCP Strategic Exercise.
- Recommendations are being implemented and results are becoming evident.

appreciated the information provided in the Follow-up report in relation to the measures taken to implement the recommendations of the TCP Evaluation within the context of the TCP Strategic Exercise, carried out in close consultation with Members.

I. Overview/Highlights

1. Management welcomed the Evaluation of the Technical Cooperation Programme (TCP).¹ In particular, Management was pleased to note that the Evaluation confirmed the value of the TCP as a vital instrument to support Members in addressing their priority needs, as well as the emphasis throughout the report on the strategic and catalytic use and effects of TCP resources.

2. Following up on the recommendations of the TCP evaluation is an integral part of the Strategic Exercise agreed with Members. A series of informal and formal consultations with Members have been completed since the TCP Evaluation was discussed at the 129th Session of the Programme Committee in November 2020.

3. Documents submitted to the Joint Meeting of the Programme and Finance Committees summarize the process followed and progress achieved in the implementation of recommendations of the Evaluation.²

4. With regard to the strategic use of TCP, it has been underlined that resource allocation occurs in the context of country level programming through the Country Programming Frameworks (CPFs). The CPF process is now fully derived from the United Nations Sustainable Development Cooperation Frameworks (UNSDCF).³ In addition, all new and ongoing FAO projects and programmes must identify their contribution to the Sustainable Development Goal (SDG) targets through the related Programme Priority Areas (PPAs) in the FAO Strategic Framework 2022-31.

5. FAO Regional Representatives take full advantage and leverage the catalytic role of TCP, in particular for resource mobilization, resulting in an increased and varied number of projects with evidence of impacts. Operational guidelines emphasize this role and communication efforts support sharing and adoption of good practices.

6. Far reaching simplifications to procedures have been introduced over the last few years and an ongoing corporate initiative to enhance the programmatic approach is expected to result in further streamlining, including for TCP.

7. The Strategic Exercise resulting from the Evaluation has set the TCP on a new course through an inclusive process with Members and FAO. Work on improving and refining implementation is ongoing and will continue.
