### 22) Harnessing science and innovation for increased agricultural productivity and competitiveness in the context of the African Continental Free Trade Area (AfCFTA)

This document underscores the transformative power of science and innovation in agriculture. It explores technological breakthroughs, climate-smart agriculture practices and digitalization as key drivers of productivity. Biotechnological advances are highlighted, with an emphasis on the importance of capacity building and supportive policy frameworks. The presentation envisions the role of innovations in fostering intra-Africa trade and global competitiveness under AfCFTA, calling for collaborative partnerships to unlock the full potential of agriculture in the region. Ultimately, it advocates for a forward-looking approach that leverages science and innovation to propel African agriculture to new heights.

### 23) Rediscovering African foods: Promoting native foods for improved nutrition, health and food security

The document *Rediscovering African foods: Promoting native foods for improved nutrition, health and food security* celebrates the nutritional richness and cultural significance of indigenous African foods. It emphasizes the role of native crops and forest-origin foods in addressing malnutrition, preserving cultural heritage, fostering community connections, sustainable use of biodiversity for food and agriculture, and sustainable management and restoration of natural resources and ecosystems, as well as resilience and adaptation to climate change. The discussion explores challenges and opportunities, advocating for value addition, community empowerment and supportive policies. The presentation calls for a collective effort to raise awareness, promote cultivation and integrate native foods into mainstream diets, contributing to improved nutrition, health of people and environment and food security across the African continent. Ultimately, it envisions a renaissance of African foods that reflects the diversity and vitality of the continent's culinary traditions.

#### 24) How to fight against food loss and waste

This paper addresses the multifaceted challenge of food loss and waste, emphasizing its environmental, economic and social consequences. It explores technological solutions, policy frameworks and educational campaigns as key pillars in the fight against food loss and waste. Infrastructure development and public-private partnerships are recognized as critical components, while the importance of monitoring and evaluation is highlighted for sustained progress. Effective policies, strategies, guidelines, legal frameworks and clear implementation mechanisms are required to support food loss and waste reduction initiatives for the continent to attain its regional and global commitments to reduce food loss and waste. The presentation calls for a comprehensive and collaborative approach, involving all stakeholders, to create sustainable and efficient agrifood systems that minimize loss and waste, ultimately contributing to enhanced food and nutrition security in Africa.

#### 26) Global and Regional Food Security Outlook

The *Global and Regional Food Security Outlook* document delves into the complex landscape of food security, addressing global trends, regional disparities and the impact of climate change. It emphasizes the role of technological innovations, trade policies and regional initiatives in shaping the food security landscape. Social and economic factors are recognized as crucial influencers, requiring comprehensive and inclusive strategies. The presentation provides policy recommendations and concludes with a call to action, urging coordinated efforts to secure a resilient and sustainable future for food in Africa and beyond. Overall, it highlights the interconnected nature of global and regional food security challenges and the need for collaborative solutions.

#### 27) Building resilience through agrifood systems transformation

The document *Building resilience through agrifood systems transformation* tackles the urgent need to adapt agrifood systems amid climate shifts, market uncertainties and other shocks. Specifically focusing on Africa, it identifies 13 key "hunger hotspots" where food security is predicted to drastically decline due to a complex mix of factors like conflict, climate variations and economic instability. These issues significantly disrupt food security, escalating social and political unrest while perpetuating cycles of hunger and conflict.

To address these challenges, the report proposes a set of strategies centred on climate-smart agriculture, diversification, infrastructure improvements and capacity building. It emphasizes holistic approaches that encompass inclusivity, digitalization and effective governance. Recognizing the crucial role of community engagement and partnerships, the report stresses collective action in enhancing resilience. Additionally, it advocates for a comprehensive, multi-hazard, cross-sectoral approach that focuses on understanding vulnerabilities, monitoring risks and preparing for crises, including anticipatory actions within agrifood systems. The report highlights the pivotal role of partnerships among diverse stakeholders from governments and United Nations (UN) agencies to donors, private sectors and local communities in effectively tackling shocks and threats to agrifood systems. This emphases on collaboration, data-driven interventions and inclusivity through a comprehensive strategy for stronger and more resilient African agrifood systems leaving no one behind.

#### 28) Financing to end hunger for today and tomorrow (SDG 2)

The Financing to end hunger for today and tomorrow (SDG 2) paper addresses the dual challenge of immediate hunger crises and the long-term goal of sustainable food security. Urging short-term emergency financing for immediate relief, the document emphasizes the need for sustained investment in sustainable agriculture, technology and innovation. Public-private partnerships, empowerment of smallholder farmers and climate resilience financing are identified as critical components in the fight against hunger. The presentation concludes with a call for data-driven decision-making, effective monitoring and evaluation to ensure the accountability and success of hunger-related financing initiatives, ultimately contributing to the achievement of Sustainable Development Goal (SDG) 2 in Africa.
