### **International Experience**

**December 1, 2005 – present – Deputy Director General, Inter-American Institute for Cooperation in Agriculture (IICA).**

Mission is promoting agriculture and reducing rural poverty in the Western Hemisphere. Chief Operation Officer for the institute; Chair, Strategic Partnership Committee; and Interim Director of Agriculture, Health and Food Safety Department, 2006.
