# **MEMBERSHIP OF THE WFP EXECUTIVE BOARD**

In accordance with Resolution 6/99 adopted by the 30th Session of the FAO Conference 1. on 13 November 1999, the Council is required to elect six members of the WFP Executive Board for a term of office of three years from among FAO Member Nations.

2. For purposes of election to the Board, FAO Member Nations are divided into five separate lists (A, B, C, D and E) as shown on the FAO Website: http://www.fao.org/unfao/bodies/council/cl133/Index en.htm.

The Council will therefore be required to elect six members for a term of office expiring 3. on 31 December 2010 to replace the ones whose terms end on 31 December 2007, i.e. Canada (D); Congo (A); Germany (D); Haiti (C); Niger (A); Kuwait (B).

4. Outgoing members are eligible for re-election.

A nomination form is given in <u>Appendix A</u>. The deadline for submission of nominations 5. to the Secretary-General of the Council and Conference is 12.00 hours on Monday 19 November 2007. The election of the above six members will take place at the 134<sup>th</sup> FAO Council (26 November 2007).
