### MEMBERSHIP OF THE WFP EXECUTIVE BOARD

1. In accordance with Resolution 6/99 adopted by the 30th Session of the FAO Conference on 13 November 1999, the Council is required to elect six members of the WFP Executive Board for a term of office of three years from among FAO Member Nations.
2. For purposes of election to the Board, FAO Member Nations are divided into five separate lists (A, B, C, D and E) as shown on the FAO web site:  
[http://www.fao.org/unfao/bodies/council/cl135/Index\\_en.htm](http://www.fao.org/unfao/bodies/council/cl135/Index_en.htm).
3. The Council will therefore be required to elect six members for a term of office expiring on 31 December 2011 to replace the ones whose term ends on 31 December 2008, i.e Algeria (List A); Colombia (List C); Finland (List D); Italy (List D); Slovenia (List E); and United Republic of Tanzania (floating seat, List A).
4. Outgoing members are eligible for re-election. The floating seat occupied by List A for the period 1 January 2006 to 31 December 2008 will pass to List C for the period 1 January 2009 to 31 December 2011.
5. A nomination form is given in Appendix A. The deadline for submission of nominations to the Secretary-General of the Council is **12.00 hours on Monday 10 November 2008**. The election of the above six members will take place at the 135<sup>th</sup> Session of the FAO Council.
