Report of the Hundred and Twenty-sixth Session of the Finance Committee (11-15 May 2009)

Changes in Representation of Members of the Finance Committee: Summary of the Qualifications of Mr Horacio Maltez (Panama) and Mr Christopher Hegadorn (United States of America)

- 1. Rule XXVII-4(a) of the General Rules of the Organization (GRO) states: "If the representative of a Member of the Committee is expected to be unable to attend a session of the Committee, or if, due to incapacity, death or any other reason, he is prevented from exercising his functions for the remainder of the term for which the Member he represents has been elected, that Member shall inform the Director-General and the Chairperson as soon as possible, and may designate a substitute representative who shall have the qualifications and experience referred to in paragraph 1 of this Rule. The Council shall be informed of the qualifications and experience of the substitute representative".
