Continue producing inputs for the preparatory process of the United Nations Conference on Sustainable Development (Rio de Janeiro, 20-22 June 2012), including the joint submission by FAO, IFAD and WFP (para. 42)	FAO has continued its corporate preparations for Rio+20, through interdepartmental mechanisms, focal points in Regional Offices, and by establishing specific Coordination and Policy Teams to develop knowledge products and logistical arrangements to support FAO's engagement with Rio+20. A broad consultative process, coordinated by DDG-Knowledge, resulted in the FAO policy document and brief (Towards the Future We Want), FAO Rio+20 video, shared Rio+20 workspace, and other associated knowledge products. FAO also provided leadership with regard to collaboration and development of joint statements with Bioversity, IFAD and WFP. The preparatory process, and associated inputs, also provide the foundation for follow-up post-Rio, will inform FAO's future programming, and serve as a platform to inform FAO engagement in the post-2015 development agenda.
