### Membership of the Programme Committee

#### Executive Summary

Two Members of the FAO Europe Region, Germany and Belgium, have notified the Organization of their intention to step down from Membership of the Programme Committee, to be effective respectively following the Hundred and Eleventh Session (Rome, 31 May-1 June 2012) of the Committee, and 31 July 2012. The Council is invited to elect candidates whose nomination for the vacated posts were received by 22 May 2012

- Under Rule XXVI of the General Rules of the Organization (GRO), the Programme Committee consists of a Chairperson and 12 Members – two Members from each of the following regions: Africa, Asia and the Pacific, Europe, Latin America and the Caribbean and Near East, and one Member from North America and from Southwest Pacific.
- Two Members of the FAO Europe Region, i.e. Germany and Belgium, have notified the Organization of their intention to step down from Membership of the Programme Committee, respectively following the Hundred and Eleventh Session (Rome, 31 May- 1 June 2012) of the Committee, and 31 July 2012. The notifications received from Germany and Belgium are given in the *Appendix A*.
- Pursuant to Rule XXVI.2 of the GRO, Member Nations from the FAO Europe region seeking election as member of the Programme Committee for the seats to be vacated by Germany and

Belgium were invited to inform the Secretary-General of the Conference and Council of the details of the candidates not later than 20 days before the start of the following Council Session (Rome, 11-15 June 2012), i.e. 22 May 2012. By such deadline two nominations had been received, namely those of Ms Natalie Feistritzer (Austria) and Ms Christina Emma Grieder (Switzerland). Brief CVs of the candidates are provided in *Appendix B*.

4. Under Rule XXVI.1 of the GRO, Members of the Committee shall appoint as their representatives individuals who have shown a continued interest in the objectives and activities of the Organization, have participated in Conference or Council sessions and have special competence and experience in economic, social and technical matters pertaining to the various fields of the Organization's activities.

5. The procedure for the election of Members of the Committee provide for Members Nations of the Organization to stand for election for a specific region, as determined by the Conference for the purpose of Council elections, and the elections are governed by the provisions of Rule XII of the GRO. In accordance with paragraph 10 of this Rule, the Chairperson may submit to the Council that appointment be decided by clear general consent without recourse to a secret ballot when there are not more candidates than vacancies.
