

Ford Idaho Center Contesting Official Rules:

NO PURCHASE OR OBLIGATION NECESSARY TO ENTER OR WIN. VOID OUTSIDE IDAHO AND WHERE PROHIBITED.

ELIGIBILITY: Contesting (the "Contest") is open only to entrants who are legal residents of Idaho and 18 years of age or older as of the date of entry. The following persons are not eligible to enter or win: employees of (i) Global Spectrum, L.P. d/b/a OVG360, or employees of the City of Nampa (collectively "Sponsors"), or (ii) any of the Sponsors' respective parents, affiliates, or subsidiaries, or (iii) any advertising and/or promotional agencies associated with the Contest, whether engaged directly by a Sponsor or not, or (iv) Prize Providers (as defined below) (collectively, (i) through (iv) the "Contest Parties"), or (v) the immediate family members (*e.g.*, the spouse, parents, siblings, and/or children and their respective spouses, regardless of where they reside) and any other members of such households, whether or not related, of any employee of a Contest Party. The Contest is subject to all applicable federal, state and local laws.

HOW TO ENTER: The Contest will commence on the date and time designated in the contest announcement, and upon posting of these Official Rules and end on designated date and time in the Contest announcement, all times are MST ("Mountain Standard Time"), (the "Entry Period").

ENTRY: Methods of entry are determined by the Contest announcements. Common methods of entry can include but are not limited to: visiting <http://fordidahocenter.com> to follow the directions provided to complete the entry form and submit electronically during the Entry Period, participating in a social campaign on a social media platform to complete common actions such as "like", "follow", "tag" someone, "hashtag", or post. By successfully transmitting a completed entry form through the entry methods set forth during the Entry Period, you will be entered in the Contest. Additional entries beyond a specified limit will be void. Sponsors' designated computer will be the official timekeeper for all matters related to this Contest. Entries generated by script, macro or other automated means and entries generated by any other means which subvert the entry process will be void. Entrants must fully complete and submit all non-optional data requested on the entry form to be eligible. Incomplete and/or inaccurate entries are void. No entries will be acknowledged or returned. Proof of submission will not be deemed to be proof of receipt by Sponsors.

DRAWING: Entries must be received during the Entry Period to be eligible for the drawing. Potential winner(s) will be drawn at random upon the end of the Entry Period, from among all eligible entries received. Sponsor reserves the right to delay the drawing. The potential winner will be notified via email, social media messaging, and/or telephone (in Sponsors' discretion). The potential winner **must respond to such notification within seventy-two (72) hours**, or he/she will forfeit the Prize (as defined in Contest announcement) and, at Sponsors' sole discretion and time permitting, an alternate potential winner will be drawn at random from among all remaining eligible entries. The potential winner will be required to execute and return, prior to and as a condition of receiving the Prize, an affidavit of eligibility and liability release and, except where prohibited by law, a publicity release. The potential winner must return such releases within two (2) days of date of issuance. Failure to comply with these Official Rules will cause the Prize to be forfeited and, at Sponsors' sole discretion and time permitting, awarded to an alternate potential winner to be randomly drawn from among all remaining eligible entries. If (i) the potential winner does not respond to the Prize notification within the timeframe stated, (ii) the Prize notification is returned as

undeliverable, (iii) the potential winner declines his or her Prize, or (iv) the potential winner fails to return all required documents within the timeframe stated, it will result in Prize forfeiture and the disqualification of such potential winner and, at Sponsor's sole discretion and time permitting, an alternate potential winner may be drawn by random drawing from among all remaining eligible entries.

The ARV of the Prize may fluctuate based on availability, location and booking of additional events. For Prizes that contain or are tickets, ticket vouchers, or event based: one performance will be awarded for one event. Specific event dates are at the sole discretion of Sponsors and subject to limitations and special conditions. No date substitutions will be permitted, except in Sponsors' sole discretion. Entries will be declared made by the authorized account holder of the email address submitted at the time of entry and he/she must comply with these Official Rules. "Authorized account holder" is defined as the natural person who is assigned to an email address by an Internet access provider, online service provider or other organization (e.g., business, education, institution, etc.) responsible for assigning email addresses for the domain associated with the submitted email address. Released Parties (as defined below) are not responsible for lost, late, incomplete, inaccurate, stolen, misdirected, illegible, undelivered or garbled entries or email; or for entries not received due to lost, failed, delayed or interrupted connections, including Internet Service Provider (ISP), Web-server, network, cable, server, satellite, phone-line connections or miscommunications, or other electronic malfunctions, computer or telephone, hardware or software failures, malfunctions, or garbled or jumbled transmissions. Released Parties are not responsible for any other errors or difficulties of any kind whether human, mechanical, electronic, computer, network, typographical, printing or otherwise relating to or in connection with the Contest, including, without limitation, errors or difficulties which may occur in connection with the administration of the Contest, the processing of entries, the announcement of the Prize, the cancellation or postponement of any event or in any Contest-related materials. Released Parties are also not responsible for any incorrect or inaccurate information, whether caused by site users, tampering, hacking, or by any equipment or programming associated with or utilized in the Contest.
