## Federal Post Card Application (FPCA) and Federal Write-in Absentee Ballot (FWAB) Reference for State Instructions

**Alaska: (FWAB Submission)** The FWAB can be faxed only if the voter requested their absentee ballot by fax or online delivery.

**Arizona: (Additional Requirements)** If the voter is using the FPCA or FWAB to register to vote, they must enclose proof of citizenship with this application. The voter must include a photocopy, not the original documents. If proof of citizenship is not included, the voter will be given a ballot with only federal offices. **(FPCA Submission)** To use the online system, the voter must have received instructions from their election official. **(FWAB Submission)** To use the online system, the voter must have received instructions from their election official.

**California: (Political Party)** Voters who do not provide a political party affiliation can vote for the office of U.S. President in a presidential primary election if the political party allows it. Political party affiliation is not required if requesting an absentee ballot for other primary elections or general elections. **(FPCA Submission)** If using the FPCA to register to vote, the form must be mailed or faxed. If the voter is already registered and is using the FPCA to request an absentee ballot or update registration information, the form can be mailed, emailed or faxed. **(FWAB Submission)** The FWAB can be faxed only if the voter is overseas or activated within 6 days of the election.

**Colorado: (FWAB Submission)** Voters may use Colorado's secure document transfer system to return the FWAB electronically, by going to <https://ballotreturn.sos.colorado.gov> and following the instructions to securely upload the FWAB for delivery to their county clerk and recorder.

**Connecticut: (FWAB Submission)** Voters will need 2 envelopes to submit the FWAB, an interior ballot envelope containing the ballot only placed inside the outer mailing envelope containing the voter's completed affidavit.

**Florida: (FPCA Submission)** If the voter is using the FPCA to register to vote, the form must be mailed. If the voter is already registered and is using the FPCA to request an absentee ballot, the form can be mailed, emailed or faxed. **(FWAB submission)** Voters may fax the FWAB only if they are outside of the U.S.

**Georgia: (Identification)** The voter must provide their Georgia driver's license number or Georgia-issued ID number. If the voter does not have a Georgia driver's license number or Georgia-issued ID number, they may provide the last four digits of their Social Security Number.

**Idaho: (FPCA Submission)** If the voter is using the FPCA to register to vote, the form must be mailed. If the voter is already registered and is using the FPCA to request an absentee ballot, the form can be mailed, emailed, or faxed. **(FWAB Submission)** Voters will need 2 envelopes to submit the FWAB, an interior ballot envelope containing the ballot only placed inside the outer mailing envelope containing the voter's completed affidavit.

**Illinois: (FWAB Submission)** Voters will need 2 envelopes to submit the FWAB, an interior ballot envelope containing the ballot only placed inside the outer mailing envelope containing the voter's completed affidavit.

**Iowa: (Registration FWAB)** Voters can use the FWAB to register to vote, but not to request a ballot. **(FWAB Submission)** The FWAB can be emailed or faxed if the voter is an overseas Uniformed Service member or if the voter is located in a hostile fire area.

**Kentucky: (FWAB Submission)** Voters will need 2 envelopes to submit the FWAB, an interior ballot envelope containing the ballot only placed inside the outer mailing envelope containing the voter's completed affidavit.

**Louisiana: (FWAB Submission)** Voters will need 2 envelopes to submit the FWAB, an interior ballot envelope containing the ballot only placed inside the outer mailing envelope containing the voter's completed affidavit.

**Maryland: (FPCA Submission)** If the voter is using the FPCA to register to vote, the form must be mailed. If the voter is already registered and is using the FPCA to request an absentee ballot, the form can be mailed, emailed, or faxed. Voter's can also use Maryland's online voter registration system to register and request an absentee ballot by going to <https://voterservices.elections.maryland.gov/OnlineVoterRegistration/InstructionsStep1>

**Massachusetts: (Registration FWAB)** Voters can use the FWAB to request a ballot, but not to register to vote.

**Missouri: (FWAB Submission)** The FWAB can be emailed or faxed only if the voter is located in a hostile fire area.

**Nebraska: (FWAB Submission)** The FWAB can be emailed or faxed if the voter received prior approval from their local election office.

**Nevada: (Identification)** The voter must provide their Nevada-issued ID number. If the voter does not have a Nevada-issued ID number, they must provide the last four digits of their Social Security Number. **(FPCA and FWAB Submission)** Voter's may use Nevada's online system by going to [nvease.gov](https://nvease.gov).

**New Hampshire: (Additional Requirements)** Undeclared voters must write in Section 6 "I want to remain an undeclared voter".

**New Jersey: (FWAB Submission)** If the voter is submitting the FWAB by email or fax, they must also mail the original copy of the FWAB.

**New York: (Identification)** The voter must provide their New York DMV-issued ID or the last four digits of their Social Security Number. **(Registration FWAB)** The voter cannot register and vote at the same time using the FWAB. The voter can use the FWAB to request an absentee ballot for future elections. **(FPCA Submission)** The FPCA must also be mailed. **(FWAB Submission)** Voters will need 2 envelopes to submit the FWAB, an interior ballot envelope containing the ballot only placed inside the outer mailing envelope containing the voter's completed affidavit.

**North Carolina: (FPCA Submission)** Voter's may use the North Carolina Military and Overseas Absentee Ballot portal, available at <https://votebymail.ncsbe.gov/app/uocava>.

**North Dakota: (Registration FPCA and FWAB)** Registration is not required in North Dakota. Voters can use the FPCA and FWAB to request a ballot. **(Identification)** The voter must provide their North Dakota-issued ID number, Tribal ID number, Military ID number, or passport number.

**Ohio: (FWAB Submission)** Voters will need 2 envelopes to submit the FWAB, an interior ballot envelope containing the ballot only placed inside the outer mailing envelope containing the voter's completed affidavit.

**Oklahoma: (FPCA Identification)** For the voter to receive their absentee ballot by email/online, they must provide the last four digits of their Social Security Number. **(Additional Requirements)** If the voter's political party affiliation is listed as Independent/No Party in Section 5, they may be able to request a ballot for a recognized political party's primary election. For specific information about recognized political parties in Oklahoma, please visit <https://oklahoma.gov/elections>.

**Oregon: (Identification)** The voter must provide their Oregon-issued ID number. If the voter does not have an Oregon-issued ID number, they may provide the last four digits of their Social Security Number. **(Political Party)** To vote in a primary election for a major party, a voter must enter the name of the party ballot they want to receive. If they do not indicate a political party, they will receive a nonpartisan ballot. **(FWAB Submission)** If the voter is submitting the FWAB by email or fax, additional forms are required for voters voting on local offices or ballot measures. Forms can be found at [www.oregonvotes.gov/myballot](https://www.oregonvotes.gov/myballot).

**Pennsylvania: (Registration FWAB)** Only Uniformed Service members and their eligible family members can use the FWAB for registration. **(FWAB Submission)** Voters will need 2 envelopes to submit the FWAB, an interior ballot envelope containing the ballot only placed inside the outer mailing envelope containing the voter's completed affidavit.

**Puerto Rico: (Additional Requirements)** Voters must provide their father's and mother's first name.

**Rhode Island: (FPCA Submission)** If a voter chooses to email the FPCA, it must be emailed to [uocava@elections.ri.gov](mailto:uocava@elections.ri.gov). **(FWAB Submission)** If a voter chooses to email the FWAB, it must be emailed to [uocava@elections.ri.gov](mailto:uocava@elections.ri.gov). The FWAB can be faxed only if the voter requested their absentee ballot by fax.

**South Carolina: (Additional Requirements)** Voters must provide their race and previous location of registration, if in another state. **(FPCA Submission)** Voters may use South Carolina's Electronic Voter Accessibility Tool to return their FPCA electronically by going to <https://www.scvotes.gov/military-overseas-citizens> and following the instructions to securely upload their FPCA.

**South Dakota: (FPCA Submission)** If the voter is using the FPCA to register to vote, the form must be mailed. If the voter is already registered and is using the FPCA to request an absentee ballot, the form can be mailed, emailed, or faxed.

**Texas: (FPCA Submission)** A timely faxed FPCA must be followed with a hardcopy mailed FPCA that must be received by the early voting clerk by the fourth business day after the fax. **(FWAB Submission)** The FWAB can be faxed only if the voter is located in a hostile fire area.

**Utah: (FPCA Submission)** Voter's may use Utah's online voter registration system by going to [https://secure.utah.gov/voterreg/login.html?selection=VOTE\\_BY\\_MAIL](https://secure.utah.gov/voterreg/login.html?selection=VOTE_BY_MAIL).

**Vermont: (Political Party)** Political party is only required for Presidential Primary Elections. **(Additional Requirements)** If the voter has never registered before in Vermont, they must take a self-administered oath or it may be administered by anyone over the age of 18. The Vermont voter's oath is: *"You solemnly swear (or affirm) that whenever you give your vote or suffrage, touching any matter that concerns the State of Vermont, you will do it so as in your conscience you shall judge will most conduce to the best good of the same, as established by the Constitution, without fear or favor of any person."* Once the voter has read the Voter's Oath, they must write the following in Section 6: *"I swear or affirm that I have taken the VT Voter's Oath."* **(FWAB Submission)** Voters will need 2 envelopes to submit the FWAB, an interior ballot

envelope containing the ballot only placed inside the outer mailing envelope containing the voter's completed affidavit.

**Virginia: (FWAB Identification)** If the voter is already registered to vote and has requested a ballot, they must provide the last four digits of their Social Security Number. **(Registration FWAB)** Voters can use the FWAB to register to vote, but not to request a ballot. **(Additional Requirements)** Overseas citizen voters whose return is not certain, must provide the name of their employer or the name of their spouse's or parent/guardian's employer. If they do not provide this, they receive a ballot for federal offices only. **(FWAB Submission)** Voters will need 2 envelopes to submit the FWAB, an interior ballot envelope containing the ballot only placed inside the outer mailing envelope containing the voter's completed affidavit.

**Wisconsin: (FPCA Identification)** The voter must provide their Wisconsin driver's license number or Wisconsin-issued ID number. If the voter does not have a Wisconsin driver's license number or Wisconsin-issued ID number, they may provide the last four digits of their Social Security Number. **(Additional Requirements FPCA)** If the voter is a temporary overseas voter, who is using the form to register, they must enclose a proof of residence document that lists their current name and voting address. If the voter is a temporary overseas voter and using the FPCA to request a ballot they must provide a valid a copy of proof of identification. **(Additional Requirements FWAB)** If the voter is a temporary overseas voter, they must enclose a proof of residence document that lists their current name and voting address to register to vote. To use the FWAB, they must enclose a copy of proof of identification (such as a Wisconsin driver's license or a passport). **(FPCA Submission)** If the voter is using the FPCA to register to vote, the form must be mailed. If the voter is already registered and is using the FPCA to request an absentee ballot, the form can be mailed, emailed, or faxed.
