Mr. MASSIE, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 277) to amend chapter 8 of title 5, United States Code, to provide that major rules of the executive branch shall have no force or effect unless a joint resolution of approval is enacted into law; providing for consideration of the bill (H.R. 288) to amend title 5, United States Code, to

clarify the nature of judicial review of agency interpretations of statutory and regulatory provisions; providing for consideration of the bill (H.R. 1615) to prohibit the use of Federal funds to ban gas stoves; and providing for consideration of the bill (H.R. 1640) to prohibit the Secretary of Energy from finalizing, implementing, or enforcing the proposed rule titled “Energy Conservation Program: Energy Conservation Standards for Consumer Conventional Cooking Products”, and for other purposes.

1 *Resolved*, That at any time after adoption of this reso-
2 lution the Speaker may, pursuant to clause 2(b) of rule
3 XVIII, declare the House resolved into the Committee of
4 the Whole House on the state of the Union for consider-
5 ation of the bill (H.R. 277) to amend chapter 8 of title
6 5, United States Code, to provide that major rules of the
7 executive branch shall have no force or effect unless a joint
8 resolution of approval is enacted into law. The first read-
9 ing of the bill shall be dispensed with. All points of order
10 against consideration of the bill are waived. General de-
11 bate shall be confined to the bill and shall not exceed one
12 hour equally divided and controlled by the chair and rank-
13 ing minority member of the Committee on the Judiciary
14 or their respective designees. After general debate the bill
15 shall be considered for amendment under the five-minute
16 rule. In lieu of the amendment in the nature of a sub-
17 stitute recommended by the Committee on the Judiciary

1 now printed in the bill, an amendment in the nature of
2 a substitute consisting of the text of Rules Committee
3 Print 118-6 shall be considered as adopted in the House
4 and in the Committee of the Whole. The bill, as amended,
5 shall be considered as the original bill for the purpose of
6 further amendment under the five-minute rule and shall
7 be considered as read. All points of order against provi-
8 sions in the bill, as amended, are waived. No further
9 amendment to the bill, as amended, shall be in order ex-
10 cept those printed in part A of the report of the Com-
11 mittee on Rules accompanying this resolution. Each such
12 further amendment may be offered only in the order print-
13 ed in the report, may be offered only by a Member des-
14 ignated in the report, shall be considered as read, shall
15 be debatable for the time specified in the report equally
16 divided and controlled by the proponent and an opponent,
17 shall not be subject to amendment, and shall not be sub-
18 ject to a demand for division of the question in the House
19 or in the Committee of the Whole. All points of order
20 against such further amendments are waived. At the con-
21 clusion of consideration of the bill for amendment the
22 Committee shall rise and report the bill, as amended, to
23 the House with such further amendments as may have
24 been adopted. The previous question shall be considered
25 as ordered on the bill, as amended, and on any further

1 amendment thereto to final passage without intervening
2 motion except one motion to recommit.

3 SEC. 2. Upon adoption of this resolution it shall be
4 in order to consider in the House the bill (H.R. 288) to
5 amend title 5, United States Code, to clarify the nature
6 of judicial review of agency interpretations of statutory
7 and regulatory provisions. All points of order against con-
8 sideration of the bill are waived. In lieu of the amendment
9 in the nature of a substitute recommended by the Com-
10 mittee on the Judiciary now printed in the bill, an amend-
11 ment in the nature of a substitute consisting of the text
12 of Rules Committee Print 118-7 shall be considered as
13 adopted. The bill, as amended, shall be considered as read.
14 All points of order against provisions in the bill, as amend-
15 ed, are waived. The previous question shall be considered
16 as ordered on the bill, as amended, and on any further
17 amendment thereto, to final passage without intervening
18 motion except: (1) one hour of debate equally divided and
19 controlled by the chair and ranking minority member of
20 the Committee on the Judiciary or their respective des-
21 ignees; (2) the further amendment printed in part B of
22 the report of the Committee on Rules accompanying this
23 resolution, if offered by the Member designated in the re-
24 port, which shall be in order without intervention of any
25 point of order, shall be considered as read, shall be sepa-

1 rately debatable for the time specified in the report equally
2 divided and controlled by the proponent and an opponent,
3 and shall not be subject to a demand for a division of the
4 question; and (3) one motion to recommit.

5 SEC. 3. At any time after adoption of this resolution
6 the Speaker may, pursuant to clause 2(b) of rule XVIII,
7 declare the House resolved into the Committee of the
8 Whole House on the state of the Union for consideration
9 of the bill (H.R. 1615) to prohibit the use of Federal funds
10 to ban gas stoves. The first reading of the bill shall be
11 dispensed with. All points of order against consideration
12 of the bill are waived. General debate shall be confined
13 to the bill and shall not exceed one hour equally divided
14 and controlled by the chair and ranking minority member
15 of the Committee on Energy and Commerce or their re-
16 spective designees. After general debate the bill shall be
17 considered for amendment under the five-minute rule. The
18 bill shall be considered as read. All points of order against
19 provisions in the bill are waived. No amendment to the
20 bill shall be in order except those printed in part C of
21 the report of the Committee on Rules accompanying this
22 resolution. Each such amendment may be offered only in
23 the order printed in the report, may be offered only by
24 a Member designated in the report, shall be considered
25 as read, shall be debatable for the time specified in the

1 report equally divided and controlled by the proponent and
2 an opponent, shall not be subject to amendment, and shall
3 not be subject to a demand for division of the question
4 in the House or in the Committee of the Whole. All points
5 of order against such amendments are waived. At the con-
6 clusion of consideration of the bill for amendment the
7 Committee shall rise and report the bill to the House with
8 such amendments as may have been adopted. The previous
9 question shall be considered as ordered on the bill and
10 amendments thereto to final passage without intervening
11 motion except one motion to recommit.

12 SEC. 4. At any time after adoption of this resolution
13 the Speaker may, pursuant to clause 2(b) of rule XVIII,
14 declare the House resolved into the Committee of the
15 Whole House on the state of the Union for consideration
16 of the bill (H.R. 1640) to prohibit the Secretary of Energy
17 from finalizing, implementing, or enforcing the proposed
18 rule titled “Energy Conservation Program: Energy Con-
19 servation Standards for Consumer Conventional Cooking
20 Products”, and for other purposes. The first reading of
21 the bill shall be dispensed with. All points of order against
22 consideration of the bill are waived. General debate shall
23 be confined to the bill and shall not exceed one hour equal-
24 ly divided and controlled by the chair and ranking minor-
25 ity member of the Committee on Energy and Commerce

1 or their respective designees. After general debate the bill
2 shall be considered for amendment under the five-minute
3 rule. The bill shall be considered as read. All points of
4 order against provisions in the bill are waived. No amend-
5 ment to the bill shall be in order except those printed in
6 part D of the report of the Committee on Rules accom-
7 panying this resolution. Each such amendment may be of-
8 fered only in the order printed in the report, may be of-
9 fered only by a Member designated in the report, shall
10 be considered as read, shall be debatable for the time spec-
11 ified in the report equally divided and controlled by the
12 proponent and an opponent, shall not be subject to amend-
13 ment, and shall not be subject to a demand for division
14 of the question in the House or in the Committee of the
15 Whole. All points of order against such amendments are
16 waived. At the conclusion of consideration of the bill for
17 amendment the Committee shall rise and report the bill
18 to the House with such amendments as may have been
19 adopted. The previous question shall be considered as or-
20 dered on the bill and amendments thereto to final passage
21 without intervening motion except one motion to recom-
22 mit.
