

Drought Response Operations Summary Sheet

The tables below reflect operations under the Drought Response Operating Agreement (DROA), beginning in 2021, including 2021 releases under DROA II(A)(3)(j), the 2022 DROA Plan, and the 2023 DROA Plan.¹ These tables will be updated on a monthly basis to reflect Drought Response Operations, which include releases and recovery.

Drought Response Operations may differ from planned operations due to changes in hydrologic conditions and real-time operations. All units are in thousands of acre-feet (kaf). Positive values indicate Drought Response Operations Releases, and negative values indicate Drought Response Operations Recovery. Recovery volumes are provisional and subject to discussion among DROA parties.
