ADDING AN ENVIRONMENTAL AREA OF LAW TAB

LOCATING NOAA ADMINISTRATIVE DECISIONS

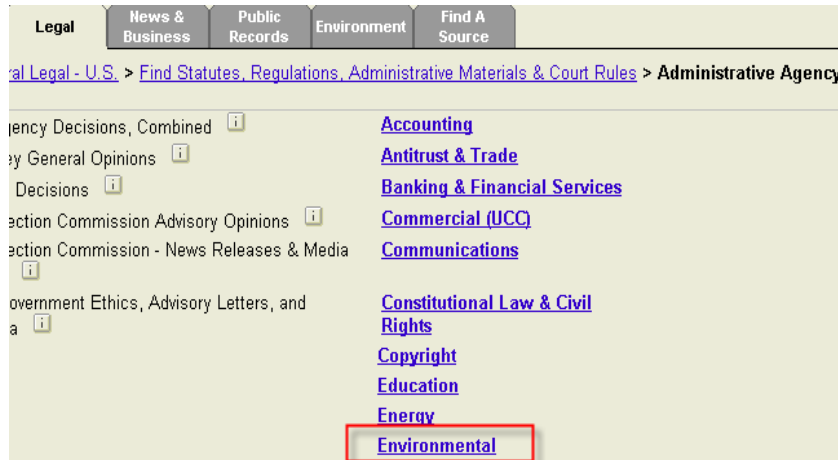
1. From the Legal tab, scroll down to the "Federal Legal" section. Click on "View More Sources."



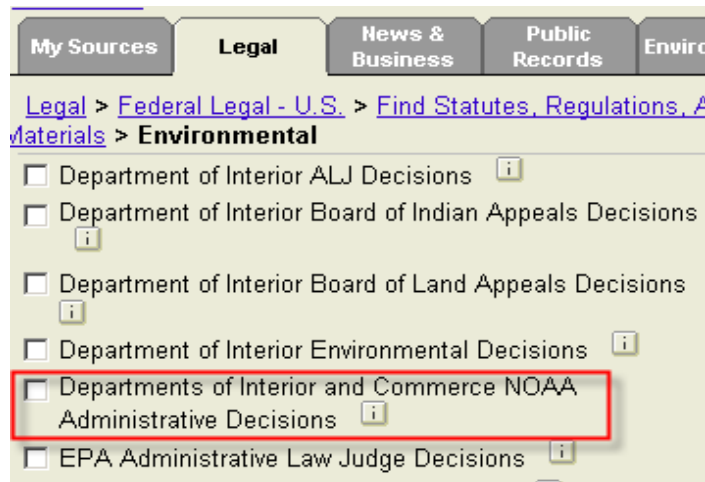
2. Once the screen re-populates, scroll down to "Find Statutes, Regulations, etc." and select "Administrative Agency Materials."



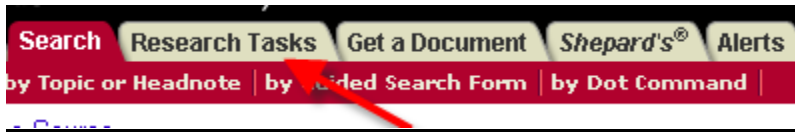
3. Then select "Environmental" on the right side.



4. NOAA decisions will appear on the left side of the screen.



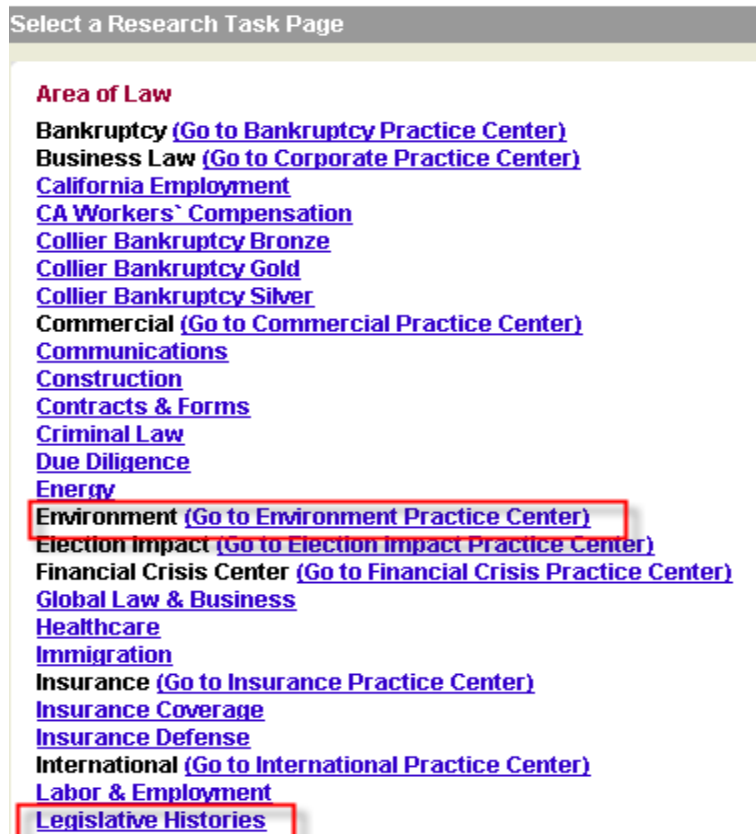
