

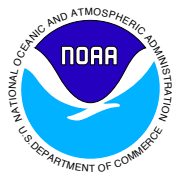

Great Lakes Ice Climatology Update: Winter 2006 – 2011

Description of the Digital Ice Cover Dataset

1. INTRODUCTION

A 6-winter digital ice cover data set consisting of 389 ice charts of total ice concentration (the fraction of a unit of surface area covered by ice), was downloaded from the National Ice Center (NIC) website, http://www.natice.noaa.gov/products/great_lakes.html. This report updates GLERL's 33-winter ice climatology dataset for total ice concentration (Assel 2003, Assel 2005). Data processing and quality control procedures, file structure, format, and naming conventions are described. The data are available as fixed formatted ASCII grids (2.55 km for winter 2006 and 1.275 km for winters 2007-2011) and has been converted to ArcMap feature classes for GIS users. Temporal distribution of the ice charts is summarized in tables. A planned companion report will contain an analysis of these data including spatial patterns of dates of first ice, last ice, ice duration, and ice concentration anomalies [relative to a 30-winter (1973-2002) base period] for each lake by winter season. It will also contain lake averages of total ice cover concentration that portray the seasonal progression of ice cover each winter.

Since the last updated ice atlas (Assel 2005), there has been significant change in ice cover on the Great Lakes. This update of the ice atlas should be useful to the research community as well as others who rely on Great Lakes ice data for planning purposes. The technical memorandum that updated the ice atlas for winters 2003, 2004, and 2005 (Assel 2005) did not include ArcGIS feature classes, so those are included here.

Lake ice cover is a sensitive indicator of regional climate and climate change (Assel et al. 1995; Assel and Robertson 1995; Magnuson et al. 1997, 2000). Seasonal ice cover repeats each year with large interannual variability. For example, the maximum ice coverage over all of the Great Lakes was 95% in 1979 and only 11% in 2002 (Bai et al. 2012). Possible contributors include interannual and interdecadal climate variability, and long-term trends (Assel 1990), some of which may be related to global climate warming. Even in response to the same climate forcing, Great Lakes ice cover may experience different spatial and temporal variability due to an individual lake's orientation, depth (i.e., water heat storage, Assel et al. 2003), and turbidity (i.e., albedo due to sedimentation). To predict seasonal and interannual variability of lake ice cover using statistical analysis, the first step is to investigate the predictability, which is measured by the ratio of the mean (climatology) to standard deviations (i.e., variability). In general, the larger the ratio between the two, the higher the predictability. In other words, if the standard deviation is larger than the mean, the mean is a poor predictor (Assel et al. 2004). In addition, under the same climate forcing, lake ice may respond differently in the upper and lower Great Lakes.

2. DISTRIBUTION OF ICE CHARTS BY WINTER SEASON

The number of ice charts per winter season, Table 1, ranged from 45 to 55, with the exception of the last winter, 2011, when it was 151. The NIC began producing daily charts for GLERL in winter 2011 because of a request from GLERL's hydrodynamic modelers to provide daily ice chart analysis for their use. The dates of first ice charts range from the last week in November to the first week in December, and the dates of the last ice usually occur in early to mid May. Winter 2010 was mild, and the last ice chart occurred in mid-April. The number of days between the first and last ice chart ranges from 162 to 130, with a median value of 158. The average number of days between consecutive ice charts ranged from approximately 3.1 to 1.1 days, with a median value of approximately 3.25 days. The date of individual ice charts for each winter is given in Table 2.

3. NIC ASCII GRID FILES

The dates of NIC ASCII grid files are the dates these files were produced at NIC and not necessarily the date the data in these files was observed. This is discussed further in section 4.2. The following metadata for NIC ASCII grid files was abstracted from a file on the NIC web site at http://www.natice.noaa.gov/products/great_lakes.html under Category "Daily Ice Concentration," and Format "Metadata" for winter 2009: "Data for the analyses can go back 96 hours from when they are completed."... "They are based on an analysis and integration of all available data on ice conditions, including weather and oceanographic information, visual observations from shore, ship and aircraft, airborne radar, satellite imagery and climatological information." The reader is referred to that web site for more metadata details.

3.1 Spatial Resolution and Grid Size

National Ice Center ASCII grid files and NIC graphic ice chart files were downloaded from the NIC website for winters 2006 through 2011. As in Assel (2003, 2005) and as described in Norton et al. (2000) the ice data for winter 2006 was mapped into a Mercator projection and re-sampled to a 510×516 pixel grid covering the Great Lakes area with a grid resolution of 2.55 km. The latitude of true scale is approximately 45° N, actual grid resolution varies with latitude, $L \approx (2.55 * \cos f / \cos 45)$, where f is the latitude. Starting in winter 2007, and for subsequent winters, the data was re-sampled to a 1024×1024 pixel grid. The grid spacing for the 1024×1024 grid is specified at the equator as 1.8 km. Actual grid resolution is $d \cos f$, where d is the spatial resolution at the equator, and f is the latitude (Schwab et al. 1992). For example, the grid spacing for the 1024×1024 grid is 1.275 km at 45°N.

During the 2007 season, 23 ice charts were given in the 510×516 pixel grid, and 23 ice charts were in the 1024×1024 pixel grid. Software was developed at GLERL to transpose the 510×516 grid ASCII files to the 1024×1024 grid, see Appendix A-1. A comparison of lake-averaged ice cover for the 1024×1024 grid and 510×516 grid for winter 2007 (23 ice charts) is given in Appendix A-2. There is a bias for slightly greater lake-averaged ice cover for the 510×516 grids, but as seen in Appendix A-2, the maximum differences are 2%, and differences are less than 2% in most cases.

3.2 File Structure, Record format, Ice Codes, and File Names

The first six records of each ASCII grid file contain header information in the following order: 1) the number of columns, 2) number of rows, 3) xllcorner, the X coordinate (longitude) of the lower-left corner of the grid, expressed in meters from a reference meridian, 4) yllcorner, the Y coordinate (latitude) of the lower-left corner of the grid expressed in meters from the equator, 5) the cell size in meters, and 6) the code for no data (-9999). Records 7 through 516 (for the 2.55 km grids), 1030 (for the 1.275 km grids) contain the ice concentration data in fixed I3 format. Ice concentration values are 0, 5, 10, 20, 30, 40, 50, 60, 70, 80, 90, 95, and 100 and have units of percent. Land grid cells have a code of -1. File names encode the year (four digits), month (two digits), and day (two digits) of the ASCII grid and are preceded with a “g” for Great Lakes and have a file extension of “.ct”, indicating total ice concentration. As an example, the file for December 2, 2004 is given as “g20041202.ct”.

4. QUALITY CONTROL PROCESSING

4.1 Ice Codes and Land Mask

The NIC ice codes on the ASCII grid files were converted to GLERL’s ice concentration codes and then processed through GLERL’s land mask, Appendix A-3, to produce a file with ice concentration codes and a consistent set of over-water grid cells. Recall that for winter 2006, NIC still produced 510×516 ASCII grids, so the old GLERL land mask (GLmask2.txt) was applied to these data to be consistent with the NOAA Great Lakes ice atlas data from 1973 to 2005. GLERL developed a new land mask for the 1024×1024 grid (for winters 2007-2011) based on the NOAA Great Lakes CoastWatch land mask to be consistent with grid data produced by the GLERL CoastWatch node. Applying the GLERL land mask, the old 510×516 mask for winter 2006 and the new 1024×1024 mask for winters from 2007 forward, resulted in a number of over-land grid cells on the NIC ASCII file being over-water grid cells in the GLERL ASCII file. These grid cells were given a code for missing data [-99], and software was written to estimate the ice concentration for these cells using over-water cells in the proximity of the missing data cells. These inconsistencies are due to minor differences in the NIC and GLERL [raster] shoreline in the NIC and GLERL ASCII files. Software similar to that given in Appendix 1 (see “apply the cw mask to standardize land and water grid cells” in program tran5.for) was developed to fit the NIC 1024×1024 ASCII grid data to GLERL’s 1024×1024 land mask, and a computer program similar to fillx07.for in Appendix 1 was used to estimate ice cover concentration for over water grid cells with -99 codes.

A count of the number of grid cells with a code of -99 was calculated for each ASCII grid file after the land mask was applied. The ASCII file was compared to the original NIC graphic file. If the number of cells with a code of -99 were small, corrections were applied to the GLERL version of the ASCII file in a text editor. An example of this occurred on the ASCII file for December 8, 2009 where a small area on Lake Erie at the head of Long Point was coded 0% ice cover in the ASCII file, and the NIC graphic file indicated it should have been 100% ice cover.

If there were a large number of cells with a code of -99, that file was not included for further analysis. This was a relatively rare occurrence. In some cases, the NIC was informed of a questionable raw data file, and they provided a corrected version of the ASCII file. An example of this occurred for a polygon in Lake Huron for January 22, 2007 that was coded 30% ice cover, while it should have been 0% ice cover. The NIC provided a corrected version of that ASCII grid.

4.2 Ice Chart Dates

Spatial distribution patterns of ice concentration were compared between graphic files produced on the NIC web site and GLERL graphic files produced from NIC ASCII files downloaded from the NIC web site. The objective of this comparison was to see if the NIC Graphic and NIC ASCII file had the same date for the same spatial ice cover patterns. Dates were not always the same for the same spatial patterns. When dates were different, the graphic file date (which was always a day earlier than the ASCII grid file date) was used to correct the date on the ASCII file. The rationale for making that adjustment is that since the graphic file existed a day earlier, it is likely that the ASCII grid file, which is a raster product produced from ARC/GIS coverage, was created the next day. Lending credence to this rationale is the fact that the Canadian Ice Service (CIS) and NIC each produced one ice chart each week during the winter and exchange data during the season in near real-time. The CIS ice chart file is used by NIC to produce special products such as the ASCII grid file for GLERL's use and different products for other users. Thus, it is likely that sometimes the CIS ice chart vector coverage is converted to ASCII raster grid coverage a day after they are received at NIC from CIS. The changed dates on ASCII grid files are summarized, indicated by shading, in Table 2. Note that no changes were made for winters 2006, 2007, and 2011. In winter 2011, there were 12 cases when the NIC ASCII file dates were 1 day later than the NIC graphic files, Table 3. The frequency of 1-day difference in 10 of these 12 cases occurred every 7th day, indicating that it was CIS data. However, it was not possible to adjust the dates on these 12 NIC ASCII grids, because there were already other NIC ASCII grid files on these dates. The reason for this is not known at this time but may be related to the NIC production of ice charts each day instead of twice per week as was the case in other winters.

5. ArcGIS FEATURE CLASSES

5.1 Preprocessing

In order to complete the update of the Great Lakes ice atlas, graphic images (.jpg files) and GIS feature classes were created for all 389 ice charts for winters 2006 through 2011. In addition, since feature classes (also known as shapefiles) were never produced for the period 2003-2005 (Assel 2005), those 143 grid files also needed to be converted to complete the climatology for 1973-2011. It should be noted that the 1973-2002 original Great Lakes ice atlas included products that were based on different ice attribute files such as ice form and ice age. The 2003-2011 additions to the ice atlas are based on a single ASCII grid file from the NIC, total ice concentration. For the 2003-2005 ASCII grid files, only 'observed data' files for total ice concentration ending with '.ct' were used from the ftp download site: http://www.glerl.noaa.gov/ftp/publications/tech_reports/glerl-135/Appendix2/DailyGrids

The first step in the process was to add the geographic location to each of the ASCII grid ice concentration values. This was accomplished by one of three IDL programs, depending on the year, since the formats of the ASCII grids are somewhat different.

For the 2003-2005 files, the latitude and longitude are read in from a file (Assel 2005). For all other input files, a subroutine is called that associates each grid pixel with its corresponding latitude and longitude coordinates. All of these programs were designed to process a year of ASCII grid files at a time. Once the ice concentration values were associated with location coordinates, they were ready to be brought into ArcGIS. The IDL program, Cwmap1024_auto.pro is found in Appendix A-4.

5.2 GIS Processing

Each file was first imported into Excel and saved as a comma-delimited (.csv) file in order to be imported to ArcView 9.2 (later 10.0). Files were loaded, geographic coordinates set (GCS North American 1983), land points removed, and finally saved as feature classes (.shp). Symbology was set to match the previous ice atlas .e00 files as closely as possible. Once the feature class file was complete, the Great Lakes ice concentration map was exported as a graphic image (.jpg) file. ArcModelBuilder was used to semi-automate this process. Feature classes (.shp) and graphic image files (.jpg) are zipped together by winter season.

6. DATA AVAILABILITY

The data is available either for an individual winter season or for all winter seasons together. Instructions for obtaining data are on the next page. You can also find this data on the GLERL ice cover webpage: <http://www.glerl.noaa.gov/data/pgs/glice/glice.html>. This Technical Memorandum is available at http://www.glerl.noaa.gov/ftp/publications/tech_reports/glerl-155/.

Individual Winter Seasons. A total of 582 ice charts are available in ASCII grid files and in ArcGIS feature classes. The data are arranged by winter season from 2003 through 2011. Note that winters 2003-2006 are in the 510×516 grid format, and winters 2007 through 2011 are in the 1024×1024 grid format.

Each winter season contains the following files in Zip compression:

- 1) Graphic files of total ice concentration
- 2) ASCII grid files
- 3) ArcGIS feature classes

An example for winter 2009 is given below.

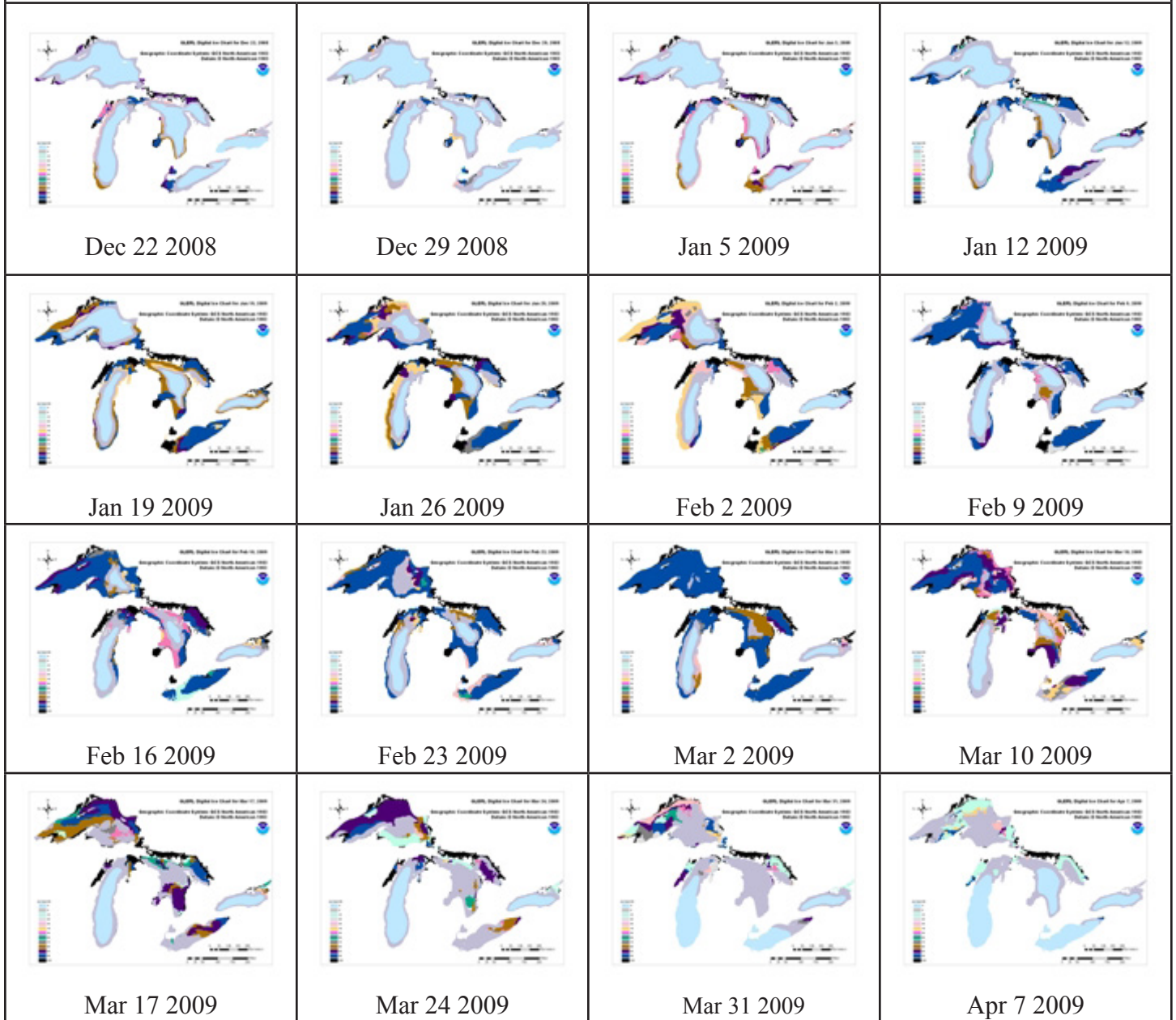

7. THE ANALYSIS USING THE UPDATED DATASET 1973-2011

7.1 Seasonal cycle

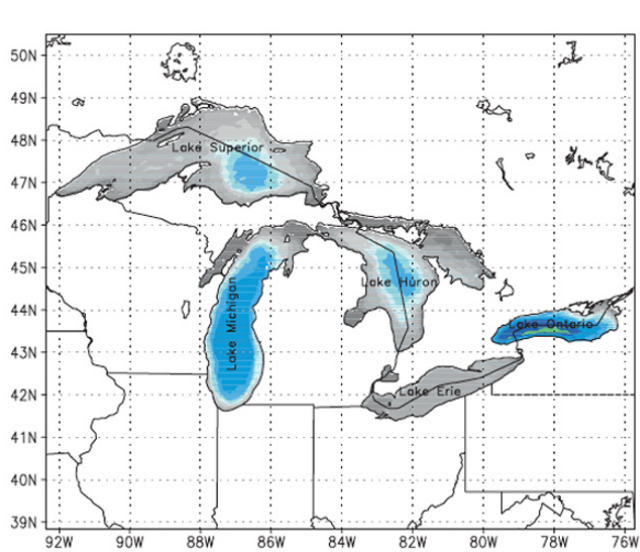


Figure 1. Long-term (1973-2002) mean annual maximum ice cover (in percent) in the Great Lakes. Note that ice cover (or concentration) ranges from 0% (ice free) to 100% (complete ice cover). (from Bai et al. 2011).

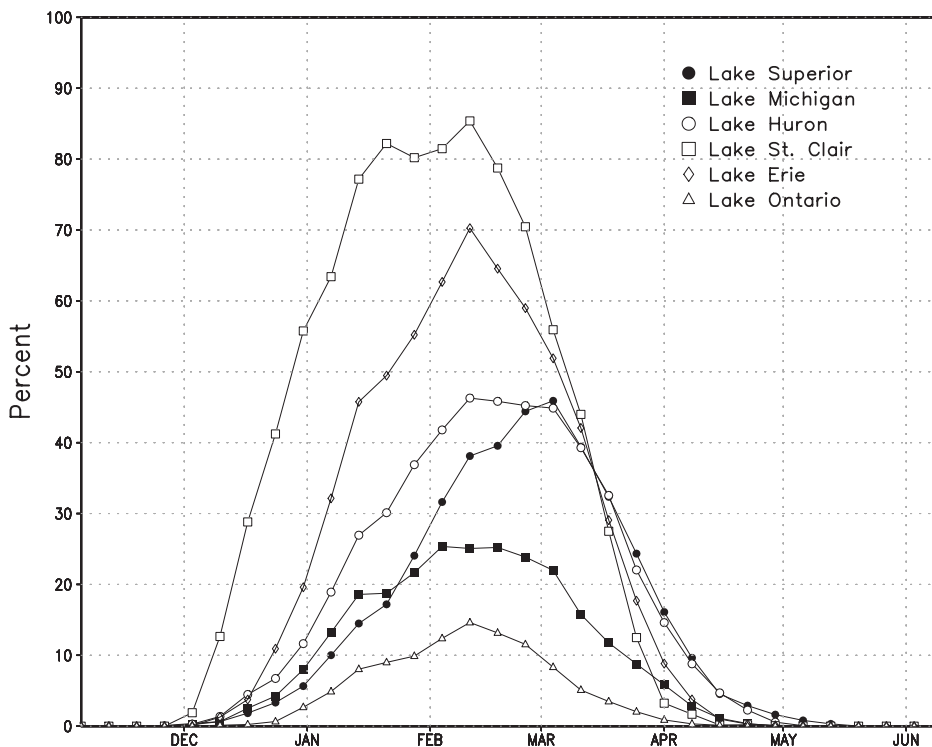


Figure 2. The NIC twice-weekly climatology of ice cover (in percent) in the Great Lakes, averaged from the period 1973-2011.

The spatial long-term (1973-2002) mean annual maximum ice cover in the Great Lakes was constructed using this dataset (Figure 1). The seasonal ice cover cycle (Figures 2-3) is computed based on the 1973-2011 data for the six lakes. The typical seasonal ice cycle of the Great Lakes consists of an initial formation (ice onset) period, followed by a growing period in which the annual maximum areal extent is reached, then a melting (break-up) period. The typical ice cycle has an ice-on date on all lakes occurring in December. The growth of ice cover is remarkably similar in all of the Great Lakes. Figure 2 also shows the progression of maximum ice cover for each lake.

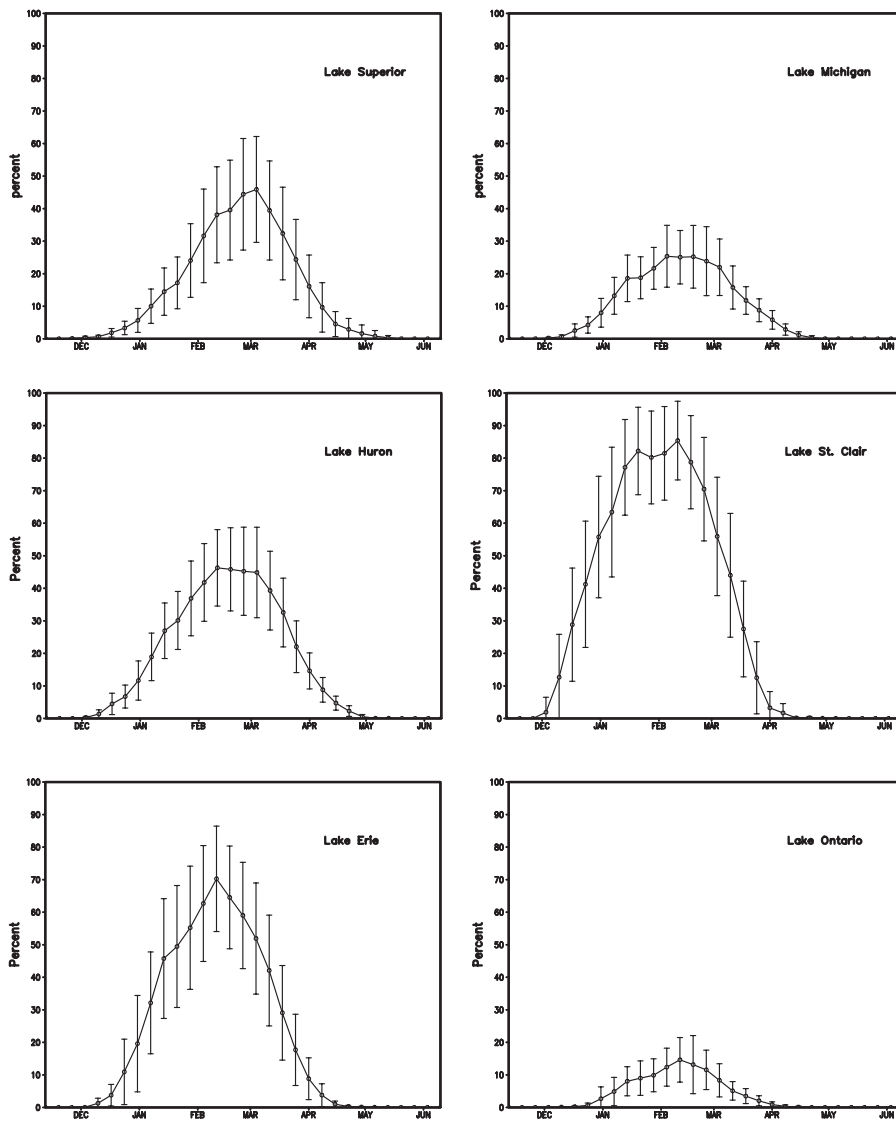


Figure 3. Variation of weekly ice coverage (in percent) of the six lakes for the period 1973-2011 with one standard deviation (SD) by the vertical bars.

7.2 Variations

The corresponding weekly variations, defined by standard deviations (SDs) of annual ice cover, are also shown in Figure 3. The months with the largest SDs are those most sensitive to atmospheric forcing, and the records with large SDs are the periods for better detecting interannual and decadal variability. One unique feature of Great Lakes ice cover, in contrast to Arctic sea ice cover (Wang and Ikeda 2001), is that the SDs are equivalent or even larger in magnitude than the means in the deep-water lakes, while SDs of sea ice are much smaller than the means in the Arctic Ocean (Wang and Ikeda 2001). This indicates that: 1) the natural variability of lake ice cover due to internal climate forcing is large (Wang et al. 2010a); and, 2) the predictability of lake ice cover using both statistical and numerical models is generally poor, particularly for interannual time scales. For example, Lake Ontario has the largest SDs compared to its mean, while Lake St. Clair has the smallest SDs. This implies that ice cover in Lake St. Clair has the best predictability, while ice cover in Lake Ontario has the poorest predictability among all the lakes, although the overall predictability in all lakes is poor.

The reason for the poor overall predictability of ice cover is that the internal variability of natural climate patterns such as ENSO and AO/NAO are poorly predicted (Wang et al. 2010a, 2012). Bai et al. (2010, 2011, 2012) revealed that both ENSO and AO/NAO have impacts on lake ice; nevertheless, none of them dominates the Great Lakes. Using both ENSO and AO/NAO indices, lake ice can be projected on an intraseasonal time scale, but has poor predictability on the interannual time scales (from year to year). Thus, short-term numerical prediction based on short-term weather prediction is an alternative to provide relatively accurate prediction of lake ice on synoptic time scales (Wang et al. 2010b).

7.3 Interannual variability

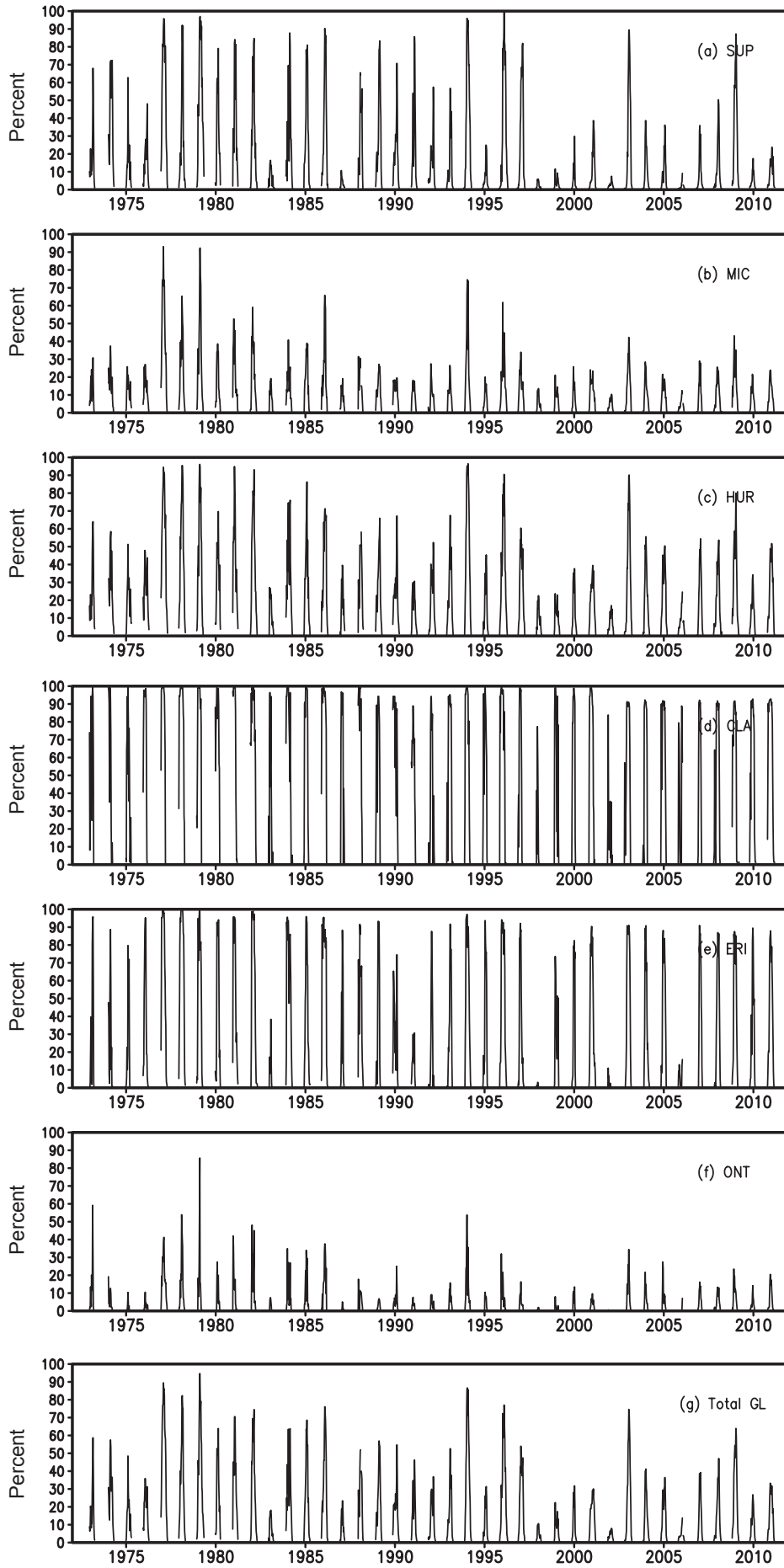
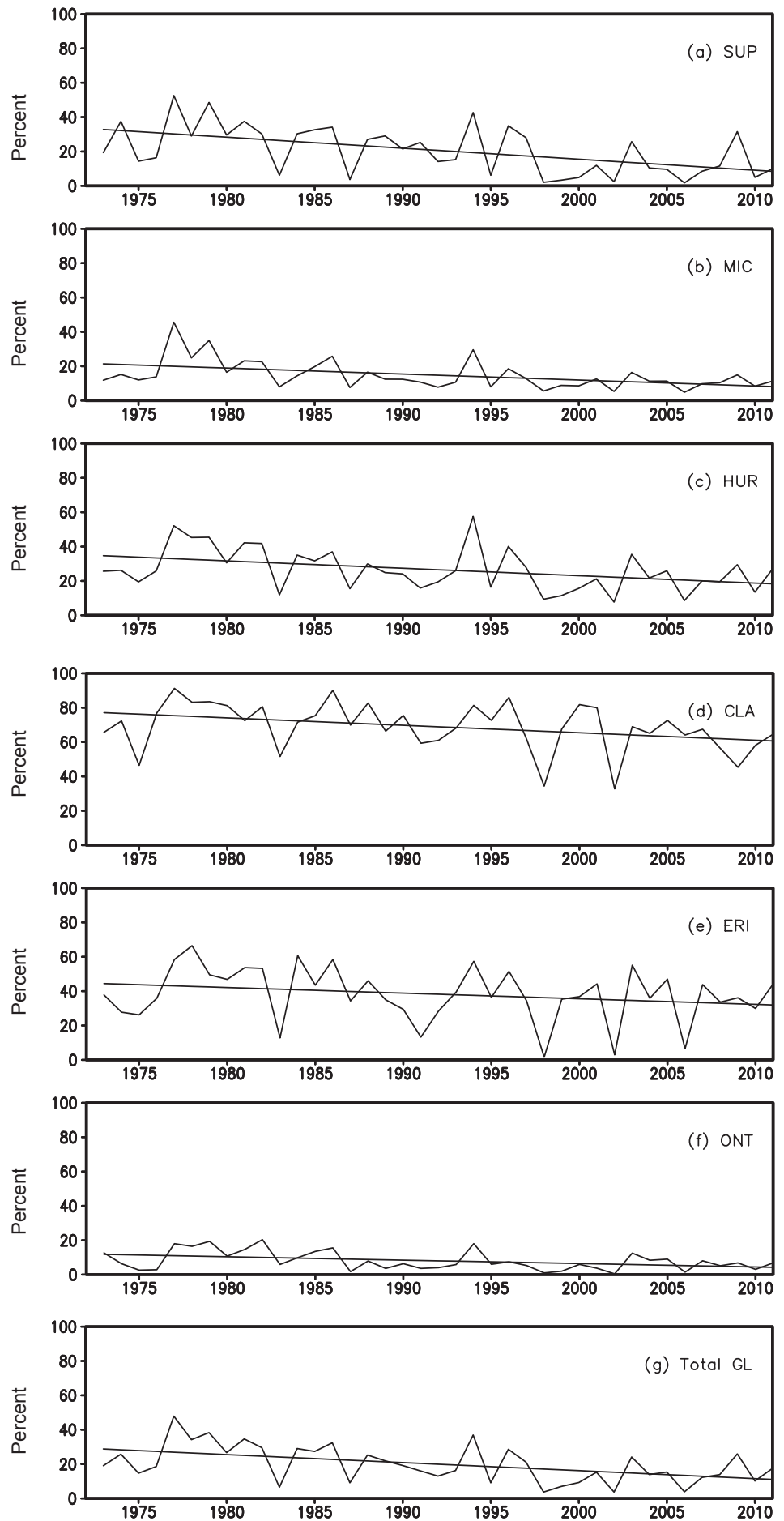


Figure 4. Twice weekly time series of ice cover (in percent) of all six lakes (a-f) and total Great Lakes (g) for the period 1973-2011.

Time series of weekly percent ice cover for all six lakes for the period 1973-2011 have been constructed (Figure 4), defined as the percentage of the total lake area that is covered by ice (Wang et al. 1994). All lakes have strong interannual variability of ice cover. However, there are two types of regional features: deep water and shallow water lakes. In the shallow water lakes such as Lakes St. Clair (3 m on average) and Erie (19 m on average), there is almost complete ice cover in winter except in 2005 for St. Clair, and 1983, 1991, 1998, 2002, 2005, 2006, and 2010 for Lake Erie. This indicates that using only lake ice area (in both percentage and square kilometers) is not sufficient to detect the climate signals in Lakes St. Clair and Erie, since the ice area is constrained by the bathymetry, the so-called boundary constraint (Wang et al. 1994). Under the boundary constraint, even though the ice area no longer increases, ice thickness can still increase in winter. Thus, lake ice thickness must be used to study lake ice in response to a changing climate. However, in the deep-water lakes (Superior: 148 m; Huron: 59 m; and Ontario: 85 m), ice cover can be used to detect climate signals, since ice rarely completely covers the lakes. On Lake Erie, the least ice cover was found in 1983, 1991, and 1998, spaced by 7-8 years, but more frequently since 1998 with a period of about 3-4 years. This implies that interannual variability of the climate patterns tends to be greater in the Great Lakes in the past decade. In the deep-water lakes, it is possible to detect climate signals using the ice cover area, since the boundary constraint is weak.

To investigate interannual variability, the time series of annual mean lake ice coverage for each lake (Figure 4) is calculated by averaging over the ice season from the original data (Figure 4). There is large interannual variability with temporal correspondence among all the lakes, implying that the major response of lake ice to the climate forcing is basically uniform over the Great Lakes, since the spatial scale of the Great Lakes is small compared to the teleconnection patterns excited by phenomena such as ENSO and AO/NAO.

7.4 Long-term trend

Ice cover on the Great Lakes has been declining since 1973. Figure 4 and Table 4 show the linear trends for the six lakes. The linear trend was estimated using the least squares regression (LSR). The linear equation is in the form: $x=a+bt$, where x is the ice cover (in %), t is the year starting in 1973, a is the x -intercept constant (the value of x for $t=0$ (i.e., 1973), and b is the slope of the line (namely, the rate of change in x with a time increment of t).

Winter mean ice cover in all lakes shows a significant negative trend (Figure 5), indicating that the ice extent in the Great Lakes has been decreasing since the 1970s. The negative trends vary from lake to lake (-0.56%/yr to -1.96 %/yr, Table 4). Lake Superior has the largest negative trend (-1.96 %/yr), Lakes Ontario and Michigan place second (~-1.6%/yr), and Lakes Erie and St. Clair have the smallest negative trend: -0.74%/yr and -0.56%/yr, respectively. This translates to the total loss of winter lake ice coverage over the entire 39-year record (from 1973-2011) relative to 1973 in Table 4 (last row), which varies

from 22% in Lake St Clair to 76% in Lake Superior. The total loss for overall Great Lakes ice coverage is 63% relative to the 1973 value. Another metric of loss of seasonal average ice cover over the 1973-2011 winters is the difference (1973 minus 2011) in the regression values for 1973 and 2011. The loss in seasonal average ice cover from 1973 to 2011 using this metric is 24.4% for Lake Superior, 12.9% for Lake Michigan, 15.5% for Lake Huron, 15.2% for Lake St. Clair, 11.1% for Lake Erie, 6.5% for Lake Ontario, and 14.9% for the entire Great Lakes basin.

Note that the trends calculated within a specific period of time such as 1973-2011 can only be applicable to the same period, and cannot be extrapolated to the future and back to the past. It should not be interpolated to a period shorter than the time series of the data from which the trends are derived, since there are decadal and multi-decadal changes in lake ice cover.

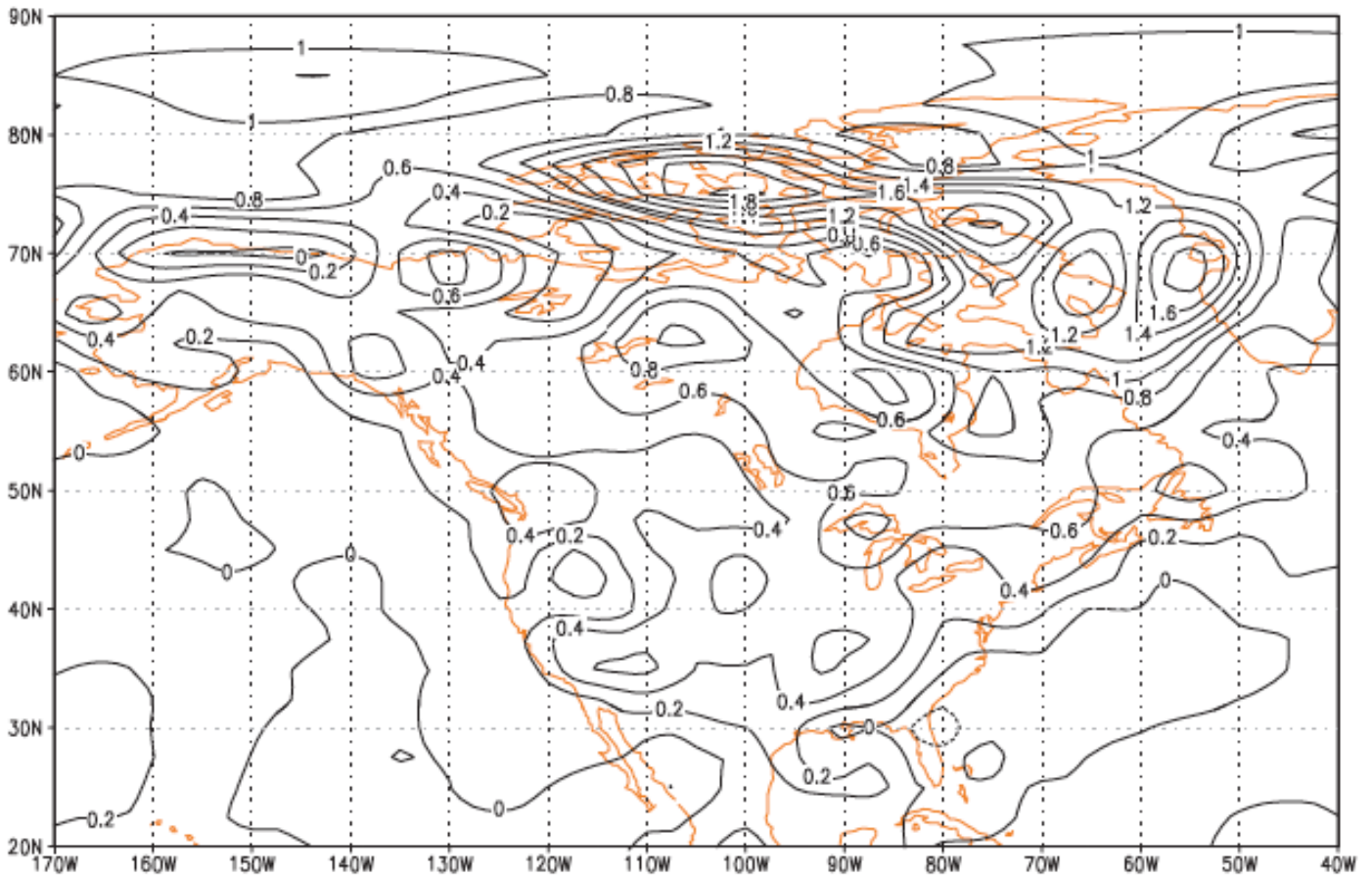


Figure 6. Winter surface air temperature (SAT) trend (°C per decade) for the period 1973-2010, calculated using the least squares fit. (from Wang et al. 2012)

To search factors responsible for the lake ice trend, the winter surface air temperature (SAT) trend over the Northern Hemisphere was calculated for the period 1973-2010 (Figure 6). The SAT trend over the Great Lakes ranges from ~0.4 °C per decade over the lower lakes to ~0.6 °C per decade over the upper lakes, with Lake Superior being the highest (0.6 °C per decade). This is consistent with the upward trend of Lake Superior water temperature (Austin and Colman 2007). They found that summer (July–September) surface water temperatures have increased approximately 2.5°C over the period 1979–2006, significantly higher than regional atmospheric warming. This excessive warming of lake water temperature relative to the local surface air temperature has caused a positive ice/water albedo feedback (Wang et al. 2005) due to the declining ice cover (Austin and Colman 2007).

7.5 Periodicity

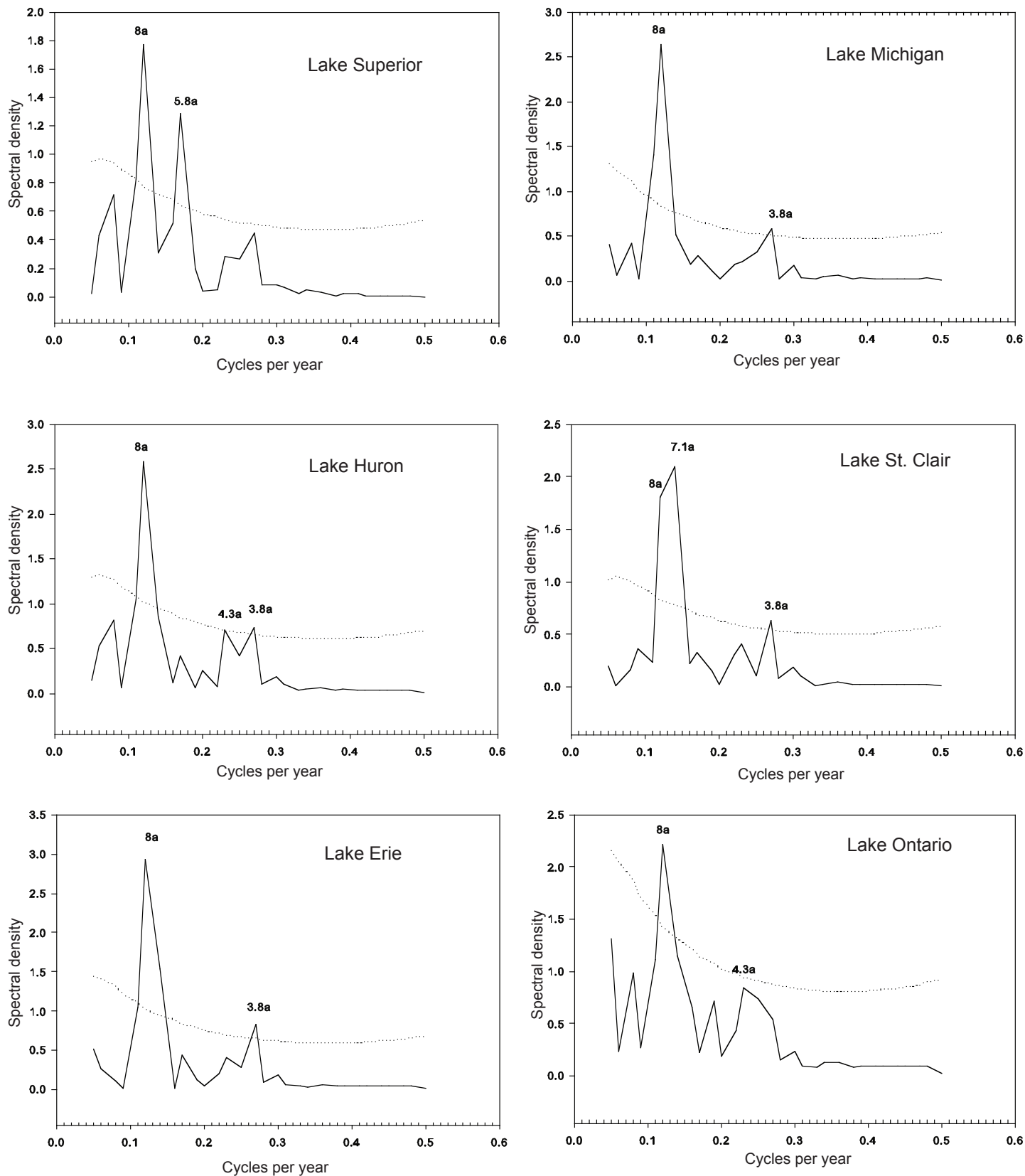


Figure 7. Spectral analysis of lake ice cover anomalies in all six lakes. The dotted curves are the 95% significance level. The peaks are marked with the corresponding periods in years.

We further examined the spectral characteristics of the 38-year time series of the six lakes (Figure 7). The main periods are ~8 years and 3-5 years. Lakes Michigan, Huron, St. Clair, and Erie have two periods: 8 and 3.8 years. The former may be related to AO/NAO, and the latter may be related to ENSO, since both ENSO and AO have impacts on Great Lakes ice cover (Bai et al. 2010, 2011); and the AO/NAO has significant decadal to quasi-decadal time scales (7-8 years) (Wang et al. 1994; Mysak et al. 1996; Wang and Ikeda 2001; Wang et al. 2005), while ENSO basically possesses strong interannual time scales of 3-5 years.

Winter SAT Trend from 1973 to 2010

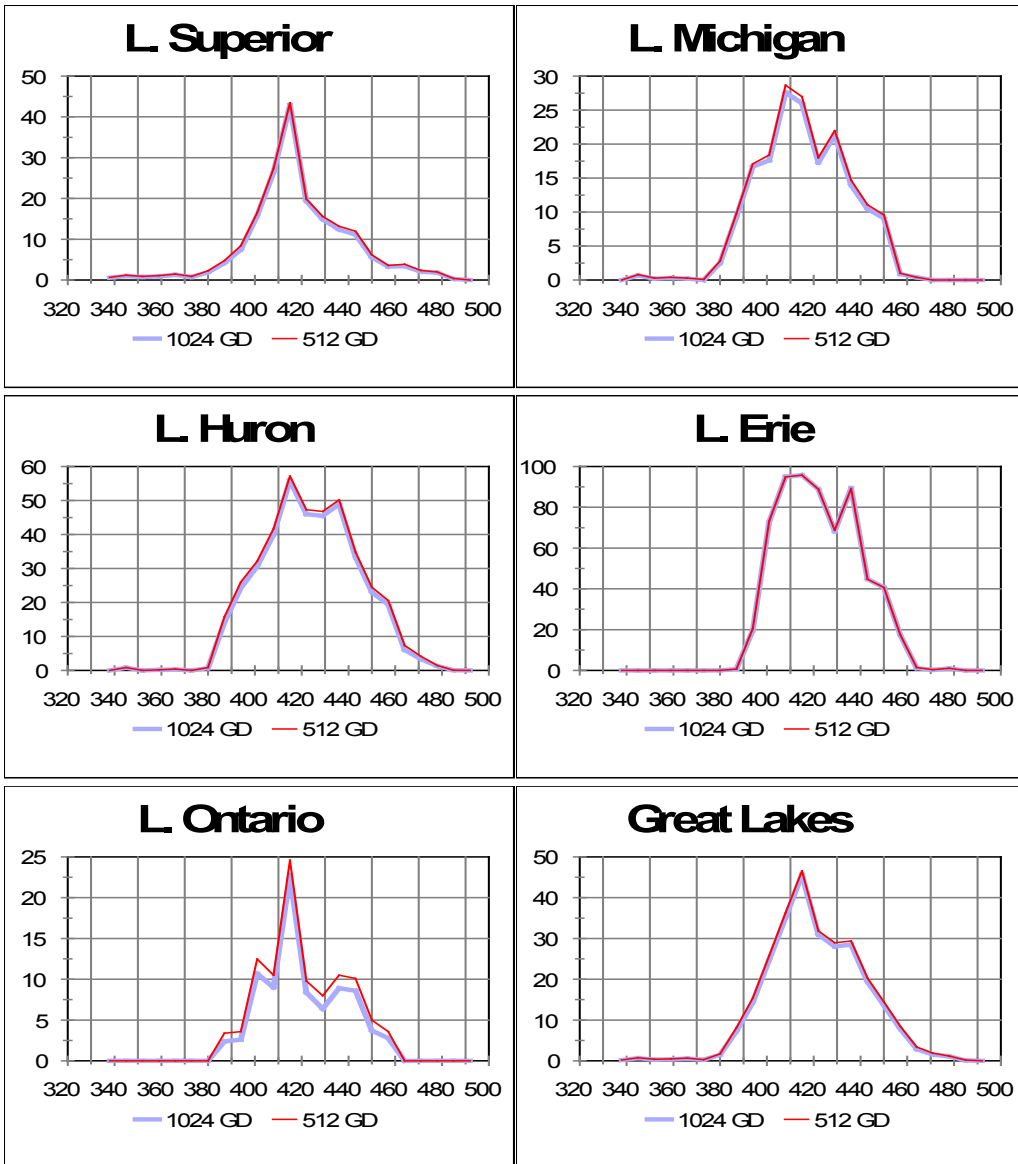

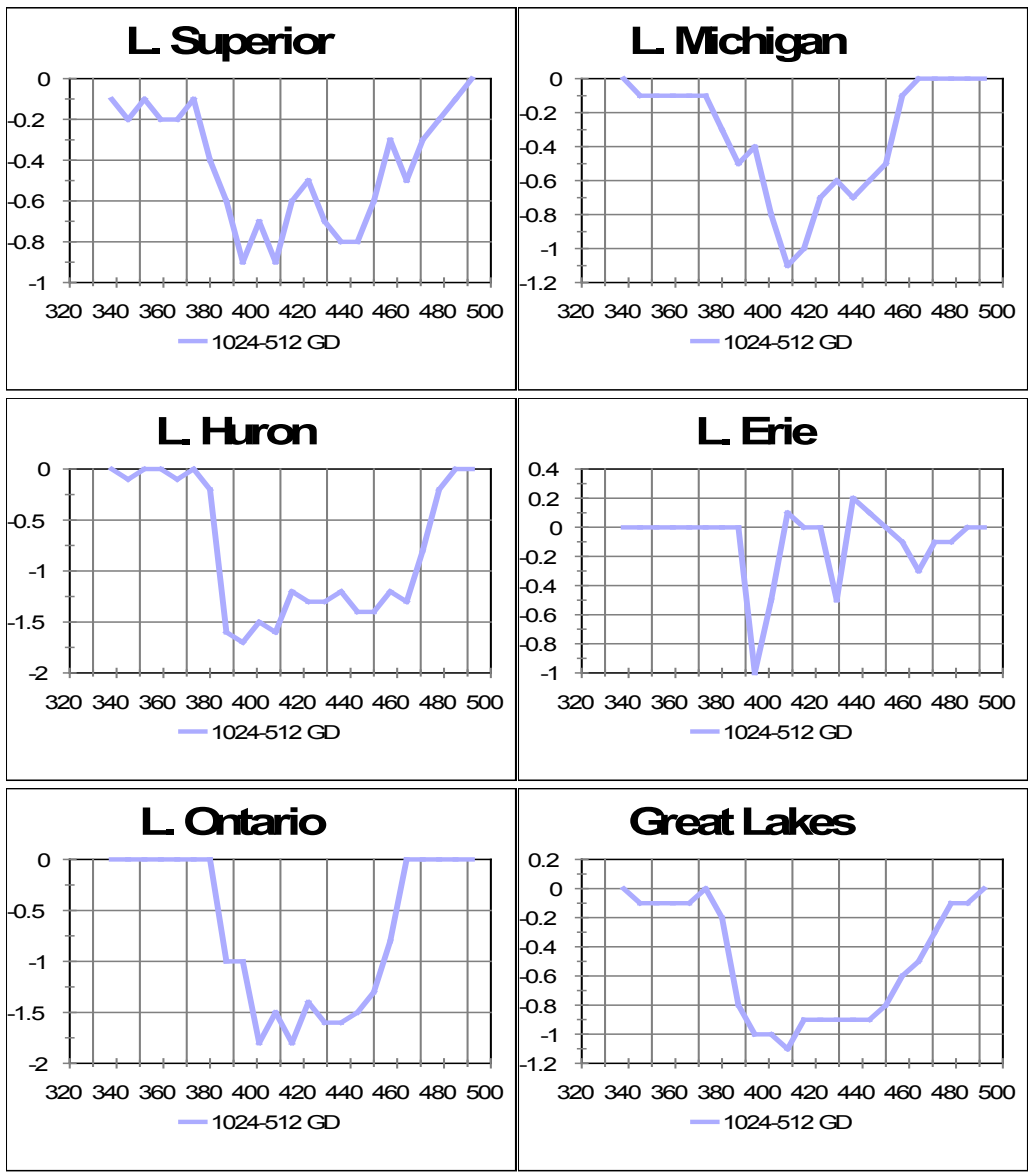
