A BY-LAW TO PROHIBIT THE PILING OF SNOW AND ICE ON HIGHWAYS WITHIN THE TOWNSHIP OF HURON-KINLOSS

WHEREAS Section 11 of the *Municipal Act, 2001*, S.O. 2001, c. 25, as amended, provides that municipalities may enact by-laws in respect of highways;

AND WHEREAS the Council of The Corporation of the Township of Huron-Kinloss deems it desirable prohibit the piling of snow and ice on highways within the Township;

NOW THEREFORE the Council of The Corporation of the Township of Huron-Kinloss enacts as follows:

- 1.0 For the purposes of this by-law, "highway" shall include a common and public highway, street, avenue, parkway, driveway, square, place, bridge, viaduct or trestle, any part of which is intended for or used by the general public for the passage of vehicles and includes the area between the lateral property lines thereof.
- 2.0 No person shall deposit or cause to be deposited snow or ice on a highway or any portion thereof without permission in writing to do so from the Township or the government authority responsible for the maintenance of the highway.
- 3.0 Every person who contravenes any provision of this By-law is guilty of an offence, and upon conviction is liable to a penalty pursuant to section 61 of the *Provincial Offences Act*.
- 4.0 That By-Law 2011-07 passed on the 17th day of January, 2011 is hereby repealed and replaced with this by-law.
- 5.0 This By-Law shall come into full force and effect upon its final passage.
- 6.0 This By-Law may be cited as the "Prohibition of Snow Piling on Highways By-law".


ONTARIO COURT OF JUSTICE

PROVINCIAL OFFENCES ACT
