TCAP Question and Answer: **Technical Assistance**



The following questions and answers are intended to assist TCAP grantees to understand and comply with various TCAP requirements. These questions and answers are not a substitute for reading and understanding the Recovery Act, TCAP grant agreement provisions, or other regulatory requirements.

1. Where can TCAP grantees go for additional training and technical assistance on the TCAP requirements and other Federal grant requirements?

<u>Answer:</u> TCAP grantees have a variety of HUD resources at its disposal to assist it in understanding and applying TCAP and other Federal grant requirements to eligible Low-Income Housing Tax Credit projects.

College of Experts: Through HUD's College of Experts (CoE) contract, grantees may request training or direct technical assistance on Federal grant requirements such as environmental review, Davis-Bacon applicability and compliance, and the use of OMB Circulars and cost principles. Grantees may **only** request CoE assistance for eligible TCAP projects that already have an investment of HOME funds, or have an **executed**, **legally binding agreement** (i.e., a 'commitment' as defined in the HOME regulations at 24 CFR Part 92), with a HOME Participating Jurisdiction (PJ) to receive HOME funds.

To request technical assistance (TA) through the College of Experts, TCAP grantees should contact the local HUD Field Office. A list of local HUD Field Office contacts may be found on HUD's website. The HUD Field Office staff will evaluate the TA request and forward a formal request for TA services to HUD headquarters for final review. TCAP grantees will be notified by the HUD Field Office staff if and when the request is approved.

HOME Participating Jurisdictions: TCAP grantees may wish to seek assistance or guidance from the state HOME PJ or other state agency or department that may have experience in complying with various Federal grant requirements. For example, all States receive an allocation of HOME funds and have agencies that have federal environmental review experience.
