- B. Meeting Minutes August 26, 2019 Minutes
 - a. JBC motioned to approve August 26, 2019 with amendment to Office/Facilities (see below), CS seconded. Unanimous approval.
 - Correction: NS shared a resident complaint of residents burning garbage.
 Trustees discussed and recommended that the ANR flyer on burn barrels be sent out in a utility bill.
- C. Privilege of the Floor
 - a. Catherine McMasters raised the concern of water quality:
 - i. Water smells and taste bad
 - ii. Other residents (Patsy Tompkins, Chantal Jesmer, Gail Robitaille) concurred
 - iii. Discussion of the seasonal change causes changes in water column in May Pond which often turns up tannins and other compounds from the pond bottom that contributes to the bad taste/smell.
 - Discussion that perhaps additional filtering may assist with smell/taste but that would not be an immediate fix and would need to be budgeted in next year's budget
 - v. Discussion that water supply contractor and BVI staff were cleaning one of the water tanks and that this may offer some immediate relief once finalized.
