Renewal of radio programming undertaking broadcasting licences due to expire 31 August 2010 – Licensees in apparent non-compliance Deadline for submission of interventions/comments: 6 July 2010

[Broadcasting interventions/comments form]

The Commission announces that it has received broadcasting licence renewal applications for radio programming undertakings for which the licences are due to expire 31 August 2010. The licensees listed below have been found to be in apparent non compliance with regulatory requirements during the current licence term. The following codes A to G identify the requirements with which the licensees are in apparent non compliance:

- **A**: failure to comply with the *Radio Regulations*, 1986 (the Regulations) relating to the broadcast of French-language vocal music;
- **B**: failure to comply with the condition of licence relating to Canadian talent development (CTD) contributions;
- C: failure to comply with the subsection 15(2) of the Regulations relating to Canadian Content Development (CCD) contributions;
- **D**: failure to comply with the Regulations as they relate to devoting 35% or more of musical selections from content category 2 (Popular music) to Canadian selections broadcast in their entirety;
- E: Failure to comply with the Regulations as they relate to devoting 10 % or more of musical selections from content category 3 (Special Interest Music) to Canadian selections broadcast in their entirety;
- **F**: failure to comply with subsection 9(2) of the Regulations relating to the provision of annual reports;
- **G**: Failure to comply with subsection 8(6) of the Regulations relating to logger tapes.



The codes as they apply to the various licensees are also set out below.

The licensees propose to operate their undertakings under the same terms and conditions as specified in the current licences and in the last renewal decisions, with the exception of Canadian talent development requirements which have been replaced by the Canadian content development requirements as set out in Section 15 of the Regulations.

The Commission notes that, in addition to the conditions set out in the current licences, the renewed broadcasting licences will be subject to the conditions set out in *Conditions of licence for commercial AM and FM radio stations*, Broadcasting Regulatory Policy CRTC 2009-62, 11 February 2009.

In the list below, stations identified with an asterisk (*) have been monitored by Commission staff. The monitoring report has been placed on each licensee's public examination file. A copy can be obtained by contacting one of the Commission's documentation centres.

The Commission notes that other such licences expiring in 2010 will be dealt with in separate notices of consultation.

Interventions will be considered by the Commission and will form part of the public record of the proceeding without further notification to intervening parties, provided the procedure set out below has been followed. Parties will be contacted only if their submissions raise procedural questions.

A true copy must be sent to the applicant, and proof that this has been done must accompany the intervention sent to the Commission.

The Commission advises those who file and serve by electronic mode to exercise caution when using e-mail for service of documents or notification, as it may be difficult to establish that service has occurred.

Parties must ensure that, before initiating service through electronic mode, they will be able to satisfy the Commission, upon request, that service of the notification was completed.

Submissions longer than five pages should include a summary.

Each paragraph of the submission should be numbered. In addition, where the intervention is filed by electronic means, the line ***End of document*** should be entered following the last paragraph of the document, as an indication that the document has not been damaged during electronic transmission.

Interventions should clearly identify the application referred to and indicate whether parties support or oppose the application, or, if they propose changes to it, include the facts and grounds for their proposal.

Important notice

All information that parties provide as part of this public process, except information granted confidentiality, whether sent by postal mail, facsimile, e-mail or through the Commission's website at www.crtc.gc.ca, becomes part of a publicly accessible file and will be posted on the Commission's website.
