Transposes Directive 2018/852 on packaging and packaging waste. It sets targets and measures for prevention, reuse, incorporation of Ministers recycled plastic, separate collection, recycling; specifically regulates the RAP for domestic, commercial and industrial packaging, indicating the scope of the costs to be assumed. Much more ambitious than the directive it transposes.
